Re: H.B. 1863, H.D.1, Relating to Economic Development

The Department of Taxation (Department) appreciates the intent of the measure to increase employment in economically depressed areas by designating an additional enterprise zone in each county for manufacturing. The Department defers to the Department of Business, Economic Development, and Tourism (DBEDT) on the merits of this bill and provides the following additional comments regarding H.D. 1 for your consideration. The measure is effective on July 1, 2018.

First, the Department notes that manufacturing of tangible personal property is already a qualified business activity under Hawaii Revised Statutes (HRS) section 209E-2, and it is not clear how this measure will encourage additional businesses to enter the enterprise zone program.

Under HRS section 209E-10, DBEDT certifies that a participant is entitled to the tax credits and exemption from the general excise tax. Only after receiving such certification can a taxpayer claim the tax benefits. As the regulatory agreements and the eligibility determinations remain with DBEDT, this measure will not have a substantial administrative impact on the Department.

Finally, the Department will be able to implement this measure with its current effective date. Thank you for the opportunity to provide comments.

The Department of Business, Economic Development, and Tourism (DBEDT) **supports the intent** of HB 1863, HD1, which authorizes the Governor to designate an enterprise zone dedicated to manufacturing in each county.

Manufacturing is currently an eligible business activity of the Enterprise Zone (EZ) program. In fact, manufacturing companies along with wholesaling and agricultural companies already comprise a substantial portion of the companies in the EZ program.

Encouraging manufacturing is an important economic development and sustainability goal. This measure may support additional manufacturing in certain parts of each county that are currently ineligible to be an enterprise zone under current EZ program rules. DBEDT supports the intent of the bill so long as it does not either replace or adversely impact the Administration's priorities.

We defer to the Department of Taxation for the fiscal impact of this measure on the state budget.

Subject: House Bill No. 1863 HD 1
Relating to Enterprise Zones

The Department of Planning and Permitting (DPP) **opposes** House Bill No. 1863, HD 1, on the basis of home rule. The Bill would allow the governor to unilaterally designate one enterprise zone per county in the interest of promoting economic development through manufacturing.

The City is not opposed to the enterprise zone program, nor necessarily establishing one focused on manufacturing. We already have adopted the maximum number of enterprise zones allowed, six.

We are opposed to the process outlined in the Bill. It ignores the long-standing procedure led by the counties. At minimum, the Bill needs to be amended to recognize the participation of the applicable county. It should also clarify that the counties may still decide what county incentives may be appropriate for the governor's enterprise zone.

We ask that House Bill No. 1863, HD1, be deferred or amended to reflect the above requests.
