Aloha Chair Evans, Vice Chair Keohokalole, and Members of the Committee:

I am Randy Cabral, President of the Hawaii Farm Bureau (HFB). Organized since 1948, the HFB is comprised of 1,900 farm family members statewide, and serves as Hawaii's voice of agriculture to protect, advocate and advance the social, economic and educational interests of our diverse agricultural community.

HFB strongly supports HB 1959, which expands the duties and functions of DBEDT to include innovative activity.

One of the biggest shortcomings of Hawaii's agriculture is its overdependence on labor. Other countries throughout the world; for example, in Japan, Thailand, and Vietnam, have increased their mechanization capacity on lands similar to ours in Hawaii -- small, irregular shaped plots, and uneven terrain. Hawaii's capacity to be competitive in a price-conscious consumer market is dependent on managing costs. Labor is one of our major costs and these excessive costs can be a deterrent to aspiring young farmers who are considering agriculture as a career choice.

This measure seeks to encourage innovative activity grants. Because farmers are skeptics and cautious of the unknown, funding new and beneficial practices as demonstrations or developing practices for implementation by farmers will fill an important gap in expanding agriculture in Hawaii.

We respectfully request your support of HB1959, that includes agriculture as a sector within which to encourage innovative activity development.
