Good morning, Chair LoPresti, Vice Chair Fukumoto, and members of the Committee:

I'm Ron Han, Director of the State Office of Veterans Services. I appreciate this opportunity to provide testimony **in support** of House Bill 1965.

This measure appropriates funds to the veteran's treatment court on the island of Hawaii. The first Veterans Treatment Court (VTC) in Hawaii over the last several years, under the leadership of First Circuit Court Judge Ed Kubo, has successfully graduated over 20 eligible Veterans. Providing this opportunity to eligible Veterans in Hawaii County by funding full-time employment authorizations will enable Veterans who served their Nation to participate in rehabilitative treatment efforts that may not be offered if they are incarcerated.

This program on record has a very low recidivism rate, has garnered successes in dealing with veterans for various issues, and has established viable monitoring links towards rehabilitation. Over 100 VTC's across the nation have experienced a reduced number of repeat offenders, thereby reducing our overall prison population.

The OVS supports the concepts and intent expressed in this measure as long as its implementation does not impact or replace the priorities set forth in the Executive Budget.

Bill No. and Title: House Bill No. 1965, Relating to Veterans Treatment Court.

Purpose: Appropriates funds to continue the Third Circuit's Veterans Treatment Court by converting one (1) temporary Social Worker IV position and establishing one (1) additional full-time equivalent permanent Social Worker IV position.

Judiciary's Position:

The Judiciary strongly supports House Bill No. 1965.

Veterans who are justice-involved typically face incarceration with very little help to address their underlying mental health problems, substance abuse problems, and or combat - related issues. In addition, they may have medical, health, housing, employment and financial issues. Veterans may be involved with the VA or may need extra assistance in pursuing eligibility for VA services. Lastly, they may have difficulty in sharing their problems with non-veterans.

Four years ago, the community, our Federal, State and County elected officials, came together to discuss with various community members, the development of a Veterans Treatment Court, on the Big Island. Community partners became the foundation for community and ultimately a team approach to not only the planning and development stages of a Veterans Court

on the Big Island but the eventual formation of the Big Island Veterans Treatment Court (BIVTC).

In 2014, the Judiciary was awarded a three-year Bureau of Justice Assistance federal grant for a Veterans Treatment Court. The Veterans Treatment Court model, based on the Drug Court 10 Key Components, its many years of research showing its effectiveness, and its successful implementation in many communities across the nation, was selected as the model to implement.

The goal of the BIVTC is to help justice-involved veterans struggling with untreated mental health issues, including PTSD, substance abuse disorders, and/or Traumatic Brain Injury. These veterans are at a high risk for recidivism (criminal reoffending) and have high treatment needs. The program is open to eligible veterans whether or not they are eligible for VA services. Collaboration with the VA via a Veteran Justice Outreach worker is critical and in place.

By the second year of the program, the BIVTC surpassed its goal by serving a total of 26 veteran participants. Since 2014, the BIVTC has worked with 30 veteran participants and 12 active Volunteer Veteran Mentors. Ten (10) of the veteran participants have graduated so far. Many of these graduates have jobs, attend mental health treatment and substance abuse sober support groups on a regular basis, have not recommitted any felony crimes, have stable housing, and have gone on to contribute back to society. In addition, many are now connected and proud of their military heritage.

House Bill No. 1965 will allow for the hiring of two full time BIVTC probation officers, one on the Big Island's East Side with a caseload of 20 veterans and one on its West Side also with a caseload of 20 veterans, and allow us to continue to expand the BIVTC.

Many of us either are veterans, know of veterans, and/or have family or loved ones who are veterans. Veterans have served our country and many have given their lives and sacrificed much. We all share the common goal to support them in their time of need and provide them with the best possible chance to be a healthy and successful part of our community.

We appreciate the Legislature's many actions to support veterans and respectfully request your support of House Bill No. 1965.

HSAC Supports HB1965

Good Morning Chair, Vice Chair And Distinguished Committee Members. My name is Alan Johnson, Chair of the Hawaii Substance Abuse Coalition, an organization of more than 40 treatment and prevention agencies across the State.

The Hawaii Substance Abuse Coalition supports the Veterans Treatment Court and recommendations expanding its diagnostic scope.

Returning veterans, and their families are subject the effects of combat exposure, and physical injuries, as well as post-traumatic stress disorder (PTSD) and traumatic brain injury (TBI).

Expand the Scope of Veterans Drug Court

Federal funds are being expended to research the epidemiology/etiology for the identification, prevention, and treatment of alcohol, tobacco, and other drug use and abuse as well as illicit and prescription drugs, and associated mental health problems among active-duty or recently separated military troops and their families:

- Improve screening and access to care for alcohol-related problems among service members returning from combat deployments.
- Expanding services will allow Veteran Drug Courts to provide more opportunities for veterans to access treatment services.
- Therapies for co-occurring disorders, such as PTSD, depression and substance abuse;
- Effectiveness of early interventions for recently returning soldiers;
- Practices to reduce the high rates of smoking among returning military personnel; and
- Impact of a youth substance abuse prevention intervention designed for parents returning from deployment.

Alcohol, substances misuses and prescription drugs are problems.

- Illicit drug use is still a major problem, especially methamphetamine.
- Prescription drug abuse is increasing at alarming rates.
- Alcohol abuse is still the most prevalent problem.
 - The Millennium Cohort Study—the largest prospective study in military history occurring from 2001 to 2012—suggests that deployed younger service members are at increased risk of heavy weekly drinking, binge drinking, and other alcohol-related problems.

Mental illness among military personnel is also a major concern.

- Studies indicate that 20% of active and 42% of reserve component soldiers require mental health treatment or co-occurring substance use disorders and mental health treatment.
- Drug or alcohol use frequently accompanies mental health problems and was involved in 30% of the Army's suicide deaths from 2003 to 2009 and in more than 45% of nonfatal suicide attempts from 2005 to 2009.

Drug courts have demonstrated effectiveness in addressing nonviolent crimes committed by drug abusers, ushering them into needed treatment instead of prison.

• Because the criminal justice system is a frequent treatment referral source for veterans, specialized drug courts for this population may give them the opportunity to access services and support they may not otherwise receive.

Veteran Drug Courts, if expanded effectively, can contribute to the design and implementation of effective prevention and treatment interventions that can help safeguard the health and well-being of those who protect and serve our Nation.

As a current Mentor in the Big Island Veterans Treatment Court (BIVTC), I have seen firsthand the positive impact this treatment court has had on our Veterans. These courts greatly facilitate the return of Veterans to contributing citizens of the community. I have had the privilege to mentoring 2 Veterans from beginning to graduation.

Many Veterans present symptoms of post-traumatic stress disorder (PTSD) and/or traumatic brain injury (TBI), and there is growing evidence that these behavioral health disorders, if left untreated, may lead to involvement in the criminal justice system. Veterans are not exempt from this. In fact, Veterans who suffer with post-traumatic stress disorder (PTSD), traumatic brain injury (TBI) or substance abuse have a higher chance of ending up in the court system. In 2006, 60 percent of Veterans in prison had substance abuse problems.*

Veteran Treatment Courts leverage the court system to keep Veterans with a diagnosis of substance abuse or a behavioral health disorder in treatment long enough to permanently change their behavior. They involve cooperation and collaboration with traditional partners found in Drug Courts, such as prosecutors, defense counsel, treatment providers, probation officers, and law enforcement personnel. Representatives from the Department of Veterans of Affairs (VA), Veterans Health Administration (VHA), Veterans Benefit Administration (VBA), and other Veteran-affiliated groups are also generally involved.

I strongly urge you to please help us to continue helping our Veteran brothers and sisters by ensuring the additional positions and funding be authorized. We cannot, and must not, forget those who volunteered to go into harms way in order to protect the freedoms we enjoy today.

I am a long time member of the "Friends of the Big Island Drug Court" (Judge Gregg Nakamura) and would like to submit testimony to support HB NO. 1965 that proposes to have Two permanent probation officers for the BIG ISLAND VETERANS TREATMENT COURT, one for Hilo and one for Kona.

I lost a son (age 28) over twenty years ago who was killed by his ex-girlfriend. He was addicted to drugs and was in treatment when she premeditated his murder and shot him seven times. She also was addicted to drugs and they both were not suitable parents for their seven year old son.

My family and I raised their son who is now an adult. His mother never reconciled with him and till today he is still affected by this tragedy. I have seen and experienced the tragedies of those who try to overcome their drug addiction and find it so difficult.

Earlier last year, I attended a graduation ceremony for a veteran who worked very hard and successfully completed the program. To my surprise, that graduate was someone I hired to work at the gas station of a retail store in Hilo. He at that time was a young man who did well in his job but after serving in Vietnam he became addicted to substance abuse for many years. With the help of the BIVTC, he was able to overcome the many challenges and was able to go back to his family after successful treatment.

Another personal story is of my cousin who served in Vietnam also and was a paratrooper who had many horrible experiences. He became so addicted to substance abuse that he became involved in crime in order to support his habit. He ended up in prison for many years and his young life was ruined. The Vietnam War was so long ago and yet till today there are many from that era who are still suffering the effects of that time.

Now in my days of retirement, I am involved in several programs to help not only perpetrators but also victims of crime. I am the president of the board for a nonprofit group called Going Home Hawaii. This consortium of many organizations is working toward helping men, women, and youth who were released from correctional institutions with reintegration into community life through employment, training and appropriate supportive services. Many of these former perpetrators are veterans who have served their time incarcerated and today are working hard to use a second chance to become good citizens and return to their families and communities.

I also am co-founder of a program called STARS (Surviving to Thriving: Advocacy, Resources and Support) who formed a support group for families of victims lost to homicide. The Hawaii Island Prosecutor's Office has supported us in forming this program. Some of us also participate in the Prosecutor's Victim Impact program where we go to speak to the incarcerated men and women about how crime has affected us. This program has been successful in showing perpetrators how their crimes have affected people's lives and in some cases destroyed families.
