# HOUSE BILL NO. 1969 HD1 RELATING TO FOOD SUSTAINABILITY

Chairperson Luke and Members of the Committees:

Thank you for the opportunity to testify on House Bill No. 1969 HD1 that requires the Department, in coordination with the Office of Planning, to prepare and periodically update a functional plan for seafood sustainability that expands the State's priority on food by including wild seafood as a viable food source. The Department of Agriculture supports the intent and offers comments.

The Department of Agriculture supports the State's initiatives to increase food self-sufficiency. We note that the plan for seafood sustainability is to be incorporated into the Agriculture Functional Plan. This suggests that the Agriculture Functional Plan itself may have to be amended. We are aware of and concerned about the substantial resources required by the Functional Plan process identified in Sections 226-55 to -57 (Functional Plans; preparation and update, form and submittal, implementation). Furthermore, the thirteen existing functional plans cover very broad areas - Agriculture, Conservation Lands, Education, Employment, Energy, Health, Higher Education, Historic Preservation, Housing, Human Services, Recreation, Tourism, and Transportation. The Department requests resources to fund this effort.
