If we do not get more people aware of the facts regarding the Little Fire Ant there will be a lot of preventable damage that will take place. Folks I work with (farmers) are afraid of the mulch, this think it is direct link to LFA and in Kona that is incorrect. The West Hawaii dump, where the mulch is processed is not Little Fire Ant habitat, in any way, shape, or form. I know folks who have obtained LFA through vegetative material (usually potted plants and landscaping material) brought from East Hawaii. I'm not trying to cause problems. At an LFA workshop, when asked how a particular neighborhood acquired this problem I was told that did not really matter when in fact it does. Farmers are worried about using the mulch significantly more than than they worry about the 100 grafted avocado trees they just got from Hilo when in fact it is those trees from Hilo that carry the greatest risk, not the mulch created in the West Hawaii facility. People need to have accurate information to deal with this issue. Also, by not being honest about the associated risks related to what someone brings on their land bad actors on this issue are being protected. If it is not understood that someone is more likely to get an LFA infestation by bring vegetative material from East Hawaii to West Hawaii you are allowing the East Hawaii business person to disregard the responsibility to the land, his customers or his community. The pulblic needs to know how important this issue is and they need to be told honest, accurate, information. Thank you.
