Thank you for the opportunity to testify on House Bill 2102, which requests a \$2 million appropriation for a nutrient cycling center pilot project on Maui and requires the Department to report on the efficacy of the pilot project to the 2020 Legislature. The Department supports the intent of the bill provided that its passage does impact priorities indicated in the Executive Budget.

The Department lacks the scientific capability for implementing waste stream capture, composting process, undertaking and prioritizing research, and operationalizing the findings. This could be a project that a partnership between the Department of Agriculture and the University of Hawaii, College of Tropical Agriculture and Human Resources could collaborate on with agricultural stakeholders such as the Hawaii Farmers Union United or the Hawaii Farm Bureau Federation.

Good morning, my name is Melodie Aduja. I serve as Chair of the Oahu County Committee ("OCC") Legislative Priorities Committee of the Democratic Party of Hawaii. Thank you for the opportunity to provide written testimony on House Bill No. 2102, relating to agriculture and a Nutrient Cycling Center Pilot Project. The OCC Legislative Priorities Committee is in favor of House Bill No. 2102 and support its passage.

House Bill No. 2102, is in alignment with the Platform of the Democratic Party of Hawai'i ("DPH"), 2016, as it establishes and appropriates funds for a regional nutrient cycling pilot program on Maui and requires DOA to report on the efficacy of the pilot project no later than 20 days prior to convening the 2020 Regular Session.
