A BILL FOR AN ACT

RELATING TO VICTIMS OF SEXUAL VIOLENCE.

BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF HAWAII:

1 SECTION 1. The legislature finds that sexual violence and

2 abuse are extremely prevalent in the United States. One in six

3 women and one in thirty-three men have experienced an attempted

4 or completed rape in their lifetimes, while one-in-four girls

5 and one-in-six boys will be sexually abused before they turn

6 eighteen. According to The Centers for Disease Control and

7 Prevention, an estimated 43.9 per cent of women and 23.4 per

8 cent of men have experienced forms of sexual violence other than

9 rape within their lifetimes.

10 The legislature further finds that sexual violence and

11 abuse can have severe and lasting emotional and mental health

12 impacts on victims. Victims of sexual assault during adulthood

13 suffer post-traumatic stress disorder at a rate between thirty

14 to sixty-five per cent, as well as elevated rates of depressive

15 disorders, parasuicidal behaviors, and substance use disorders.

16 Victims of sexual abuse during childhood face numerous

17 psychological challenges at rates higher than people who have

1 not experienced sexual abuse including being three to five times 2 more likely to be diagnosed with post-traumatic stress disorder, 3 fifty-two per cent higher lifetime depression rates, experience increased rates of suicide, self-harming behaviors, alcohol use, 4 5 eating disorders, and disruptions to developmental processes 6 that lead to personality disorders. Consequently, many victims 7 of sexual violence and abuse represent mental health cases that 8 require clinical victim support services by qualified mental 9 health providers, in addition to psychotherapy, to effectively **10** manage mental disorders related to sexual violence and abuse. 11 The legislature also finds that it can be difficult for 12 victims of sexual violence and abuse to obtain appropriate 13 mental health services due to the limited availability of 14 qualified mental health providers who are able to take on 15 potentially complex mental health cases. Clinical victim 16 support services, which are required for treatment of mental **17** disorders caused, in whole or in part, by sexual violence and 18 abuse, are not generally covered by health insurers. This is a 19 barrier to sufficient provider availability, as clinical victim 20 support services are often an unreimbursed expense that 21 discourages providers from accepting potentially complex cases.

1	The purpose of this Act is to improve mental health service
2	availability for victims of sexual violence and abuse by
3	requiring that accident and health or sickness insurance
4	policies provide coverage for appropriate clinical victim
5	support services provided by qualified mental health providers.
6	SECTION 2. Section 431M-1, Hawaii Revised Statutes, is
7	amended by adding two new definitions to be appropriately
8	inserted and to read as follows:
9	""Clinical victim support service" means a professional
10	intervention conducted by a qualified mental health provider to
11	identify needs and assist in obtaining coordinated, appropriate
12	services, and resources for a victim of sexual violence and
13	abuse to curtail or prevent the progression and worsening of
14	mental disorders and associated functional impairments caused,
15	in whole or in part, by the sexual violence and abuse. Clinical
16	victim support services include:
17	(1) Coordinating with other health care providers, such as
18	primary care physicians, behavioral and mental health
19	care providers, and hospitals;
20	(2) Assisting victims of sexual violence and abuse in
21	obtaining appropriate government entitlements, access,

9	SECTION 3. Section 431M-2, Hawaii Revised Statutes, is

13	hospital or medical service plan contracts, and nonprofit mutual
14	benefit society, fraternal benefit society, and health
15	maintenance organization health plan contracts shall include

The Department of Commerce and Consumer Affairs ("Department") appreciates the opportunity to testify on H.B. 2128, Relating to Victims of Sexual Violence. My name is Gordon Ito, and I am the Insurance Commissioner for the Department's Insurance Division. The Department submits the following comments on this bill, which is a companion to S.B. 2342.

The purpose of this bill is to require coverage for clinical victim support services for victims of sexual violence and abuse who suffer from mental disorders.

This bill purports to mandate appropriate, related clinical victim support services by qualified mental health providers, and this may be viewed as a new mandate. The addition of a new mandated coverage may trigger section 1311(d)(3) of the federal Patient Protection and Affordable Care Act ("PPACA"), which requires states to defray the additional cost of any benefits in excess of the essential health benefits of the State's qualified health plan under PPACA.

Additionally, any proposed mandate providing coverage for care requires the passage of a concurrent resolution requesting the State Auditor to prepare and submit a report assessing the social and financial impacts of the proposed mandate, pursuant to Hawaii Revised Statutes section 23-51.

Chair, Vice-Chair, and committee members thank you for this opportunity to provide testimony on this bill relating to insurance coverage for mental health services for victims of sexual violence.

Kaiser Permanente Hawaii supports the intent of this bill, but requests an amendment.

Kaiser Permanente Hawaii supports this bill's intent to promote mental health service availability for victims of sexual violence and abuse. Kaiser Permanente already provides clinical counseling for sex abuse victims through its Integrated Behavioral Health (IBH), which is an integration of Kaiser Permanente's psychiatry/psychology/licensed social work counselor departments.

However, as this bill recognizes, there is a lack of access to professional clinical services due to the "<u>limited availability of qualified mental health providers</u> who are able to take on potentially complex mental health cases." See Page 2, Lines 13-14. To free up much-needed access to professional clinical services by qualified mental health providers, we request an amendment to add <u>unlicensed clinical staff</u>, under the supervision of qualified mental health providers, to assist in providing the case management functions included under "clinical victim support service", i.e., coordinating with other health care providers, assisting victims in obtaining government entitlements, and coordinating with schools, employers, etc. This addition will allow more flexibility by allowing clinical staff such as case managers/care coordinators, under the supervision of qualified mental health providers, to perform these more administrative case management functions and ease demand strain on qualified mental health providers (to allow more opportunity for these providers to focus on providing psychotherapy services, etc.).

The Hawaii Medical Service Association (HMSA) appreciates the opportunity to testify on HB 2128 requiring health insurance coverage for clinical victim support services for victims of sexual violence. HMSA appreciates the intent of this measure and respectfully offers the following comments.

On the Committee's recommendation last Session HMSA met with the proponents of the bill during the interim to better understand the type of services that they seek to include as part of this benefit. We received a list of those services on the afternoon of 1/29/18 and are in the process of comparing it to the qualified case management services we provide.

That being said, we do continue to believe this bill is unnecessary as there is no distinction made when a member has a mental health issue in regards to the cause or reason for the condition; we do, however, understand and appreciate that victims of sexual violence have particular support service needs that deserve specific consideration and we believe we meet these needs.

We also draw the Committee's attention to the following:

- HMSA's existing case management services meet the intent of this measure; however, as drafted this measure could expand benefits beyond what plans currently offer. In particular, Section 2(3), coordination with schools, employers, and other individuals and entities concerning the victim.
- Section 2, consider replacing "qualified mental health provider" with "licensed mental health provider" and include an accompanying definition consistent with the statute.

We will continue to work with stakeholders to find common ground. Thank you for allowing us to provide these comments on HB 2128.

Good morning Chair Mizuno, Vice Chair Kobayashi, and members of the House Committee on Health and Human Services:

The Sex Abuse Treatment Center (SATC) strongly supports H.B. 2128.

According to The Centers for Disease Control, sexual violence is extremely prevalent in the United States. It is estimated that 22 million women and 1.6 million men are victims of rape, while 53 million women and 25 million men have experienced some other form of sexual violence in their lifetimes. Trauma caused by this sexual violence can have significant, lasting impacts on a victim's mental health that interfere with their functional ability to engage and interact with the world, with 81% of women and 35% of men reporting significant short- or long-term impacts such as post-traumatic stress disorder.

In addition to psychotherapy, victims with mental health conditions caused by sexual violence can require clinical victim support services, a professional intervention delivered by a qualified mental health provider with whom the victim has established a therapeutic relationship. Clinical victim support services can include working with schools, employers and other individuals and entities on such issues as safety planning and reasonable accommodations for the victim's mental health conditions; assisting a victim to obtain entitlements and access programs and services offered by government agencies and community organizations; and coordinating with a victim's other health care providers, such as primary care physicians and hospitals.

These services are particularly responsive to some victims' need for assistance coping with daily stressors, which they are unable to manage on their own due to their sexual violence-related mental health conditions. The trust and understanding developed between a victim and their therapist is critically important to the effectiveness of these services: the therapist, having received the victim's disclosure of sexual violence and possessing in-depth knowledge of how that trauma impacted the victim, is in the best position to identify the victim's specific needs and provide direct support to them.

As such, clinical victim support services are a best practice and are medically necessary for some victims to recover and heal, while avoiding additional harm and decompensation. These services are also consistent with a health care approach that invests in preventing the need for more costly interventions, such as hospitalization.

Unfortunately, clinical victim support services delivered by the victim's own therapist are not routinely covered by health insurers, which causes some qualified mental health providers to decline to accept cases that could be complex and require substantial unreimbursed time and effort, or to provide a lower level of service than may be needed to fully address a victim's condition. SATC notes that this contributes to a significant capacity issue that prevents victims from accessing services in the community and reduces their options for treatment.

H.B. 2128 is narrowly tailored to remove this barrier, by ensuring that health insurance coverage for mental health services allows qualified mental health providers are able to deliver both psychotherapy and clinical victim support services, and accurately reflects the range of medically necessary care that is needed for victims of sexual violence to recover and heal.

Therefore, we respectfully urge you to support H.B. 2128.

Position Statement in Support of House Bill 2128

Good afternoon Chair Mizuno, Vice Chair Kobayashi, and members of the committees,

Thank you for the opportunity to testify in strong support of HB 2128 which requires health insurers to provide coverage for clinical victim support services for victims of sexual violence and abuse who suffer from mental disorders. Almost 90 percent of women in jail are survivors of sexual violence¹. Additionally, evidence has shown that substance abuse is highly correlated with women's physical and sexual abuse². Many have never received treatment for the trauma and the issues from the violence plague the person and can manifest in unhealthy and dangerous ways. However, with treatment the person is better able to lead a productive, normal life.

Beyond disrupting the patient-therapist relationship and inserting a delaying and distorting layer of bureaucracy between the survivor and services that may be urgently needed, this approach to case management could be construed as an intrusion when applied to a survivor of sexual violence.

An integral part of treatment is the support of a skilled mental health case manager. The case manager assists the person in recovery and healing by communicating and coordinating with systems, programs, and people. Although this seems a simple task, the stress it brings can be overwhelming and can cause additional harm to the survivors when attempted on their own.

Unfortunately, case management for survivors of sexual violence is not routinely covered by health insurers, which causes some mental health providers to decline to accept cases that could be complex and require substantial unreimbursed services, or to provide a lower level of service than may be needed to appropriately address a survivor's condition. This bill would ensure health insurance coverage for mental health services includes case management.

For these reason, I respectfully urge you to support House Bill 2128.

Good morning. My name is Melodie Aduja. I serve as Chair of the Oahu County Committee ("OCC") Legislative Priorities Committee of the Democratic Party of Hawaii. Thank you for the opportunity to provide written testimony on House Bill No. 2128 regarding clinical victim support services for victims of sexual violence and abuse.

The OCC Legislative Priorities Committee is in favor of House Bill No. 2128 and support its passage.

House Bill No.2128 is in accord with the Platform of the Democratic Party of Hawai'i ("DPH"), 2016, as it requires that health insurance policies include coverage for clinical victim support services for victims of sexual violence and abuse who suffer from mental disorders.

Specifically, the DPH Platform provides that we "believe in women's equality and right to privacy, including but not limited to equal access to reproductive services and care, shelter, and counseling for victims of domestic violence and the right of rape victims to emergency contracption in the emergency room." (Platform of the DPH, P. 4, Lines 170-172 (2016).

We also support the establishment of adequate mental health and statewide drug rehabilitation programs set up in conjunction with policing policies aimed at enabling all that seek assistance to obtain whatever support assistance is needed to allow them to remain free of drug dependence" (Platform of the DPH, P. 7, Lines 383-384 (2016)).

Given that House Bill No. 2128 requires that health insurance policies include coverage for clinical victim support services for victims of sexual violence and abuse who suffer from mental disorders, it is the position of the OCC Legislative Priorities Committee to support this measure.

Honorable Chair Mizuno and committee members:

I am Kris Coffield, representing IMUAlliance, a nonpartisan political advocacy organization that currently boasts over 400 members. On behalf of our members, we offer this testimony in strong support of House Bill 2128, relating to victims of sexual violence.

IMUAlliance is one of the state's largest victim service providers for survivors of sex trafficking. Over the past 10 years, we have provided comprehensive direct intervention services to 130 victims, successfully emancipating them from slavery and assisting in their restoration, while providing a range of targeted services to over 1,000 victims in total. Each of the victims we have assisted has suffered from complex and overlapping trauma, including post-traumatic stress disorder, depression and anxiety, dissociation, parasuicidal behavior, and substance abuse. Trafficking-related trauma can lead to a complete loss of identity. A victim we cared for in 2016, for example, had become so heavily trauma bonded to her pimp that while under his grasp, she couldn't remember her own name.

Sex trafficking is a profoundly violent crime. The Average age of entry into commercial sexual exploitation is 13-years-old, with 60 percent of trafficked children being under the age of 16. Approximately 150 high-risk sex trafficking establishments operate in Hawai'i. An estimated 1,500-2,500 women and children are victimized by sex traffickers in our state annually. Over 120,000 advertisements for Hawai'i-based prostitution are posted online each year, a number that is rapidly increasing as technology continues to outpace the law. More than 80 percent of runaway youth report being approached for sexual exploitation while on the run, over 30 percent of whom are targeted within the first 48 hours of leaving home. With regard to mental health, sex trafficking victims are twice as likely to suffer from PTSD as a soldier in a war zone. Greater than 80 percent

of victims report being repeatedly raped and 95 percent report being physically assaulted, numbers that are underreported, according to the United States Department of State and numerous trauma specialists, because of the inability of many victims to recognize sexual violence. As one underage survivor told IMUAlliance prior to being rescued, "I can't be raped. Only good girls can be raped. I'm a bad girl. If I *want* to be raped, I have to *earn* it."

Slavery has no place in paradise. For the sake of our survivors, we ask you to do all you can to ensure—and insure—their access to mental health services, including clinical case management. Mahalo for the opportunity to testify <u>in strong support</u> of this bill.

On behalf of Hawaii Children's Action Network (HCAN), we are writing to support HB 2128 – Relating to Victims of Sexual Violence.

The Centers for Disease Control and Prevention estimate that 9% of child maltreatment cases involve sexual abuse. Experiencing sexual violence or abuse at a young age can cause serious trauma, and significantly increases the likelihood that the child will experience negative health and well-being outcomes throughout their lifetime.

After experiencing sexual violence, children often require comprehensive medical and psychological services to help them heal, continue healthy neurodevelopment, and navigate everyday life. In addition to psychotherapy, sexual violence victims may require clinical victim support services, a professional intervention delivered by a qualified mental health provider with whom the victim has established a therapeutic relationship. This relationship of trust is especially important when dealing with child victims. Clinical support services could include working with a child's school or other entities to arrange reasonable accommodations to address the child's needs, helping a child and their family to access government or community programs and services, and coordinating with the child's pediatrician.

These services are often medically necessary to address a victim's needs and may prevent the need for more costly interventions. Unfortunately, these services are also routinely not covered by health insurance. This severely limits services' accessibility to children in low-income households. This bill is necessary because it will ensure that children are not denied access to the services they need to heal from sexual abuse simply because their parents cannot afford it.

For these reasons, HCAN respectfully requests that the committee PASS this bill.

HCAN is committed to building a unified voice advocating for Hawaii's children by improving their safety, health, and education.

RE: Testimony in **SUPPORT** of HB 2734: RELATING TO PRESCRIPTIVE AUTHORITY FOR CERTAIN CLINICAL PSYCHOLOGISTS.

I am writing this testimony in strong support of HB2734. This bill will provide the foundation to explore the suitability of Prescriptive Authority for specially trained advance practice Psychologists to be able to support psychotherapy with psychopharmacological support in Hawai'i's underserved communities.

Currently, clinical psychologists working side by side with our physician colleagues in Hawai'i's community health centers provide much needed care for those who would otherwise be without. Given that approximately 3/4's of mental health disorders are diagnosed and treated in the primary care arena, having these highly trained and skilled providers in the community health centers where patients enter the system makes good sense. In fact, in Hawai'i's outlying health centers, this has translated to increased access to mental health care for this population and a general improvement in the quality of care. However, there are still impediments to providing our rural patients the highest quality of care. For example, in busy clinics with limited personnel and scarce resources, care can become fragmented as the patient may need to keep multiple doctor visits for the treatment of a single problem (a psychologist to provide psychotherapy and a primary care physician to prescribe the medications, for example).

HB2734 will help remedy this situation by providing the foundation to explore the value of having appropriately trained psychologists appropriately utilize medication in conjunction with the apposite psychotherapy. It is notable that many of the primary care physicians and community health center providers among others that treat Hawaii's medically underserved are

in support of this. Psychologists in this setting are already providing high quality patient care and are recognized as having specialized psychopharmacologic knowledge.

Interestingly, many who oppose this bill, are not presently working in Hawai'i's rural community health centers or have had very limited exposure to the psychologists who do. They cite concerns about patient safety as their primary concern. Patient safety should be the concern of all health care providers. However, as a scientist, I look to the data to support my evaluation and diagnosis. While there is much hyperbole about this concern, it is not borne out by the facts. There are no studies to date in which psychologists as a group have caused harm to their patients through their prescribing practices. The opponents to this legislation seem to imply that medication is somehow magic; it of course is not. It is simply science and science is apprehendable.

On average, psychologists require eight years post baccalaureate to earn their doctorates. This is twice as long as the training required for our physician colleagues to prescribe. In addition, this bill requires additional postdoctoral training in pharmacology. For the opponents of this bill to imply that it is not possible for psychologists to be appropriately trained to prescribe medications is not only illogical, it is also inaccurate. Psychologists have safely and efficaciously prescribed medications to patients in a variety of settings from 1974 through today, providing citizens with much needed access to the high quality health care we all deserve. As a retired Federal psychologist I have safely and thoughtfully written in excess of 8,000 prescriptions to those in need of such care.

HB2734 will provide the foundation to explore appropriate adjuvant psychopharmacologic interventions, thereby increasing much needed mental health services to Hawai'i's medically underserved.
