# TESTIMONY OF THE OFFICE OF THE LIEUTENANT GOVERNOR TO THE HOUSE COMMITTEE ON FINANCE

## HOUSE BILL NO. 2156, HOUSE DRAFT 2 Relating to the Hawaii Farm to School Program

February 27, 2018

Chair Luke, Vice Chair Cullen, and Members of the Committee:

The Office of the Lieutenant Governor appreciates this opportunity to testify in **strong support** of House Bill No. 2156, House Draft 2. The vision of farm to school is to improve the health of schoolchildren and support local agriculture by incorporating fresh, local food into child nutrition programs. Since 2015, my predecessor former Lt. Governor Shan Tsutsui spearheaded the Hawaii Farm to School Initiative to test whether this vision is achievable for Hawaii. I am proud to continue to work to achieve this vision, now that a team of public and private partners have demonstrated that yes, it is possible but not without some significant changes made by the Hawai'i Department of Education (HIDOE) to its approach to school food, including (at a minimum):

- (1) Introduction of new menus with recipes that emphasize fresh, local food;
- (2) Institution of staff training to be able to prepare these new recipes;
- (3) Collection of data, financial analysis, leadership training, and waste management to create the efficiencies needed to afford better quality food;
- (4) Conducting agricultural market research and networking to source local food and build supply over time;
- (5) Exploration of new approaches to procurement and contracts with multiple local food vendors; and
- (6) Implementation of nutrition education to encourage students to try new foods and make healthy food choices.

The 'Aina Pono Executive Committee which includes my office, HIDOE, the Kohala Center, and Beyond Green Sustainable Partners has worked tirelessly to show proof of concept. The Legislature now has the opportunity to expand this vision for Hawaii by formally establishing the 'Aina Pono Farm to School Program in the HIDOE with dedicated farm to school staff positions.

As state leaders, we must make 'Aina Pono a state priority through policy and legislation. The program has the potential to support local agriculture, boost academic performance and childhood health through improved nutrition, increase food security statewide, and create jobs. The program also impacts multiple departments, including HIDOE, HDOA, HDOH, DLIR, among others. A message from state leadership prioritizing the implementation of 'Aina Pono will set the stage for prioritizing the project within these various departments.

We must also encourage and empower HIDOE – as the single largest public purchaser of food and lead implementing agency for 'Aina Pono – to undertake the significant efforts listed above to implement the program statewide, which amounts to broad-based systems changes within the HIDOE's School Food Services Branch (SFSB). Each of HIDOE's recent internal audits of SFSB indicates that SFSB is understaffed. SFSB simply cannot undertake this level of work without sufficient staffing. Accordingly, I ask for your help to demonstrate the state's staunch commitment to the 'Aina Pono Farm to School Program and favorably consider this measure.

#### HOUSE BILL NO. 2156 HD2 RELATING TO THE HAWAII FARM TO SCHOOL PROGRAM

Chairperson Luke and Members of the Committee:

Thank you for the opportunity to testify on House Bill No. 2156 HD2. The purpose of this bill is to establish a farm to school program in the Department of Education with dedicated farm to school staff positions to work with the Farm to School Coordinator in the Department of Agriculture, to grow and sustain the Hawaii Farm to School Program. The Department of Agriculture supports this measure.

When the legislature established the Hawaii Farm to School Program in the Department of Agriculture with Act 218 (SLH 2015), the Farm to School Coordinator began working with Department of Education to "address the issues of supply, demand, procurement, and consumption of Hawaii-grown foods in state facilities" (HRS §141-11(b)), as well as accelerate school garden and farm based education, and expand the relationships between public schools and agricultural communities (HRS §141-11(a)). This measure supports the necessary coordination between the Department of Education and the Department of Agriculture for farm to school success.

Through the leadership of the Office of the Lieutenant Governor, the Department of Education's School Food Services Branch (HIDOE-SFSB) has implemented the 'Aina Pono farm to school initiative, to develop more scratch cooked meals for students and source more locally grown foods for new recipes. In support of these efforts, the



Department of Agriculture has developed the "Hawaiian Harvest of the Month" with stakeholders, as a farm to school promotion and outreach program to connect inseason Hawaii –grown food to school cafeterias, student education activities, recipe development, and farmer outreach. We have seen some success with December's local beef month and are eager to continue working through seasonal items with HIDOE-SFSB.

The Department of Agriculture is encouraged by the increased purchases of locally grown food the Department of Education has been procuring from local vendors, and supports their continued efforts to work with our local producers. Establishing a Farm to School Program with dedicated coordinators within the Department of Education will provide the critical support to build on the momentum of the current initiative and institutionalize a program with protocols that should work for the Department of Education.

Chair Luke and Members of the Committee:

The Hawaii State Teachers Association <u>supports HB 2156 HD2</u>, relating to the farm to school program.

We need to restore the balance in our public educational system in Hawaii. Hawaii's Career and Technical Education programs need to be expanded to provide greater opportunity to prepare young people to design their own futures. The purpose of this Act is to authorize the department of education to establish a farm to school program to be managed by department staff and, if the program is established, to require the department of education to work with the farm to school coordinator in the department of agriculture to grow and sustain the Hawaii farm to school program.

This act would provide a farm to school coordinator who shall work in collaboration with the department of education to help to make the connections with teachers in the DOE to help them understand not only how the agriculture workforce needs have changed over time, but also how to incorporate sustainability in agriculture that is in high demand in Hawaii and how Farm to School promotes the use of school gardens, sustainability, and healthy eating.

According to the Hawaii Agriculture Skill Panel Report from the Workforce Development Council, the average age of Hawaii's commercial farmers is over 60

years old. Interest in agriculture is waning in our youth and this is worrisome to the industry and to the economy and self-sustainability of our state. There is a common misconception that farming is a low-paying, low-skilled trade. Our youth need to understand that there are a variety of careers within the agricultural industry that need to be filled. They need more workers that are not only technical in nature, but also those who will help to solve the problems listed in the report such as developing new technology and developing ideas for innovation that are critical components to the growth and expansion of the agricultural industry in Hawaii, especially in the areas of sustainability. The agricultural industry also needs workers in business, marketing, and management to refine and streamline production and distribution, along with workers to guide the industry in using sustainable practices, Organic farming, Soil building, and Natural Farming.

Passage of this bill would help provide schools with opportunities for their students to learn about sustainability, healthy eating, and the changing needs of agriculture. It will also provide their teachers with the knowledge they need to incorporate agricultural career paths into their curriculum using school gardens, and farm to table programs with their students.

Hawaii, like most states, is working toward the goal of getting their students 'college-and career-ready,' but CTE experts are concerned that what we mean by 'career-ready' is not always clear, and the supply of quality career-technical education programs has not kept pace with demand. Students must have several options available to them in order to explore a variety of career options, one of them being in agriculture. This bill supports these efforts.

According to a national study, The Shocking Truth About The Skills Gap (2015), only 25 percent of polled job seekers reported receiving career path in high school, and 41 percent said they wished they had received more guidance.

Because a robust education involves developing all aspects of learning for our everchanging world including the changes in agriculture, and how vital it is to sustainability, the Hawaii State Teachers Association asks your committee to support this bill.

Aloha Chair Luke, Vice Chair Cullen, and Members of the Committee:

I am Randy Cabral, President of the Hawaii Farm Bureau (HFB). Organized since 1948, the HFB is comprised of 1,900 farm family members statewide, and serves as Hawaii's voice of agriculture to protect, advocate and advance the social, economic and educational interests of our diverse agricultural community.

The Hawaii Farm Bureau supports HB 2156, HD2, which authorizes the Department of Education to establish a farm to school program, requires the farm to school coordinator in the department of agriculture to work in collaboration with the department of education on any farm to school program, and establishes two FTE farm to school staff positions within the department of education

HFB strongly supports increased use of locally grown agricultural products, fruits, vegetables, meats, dairy and poultry products in our schools and other public institutions. This will truly be a significant step towards increasing our levels of self- sufficiency. HFB also believes that learning where food comes from is an important part of our children's education. Agriculture education involves more than just learning the basics of food production, it provides the opportunity for our children to understand and appreciate the importance of agriculture.

Many formal and informal studies have been done addressing farm to school programs. Our farmers and ranchers have tried to work with the procurement system and can speak about the challenges of the system. For example, supplying a school or schools within a geographic area is feasible, but providing to the entire school system is not. Focus should now be on working with the procurement system to make institutional markets accessible while considering the capacity of farmers and ranchers in Hawaii. Assistance to farmers on how to navigate the system should be a priority.

HFB recognizes the need and importance of agricultural education and school farm programs, and as a farm organization we would like to see increased emphasis of agriculture in schools. We believe that school farms serve multiple purposes. They serve not only to educate students on how to grow crops but also what it takes to turn a farm into a successful business enterprise that can be a career choice. Agronomy, economics, science, business planning, entomology, pathology and various technologies including programming, navigation and robotics are some of the courses that can evolve around the farm. Programs that teach the principles behind good agricultural practices - steps that must be taken that protect the environment, product, and worker are critical components of a school farm. The purpose of the farm should be to educate and expose students to a career choice.

Developing and maintaining an agricultural workforce should be a vital component of this program. A trained workforce with various skills is necessary to any agricultural operation. This need has to be addressed along with generating interest in our youth to pursue the various careers and to become our future leaders in Hawaii agriculture. HFB supports programs and initiatives such as the FFA, 4-H, and Farm to School programs because they help to educate and reconnect our children with agriculture. Through agricultural education programs, our children will gain an understanding and appreciation for agriculture which will result in healthier eating habits, stronger support for Hawaii's agriculture industry and will contribute to Hawaii's food security.

This should be viewed is an investment in Hawaii's future to develop well-informed consumers and supporters of our local agricultural industries.

Thank you for the opportunity to testify in **strong support** of HB 2156 HD 2, which authorizes the Hawai'i Department of Education (HIDOE) to establish a Farm to School Program and establishes two HIDOE Farm to School staff positions.

The Hawai'i Public Health Institute (HIPHI) works to advance policy and systems change to reduce disparities and improve the health of Hawai'i residents. HIPHI is home to the Obesity Prevention Task Force and the Hawai'i Farm to School Hui<sup>i</sup>.

#### State-level support is critical to the success of Farm to School in Hawai'i

HB 2156 helps to support the progress made by HIDOE toward improving the quality of meals served in Hawaii's public schools. Locally sourced and scratched cooked recipes and menus were tested in the Kohala Complex on Hawaii' Island during the 2016-2017 school year; the inaugural year of the HIDOE 'Aina Pono Farm to School Program. With lessons learned from Phase I, the HIDOE School Food Services Branch (SFSB) has recently expanded the program to Mililani High School, which is HIDOE's second largest food production site in the state, serving over 3,000 meals per day. State-level funding will continue to build upon these successes and expand Farm to School to HIDOE schools.

#### Strong public support for Farm to School

Farm to School programs promote healthy eating habits for Hawaii's keiki both in school and at home through education, school gardens, and school food improvements. Public support for Farm to School is strong. In a recent public opinion poll<sup>ii</sup> conducted for HIPHI, 93% of registered Hawaii' voters support increasing government funding to provide more locally grown food served in school meals, while 90% support increasing government funding to provide healthier foods in our schools and communities. In addition, stakeholders from the Obesity Prevention Task Force and the Hawaii Farm to School Hui have identified this bill as a top legislative priority.

#### Dedicated Farm to School staff are required for statewide expansion

Ensuring that these school food improvements are made available every day to all 180,000 of Hawaii's public school students requires the full time dedication of two Farm to School staff within HIDOE. These positions are essential to:

- Expanding school food improvements statewide
- Providing critical support for school garden programs from within HIDOE
- Establishing a protocol for serving school garden-grown produce in school cafeterias

#### Farm to School activities help to promote healthy habits among our keiki

In Hawai'i, a growing public health concern is that approximately 1 in 4 children entering kindergarten are overweight or obese. Among high school students, only 1 in 5 (21.2%) consume fruit 2+ times daily and 1 in 9 (11.8%) consume vegetables 3+ times daily<sup>iii</sup>. Successful Farm to School programs can increase students' physical activity, school meal participation, preference for fresh fruits and vegetables, and improve academic achievement and behavior.

HB 2156 HD 2 provides essential state-level support for expanding Farm to School in Hawai'i and improving our local school food systems. We respectfully ask you to pass this measure out of committee.

The **Hawai'i Farm to School Hui** is a statewide network whose mission is to strengthen Hawaii's Farm to School movement by supporting our island networks in the areas of capacity building, resource development and sharing, professional development, and policy development and advocacy. The Hui is comprised of five island-level school garden and Farm to School networks, community organizations and schools, and representatives from the Hawai'i Departments of Agriculture, Education, and Health and the University of Hawai'i. The Hui formed in 2010 and became a program of HIPHI in 2017.

## American Heart Association in SUPPORT of HB 2156, HD2 "Relating to the Hawaii Farm To School Program"

The American Heart Association supports HB 2156, HD2 "Relating to the Hawaii Farm to School Program," but suggests amending line 10 on page 3 to "The Department shall...".

The Farm to School Program helps students develop a rich understanding and appreciation for fresh fruits and vegetables, making it easier to continue practicing healthy eating habits at home.

Obesity is an epidemic in Hawaii, with adult rates more than doubling since the mid-1990s. Additionally, about one in every three children entering kindergarten in our state is already overweight or obese. The danger is that obesity can lead to chronic diseases later in life, such as diabetes, heart disease and some cancers. It is also costly to our society; each year, Hawaii spends roughly \$427 million obesity-related health care costs.

Staying active and eating healthy food are the two main ways to prevent obesity and reduce the risk of chronic disease. Establishing healthy behaviors at an early age can help to prevent the onset of many of the common chronic diseases. The American Heart Association estimates that 80 percent of heart disease and stroke is preventable through improved lifestyle habits.

Eating a variety of fruits and vegetables may help control both weight and blood pressure, and they contribute a number of important nutrients that most people don't get enough of, including folate, magnesium, potassium and dietary fiber, as well as vitamins A, C, and K. And they are naturally low in saturated fat and calories. The American Heart Association recommends eating eight or more fruit and vegetable servings every day. Average adults consuming 2,000 calories daily should aim for 4.5 cups of fruits and veggies a day. Variety matters, it's important to eat a wide range of fruits and veggies.

Teaching our keiki from a young age the value of healthy, fresh, and local foods can establish in them healthier eating habits that will continue through their lifespan. The American Heart Association encourages legislators to support HB 2156, HD2 with the AHA's suggested amendment.

To the Honorable Sylvia Luke, Chair; the Honorable Ty J.K. Cullen, Vice-Chair, and Members of the Committee on Finance:

Good afternoon, my name is Melodie Aduja. I serve as Chair of the Oahu County Committee ("OCC") Legislative Priorities Committee of the Democratic Party of Hawaii. Thank you for the opportunity to provide written testimony on House Bill No. 2156, **HD2**, relating to the Keiki Caucus; Hawaii Farm to School Program; Department of Agriculture; Department of Education; and an appropriation.

The OCC Legislative Priorities Committee is in favor of House Bill No. 2156, **HD2** and supports its passage as it authorizes the Department of Education to establish a farm to school program.

House Bill No. 2156, **HD2** is in alignment with the Platform of the Democratic Party of Hawai'i ("DPH"), 2016, as it authorizes the Department of Education to establish a Farm to School Program; requires the Farm to School Coordinator in the Department of Agriculture to work in collaboration with the Department of Education on any Farm to School Program; establishes two FTE Farm to School staff positions within the Department of Education; and appropriates funds.

The DPH Platform states that "[w]e believe a major role of education is to develop critical and creative thinkers who are knowledgeable about issues and able to evaluate and solve real-world problems. The curriculum also should emphasize cultural learning, the arts, career and trade skills, and physical education so that we may preserve our health and rich cultural history. A variety of learning strategies should be used, including group projects, cooperative learning, discussion, games and technological innovations." (Platform of the DPH, P. 6, Lines 310-314 (2016)).

"As an island state, securing affordable food for all is a priority. We support healthy, sustainable, and diversified local food production, and "Buy Local" strategies to assure greater food security and food safety." (Platform of the DPH, P. 2, Lines 97-99 (2016)).

"We support community health initiatives that provide opportunities for the overall health of communities through strategic projects and programs focusing on increased interaction and physical activities among all age groups, as well as on better nutrition." (Platform of the DPH, P. 7, Lines 378-380 (2016)).

Given that House Bill No. 2156, **HD2** authorizes the Department of Education to establish a Farm to School Program; requires the Farm to School Coordinator in the Department of Agriculture to work in collaboration with the Department of Education on any Farm to School Program; establishes two FTE Farm to School staff positions within the Department of Education; and appropriates funds, it is the position of the OCC Legislative Priorities Committee to support this measure.

Dear Chair Luke, Vice Chair Cullen, and Members of the Committee:

My name is Kyle Datta and I am General Partner of Ulupono Initiative, a Hawaiʻi-based impact investment firm that strives to improve the quality of life for the people of Hawaiʻi by working toward solutions that create more locally produced food; increase affordable, clean, renewable energy; and better management of waste and fresh water. Ulupono believes that self-sufficiency is essential to our future prosperity and will help shape a future where economic progress and mission-focused impact can work hand in hand.

**Ulupono** <u>strongly supports</u> **HB 2156 HD 2**, which establishes a farm to school program and two critical positions within the Department of Education, because it aligns with our goal of creating more locally produced food.

This program incorporates more locally grown scratch-cooked meals into our public school cafeterias and is a win for all parties involved. This effort started decades ago with passionate advocates, was test trialed in the last year at the Kohala school complex via funding by private sector and non-profit foundation grants, and resulted in adoption by the Department of Education after demonstrating initial success thru data. The results were encouraging, including greater meal participation, less food waste, far higher local food and fresh food content, and, bottom line, lower cost per meal eaten. It also sets the foundation for our students to understand the value and benefits of a scratch-cooked meal and why fresh, locally produced foods are important, thereby influencing their behavior, health, and purchasing decisions for the rest of their lives.

We applaud the Department of Education's leadership to expand this pilot to more schools with the longer-term intention of a statewide rollout.

For farm to school to grow successfully to all public schools statewide, there needs to be additional staff within the Department of Education to manage this program. Based upon the trial results, we believe this program will:



- · Allow our public school children to eat healthier, more delicious school meals,
- Further educate students about the foods they eat and farming as a career,
- Grow our local agricultural industries,
- Reduce food waste, and
- Increase profitability for State government

We urge this committee to pass funding for this program and the staffing positions.

As Hawai'i's local food issues become more complex and challenging, organizations need additional resources and support to address and overcome them. We appreciate this committee's efforts to look at policies that support local food production.

We believe that by collaborating, we can help produce more local food and support an economically robust homegrown agriculture industry, which strengthens our community with fresh, healthy food. Thank you for this opportunity to testify.

'ĀINA (Actively Integrating Nutrition & Agriculture) In Schools is a farm to school initiative launched in 2006 that connects children to their local land, waters, and food to grow a healthier Hawai'i. In addition to encouraging the use of locally grown fruits and vegetables in school meals and snacks, the program includes a standards-based nutrition, garden, and compost curriculum that empowers children to grow their own food, make informed food decisions, and reduce waste. 'ĀINA In Schools also promotes field trips to local farms, chef cooking demonstrations in classrooms, as well as waste reduction, garden, and cooking educational opportunities for families and community members. We work directly with 23 O'ahu elementary schools that have implemented the program school-wide. We have also trained an additional 472 educators from over 239 schools and organizations from across the state in the use of our 'ĀINA garden, composting, and nutrition curricula.

**HB2156 HD2** is essential to expanding Farm to School statewide, providing necessary support to the Department of Education to improve school food environments, incorporate school garden programs in the school curriculum, and work with stakeholders to increase educational opportunities and the procurement of locally grown produce in school cafeterias.

With more than 85 percent of Hawai'i youth attending public schools, Farm to School is an ideal program that would bring parents, students, teachers, and farmers together to strengthen what is grown and consumed in our state. More importantly, students who participate in Farm to School activities are more likely to be familiar with, prefer, and consume fruits and vegetables at school and at home. It is never too early to establish healthy behaviors to prevent unhealthy weight gain, tooth decay, or Type 2 diabetes, which are often associated with unhealthy dietary behaviors. Please see the attached document from the National Farm to School Network, "The Benefits of Farm to School" for specific examples and statistics of how farm to school programs benefit students, schools, and local economies.

Farm to school enriches the connection communities have with fresh, healthy food and local food producers by changing food purchasing and education practices at schools and early care and education sites. Farm to school empowers children and their families to make informed food choices while strengthening the local economy and contributing to vibrant communities. Farm to school implementation differs by location but always includes one or more of the following three core elements:

**Procurement:** Local foods are purchased, promoted and served in the cafeteria, as a snack or in classroom taste-tests.

**School gardens:** Students engage in hands-on, experiential learning through gardening.



#### TESTIMONY TO THE HOUSE COMMITTEE ON FINANCE HB 2156, HD2

Relating to the Hawaii Farm to School Program February 26, 2018

Dear Chair Luke and Vice Chair Cullen,

The Kohala Center <u>strongly supports</u> House Bill No. 2156, House Draft 2. Through this bill, the Hawai'i State Legislature can make farm to school a clear state priority and empower the Hawai'i State Department of Education (HIDOE) to implement this important program.

#### **Benefits of Farm to School**

For over a decade, The Kohala Center has been dedicated to advancing farm to school in Hawai'i due to the far reaching potential benefits, including:

- Educational benefits: improved academic performance
- Agricultural benefits: increased demand for local food and increased local food production
- Public health benefits: improved childhood nutrition and increased food security
- **Economic benefits**: increase in federal dollars to Hawai'i, expanded agricultural industry, increase in jobs, and improved HIDOE financial accountability

#### 'Aina Pono Farm to School Program - Pilot

In 2015, The Kohala Center joined former Lt. Governor Shan Tsutsui's Hawai'i Farm to School Advisory Group, and in 2016 we became a member of the Executive Committee to pilot the 'Aina Pono Farm to School Program. From 2016-2018, we secured over \$750,000 in grant funding to implement the 'Aina Pono pilot program at the Kohala Complex on Hawai'i Island (beginning in 2016) and at Mililani High School on O'ahu (beginning in January 2018). This private funding also supports data tracking and analysis, the development of new farm to school protocols with School Food Services Branch (SFSB), a farm to school professional development guide for HIDOE cafeteria staff, summer cafeteria staff training, agricultural market research, and assistance with branding, communications and outreach.

Thanks to this substantial investment from the private sector, the pilot program has demonstrated that farm to school is possible in Hawai'i. At the pilot schools, cafeteria staff are chopping fresh local fruits and vegetables, making fresh hamburgers and meatballs from local ground beef, and creating sauces from scratch. In one semester in Kohala:

- local food doubled from 20% to 43%;
- fresh food increased from 27% to 80%;
- participation in school meal programs increased from 51% to 54%; and
- the cafeteria saved \$30,000.

#### 'Aina Pono Farm to School Program - Moving Forward

The pilot program has demonstrated that implementing farm to school requires significant changes in the way SFSB does business. We applaud and greatly appreciate the new SFSB administrator's support for farm to school. *However, according to several years of internal DOE audits and consultant reports, SFSB is currently understaffed and school cafeteria staff are undertrained*. SFSB Supervisors each oversee over 30 schools *plus* an entire departmental function, such as procurement, technology implementation, and menu development.

Compared to their peers in the nation's top ten largest school districts, including New York, Los Angeles, and Miami-Dade, SFSB Supervisors have unmanageable workloads and their audits reflect that reality. SFSB simply cannot implement Farm to School without sufficient staff and resources.

The following changes are necessary to implement Farm to School:

- Menu Development. Farm to School requires shifting from one menu for the entire state to islandspecific menus with recipes that use fresh, local food and take into account feedback from cafeteria staff and students.
- 2. **Staff Training**. Farm to School requires training cafeteria staff at 256 schools to cook with fresh food. For years SFSB meals have included primarily processed foods. Using fresh food requires different food preparation procedures, skills, and techniques.
- 3. **Financial Accountability**. Farm to School requires strong financial accountability and management to create a program that is financially viable in the long-term. At present, SFSB does not provide cafeterias with budgets, nor does it track profit and loss per cafeteria. To effectively manage costs, SFSB must hold cafeteria managers accountable to a budget and analyze profit and loss per cafeteria. An increase in accountability is essential for the USDA to even consider raising Hawai'i's federal reimbursement rate for federal child nutrition programs to reflect Hawai'i's higher cost of living. Alaska was granted an increase but SFSB's financial recordkeeping contributed to Hawai'i being denied a similar increase. As a result, Hawai'i has been missing out on at least \$15 million in federal funds each year.
- 4. Reducing Waste. Farm to School requires greater efficiencies to afford staff training and quality ingredients for students (although fresh and local foods are not necessarily more expensive than imported and processed foods). At present, SFSB does not require staff to measure ingredients, yields, overproduction, or plate waste. Implementing measurement and management systems will help minimize waste and increase efficiencies.
- 5. **Setting Goals, Determining Baselines, and Tracking and Analyzing Data**. Farm to School requires tracking and analyzing data to monitor progress towards defined goals. At present, SFSB does not track income or expenses per cafeteria, food waste, or whether food is fresh, processed, local, or imported.
- 6. **Procurement Innovation & Contracts Management**. Farm to School requires creating new approaches to procurement. For years, SFSB has sought one vendor to supply processed food for the entire state and one vendor to supply fresh produce for the entire state. As a result, SFSB has not had a contract for fresh produce in a decade; no one will enter into a contract to supply fresh produce for the entire state with prices locked in for a full year. The market is too volatile, and the volume is too high. To support Farm to School, SFSB must be willing to shift from seeking one vendor to entering into multiple contracts with vendors on each island to source local food. SFSB must also adequately manage those contracts to ensure that vendors are delivering quality fresh, local foods.
- 7. **Supply Chain Development**. SFSB is the largest restaurant chain in the state. They can create incredible demand for local food. For local supply to meet that demand over time, SFSB will need to partner with the agricultural sector to develop the local food supply chain.
- 8. **Nutrition Education and Community Outreach**. Nutrition education and communication with families is essential to students trying new foods and making healthy eating choices.

We hope you will support this bill and transition Farm to School from a privately-funded pilot program to a state priority and an official program within HIDOE. Thank you for your consideration of this measure, as well as this opportunity to submit testimony.

### 'Aina Pono Hawai'i State Farm to School Program



'Aina Pono is a collaborative initiative of the Hawai'i Lieutenant Governor, Hawai'i State Department of Education, Beyond Green Sustainable Food Partners, and The Kohala Center.

#### Introduction

Hawai'i has an amazing legacy of land cultivation spanning two millennia. Providing meals for Hawai'i's next generation grown from the lands on which they live is an approach that at one point in our history was the only way to provide meals. Connecting our keiki to "that which feeds" (a literal term for the Hawaiian word 'āina) will grow an understanding and respect for the land with a generation growing farther removed from its utility and capacity.

In 2015, the Office of the Lieutenant Governor convened the Hawai'i Farm to School Advisory Group to develop a pathway toward bringing fresh, local food to schools statewide to reinforce the vision that Hawai'i exists as a perpetual reminder of finite resources, fertile lands, and communities who are committed to the wellbeing of their keiki. Today, 'Aina Pono is the Hawai'i State Department of Education's (HIDOE) pioneering farm to school pilot initiative that aims to bring more healthy, nutritious, fresh, and local food to school cafeterias throughout Hawai'i. 'Aina Pono: Hawai'i's Farm to School Initiative is an expression of the pride we have in food grown in these islands, the ingenuity of the people we trust to feed our keiki and the collective strength to return our communities to a legacy of cultivating fresh, locally grown sustenance to build the minds of tomorrow.

Farm to school encompasses a variety of efforts to connect communities and students to fresh, nutritious food. Farm to school generally includes three core elements: (1) school gardens; (2) nutrition, agriculture, health, and food education; and (3) the procurement of local foods for school meals. The first and second elements aim to help students become "citizen eaters" who understand the connections between food, health, and agriculture. 'Aina Pono focuses on the third element, which aims to create pathways to include local food in school meals. From improving academic performance to encouraging healthy food choices, to supporting farmers and the local economy, the benefits of farm to school programs are truly abundant.

#### Goals

'Aina Pono has four main goals:

- 1. Systematically increase HIDOE's **purchasing of local food** for school breakfast, lunch, and snack programs. Target: 40% local food (*i.e.*, grown and/or raised within the State of Hawai'i).
- 2. **Increase student participation** in child nutrition programs, *i.e.*, increase the number of students that eat school meals. Target: participation increases by 5%.
- 3. Increase student **consumption of healthy foods** in school meals. Targets: Processed food shall not exceed 40%; food waste declines by 10%.
- 4. The Initiative will be **cost-neutral** over time, *i.e.*, implementation costs will be covered by cost-savings generated by decreased waste and increased efficiencies. Target: Overproduction shall not exceed 5%.


#### **Implementation**


'Aina Pono is being implemented by HIDOE's School Food Services Branch in partnership with the Office of the Lieutenant Governor, The Kohala Center, and Beyond Green Sustainable Food Partners. The Initiative includes the following components:


- Menu Development: Working with cafeteria staff to develop new student-approved recipes that
  use fresh, locally sourced ingredients and meet USDA guidelines. Cooking with fresh food is
  integral to sourcing local food in Hawai'i due to the unprocessed nature of most local food
  products.
- Training: Training cafeteria staff on production planning; just-in-time production; teamwork; leadership; time management; production records; portion control; local procurement; cooking skills; knife skills; offer vs. serve; waste systems; profit and loss analysis; purchasing/inventory/cost controls; customer service; taste testing; and recordkeeping.
- Data Tracking: Developing data tracking systems to track profit and loss, waste, and local procurement.
- Waste Management: Developing waste management systems to measure and reduce overproduction (i.e., food that is prepared but not sold) and plate waste (i.e., food that is sold but not eaten).
- **Supply Chain Development**: Meeting with farmers and food distributors to increase the pipeline of local food available to HIDOE.
- Procurement Innovation: Working with HIDOE's School Food Services Branch supervisors and
  procurement contracts branch, Hawaii Child Nutrition Programs, the State Procurement Office,
  and the USDA to develop innovative procurement approaches that support buying local while
  complying with state and federal laws.
- Community Outreach: Engaging community members throughout the state in the Initiative in order to share information, receive feedback, and encourage students to try new menu items.
- Nutrition Education: Providing schoolchildren with nutrition education in school garden and classroom settings to connect them to the source of their food and expose them to a wide variety of fresh, local foods, including fresh fruits and vegetables.

#### Phase I: Kohala

In November 2016, the 'Aina Pono team launched Phase I of the Initiative at the Kohala School Complex on Hawai'i Island - Kohala Elementary, Kohala Middle, and Kohala High schools. One central cafeteria serves all three schools, with a combined enrollment of approximately 780 students. Sixty-nine percent of enrolled students qualify for free and reduced-price lunch. The following graphs show the changes in local procurement, the use of processed foods, participation, and net income from January 2017-May 2017 at the Kohala complex cafeteria.







#### **Local Food Vendors**

- Big Island Beef (Hawai'i Island): ground beef and stew meat
- Hilo Products (Hawai'i Island): variety of local produce
- HIP Agriculture (Hawai'i Island): bananas, papayas, oranges, tangerines, tangelos
- Suisan (Hawai'i Island): variety of local produce
- Meadow Gold Dairies (Hawai'i Island): milk

These vendors have purchased local food from the following farms: Akea Farm (cucumbers/Maui), Aloun Farms (cabbage/Oʻahu), Maui Gold: (pineapple/Oʻahu), Sinaloa Tortillas (tortilla/Oʻahu), Sugarland Growers (tomatoes/Oʻahu).

#### Phase 2: Expansion

HIDOE selected Mililani High School as the second pilot site, which serves approximately 2,500 lunches per day to students at Mililani High School (2,552 students), Mililani Uka Elementary (662 students), and Mililani Waena Elementary (767 students). DOE will be selecting additional schools for implementation during the 2017-18 school year and beyond. Implementation will include in-cafeteria training, summer trainings, workshops, videos, and written educational materials.

As a pediatric nurse that has worked in the DOE for over 8 years I personally see a direct correlation between the nutritional health of our keiki and their physical and educational demands of these growing years. The amount of disconnect between people and the knowledge of our food source is saddening. To truly reduce our health care costs, we need to take responsibility for the way in which we approach our food source, because we truly are what we eat. To connect back to the Aina and respect the gifts that it provides us, only strengthens the health of our community. By teaching children at a young age where our food comes from, how to produce it sustainably, and how if affects our health, ensures that this knowledge is kept alive and we can empower the next generation with choice.

I have worked across the lifespan. I've been in preschools and seen many children with the majority of their teeth capped with silver, consuming snacks with ingredients that only a chemist can pronounce. I then witness that immediately after this brightly packaged snack is eaten, this child has increased difficulty focusing. Many of these children grow into adolescence and are now dealing with weight issues, depression, fatigue, attention deficits, and hormonal dis-regulation. They then become adults facing possible Type 2 diabetes, high cholesterol, coronary heart disease, auto-immune disorders, and other diet and lifestyle conditions. Often, they need to go on medication for the remainder of their lives, and have increased health care costs.

I currently teach at a community college, and 80% of my adult students are not even AWARE of the direct connection between the foods and drinks they consume and their overall health and well being. My name is Dale Sandlin, and I am Managing Director of the Hawaii Cattlemen's Council. The Hawaii Cattlemen's Council, Inc. (HCC) is the Statewide umbrella organization comprised of the four county level Cattlemen's Associations. Our 150+ member ranchers represent over 60,000 head of beef cows; more than 75% of all the beef cows in the State. Ranchers are the stewards of approximately 25% of the State's total land mass.

The Hawaii Cattlemen's Council <u>Strongly Supports</u> HB 2156 as this measure provides a truly beneficial relationship with all parties.

As the first agricultural product to be featured by the Department of Agriculture, the beef industry has seen the results of the Hawaii Farm to School Program first hand. Locally raised ground beef was chosen as the first Aina Pono Harvest of the Month program where 18,000 lbs of beef were used in the school lunch program across the state in December.

The Department of Education (DOE) is the largest restaurant in the state as they serve approximately 100,000 meals each day. While ranchers, processors and distributors are able to sell their higher value cuts at a profit, they often have a surplus of high-quality ground beef and stew meat left to sell. The DOE only uses ground beef and stew meat in their meals and as such have begun to purchase these cuts of beef from local sources. This is truly a win-win for all parties.

## **Department's Position:**

The Department of Education (DOE) supports HB2156, HD2 to establish two FTE farm to school staff positions within the DOE. Since this is a priority for the DOE, the Board of Education approved the budget that included four farm to school positions and \$228,672, and the Governor's budget request in front of the legislature for consideration includes two farm to school positions and \$114,336.

Currently, the School Food Services Branch (SFSB) has made good progress in implementing the Farm to School Program. However, the ability to grow the program, which includes increasing the consumption of local fruits and vegetables, procurement, developing school gardens, meal planning and providing curriculum and training is beyond SFSB current capacity and capabilities. These additional positions will assist SFSB's ability to move in a more efficient manner in increasing the Farm to School Program.

Furthermore, the result of having these two positions will not just impact the health of children; it will also impact the health of senior citizens that SFSB serves through its vended meal program. It will result in helping the economy through local agriculture growth as well as the local communities in which the schools and senior centers reside.
