Aloha Chair Woodson, Vice Chair Kong, and Members of the Committee:

I am Randy Cabral, President of the Hawaii Farm Bureau (HFB). Organized since 1948, the HFB is comprised of 1,900 farm family members statewide, and serves as Hawaii's voice of agriculture to protect, advocate and advance the social, economic and educational interests of our diverse agricultural community.

The Hawaii Farm Bureau supports HB 2156, which authorizes the Department of Education to establish a farm to school program, requires the farm to school coordinator in the department of agriculture to work in collaboration with the department of education on any farm to school program, and establishes two FTE farm to school staff positions within the department of education

HFB strongly supports increased use of locally grown agricultural products, fruits, vegetables, meats, dairy and poultry products in our schools and other public institutions. This will truly be a significant step towards increasing our levels of self- sufficiency. HFB also believes that learning where food comes from is an important part of our children's education. Agriculture education involves more than just learning the basics of food production, it provides the opportunity for our children to understand and appreciate the importance of agriculture.

Many formal and informal studies have been done addressing farm to school programs. Our farmers and ranchers have tried to work with the procurement system and can speak about the challenges of the system. For example, supplying a school or schools within a geographic area is feasible, but providing to the entire school system is not. Focus should now be on working with the procurement system to make institutional markets accessible while considering the capacity of farmers and ranchers in Hawaii. Assistance to farmers on how to navigate the system should be a priority.

HFB recognizes the need and importance of agricultural education and school farm programs, and as a farm organization we would like to see increased emphasis of agriculture in schools. We believe that school farms serve multiple purposes. They serve not only to educate students on how to grow crops but also what it takes to turn a farm into a successful business enterprise that can be a career choice. Agronomy, economics, science, business planning, entomology, pathology and various technologies including programming, navigation and robotics are some of the courses that can evolve around the farm. Programs that teach the principles behind good agricultural practices - steps that must be taken that protect the environment, product, and worker are critical components of a school farm. The purpose of the farm should be to educate and expose students to a career choice.

Developing and maintaining an agricultural workforce should be a vital component of this program. A trained workforce with various skills is necessary to any agricultural operation. This need must be addressed along with generating interest in our youth to pursue the various careers and to become our future leaders in Hawaii agriculture. HFB supports programs and initiatives such as the FFA, 4-H, and Farm to School programs because they help to educate and reconnect our children with agriculture. Through agricultural education programs, our children will gain an understanding and appreciation for agriculture which will result in healthier eating habits, stronger support for Hawaii's agriculture industry and will contribute to Hawaii's food security.

This should be viewed is an investment in Hawaii's future to develop well-informed consumers and supporters of our local agricultural industries.

Chairperson Woodson and Members of the Committee:

Thank you for the opportunity to testify on House Bill No. 2156. The purpose of this bill is to establish a farm to school program in the Department of Education with dedicated farm to school staff positions to work with the Farm to School Coordinator in the Department of Agriculture, to grow and sustain the Hawaii Farm to School Program. The Department of Agriculture supports this measure.

When the legislature established the Hawaii Farm to School Program in the Department of Agriculture with Act 218 (SLH 2015), the Farm to School Coordinator began working with Department of Education to "address the issues of supply, demand, procurement, and consumption of Hawaii-grown foods in state facilities" (HRS §141-11(b)), as well as accelerate school garden and farm based education, and expand the relationships between public schools and agricultural communities (HRS §141-11(a)). This measure supports the necessary coordination between the Department of Education and the Department of Agriculture for farm to school success.

Through the leadership of the Office of the Lieutenant Governor, the Department of Education's School Food Services Branch (HIDOE-SFSB) has implemented the 'Aina Pono farm to school initiative, to develop more scratch cooked meals for students and source more locally grown foods for new recipes. In support of these efforts, the



Department of Agriculture has developed the "Hawaiian Harvest of the Month" with stakeholders, as a farm to school promotion and outreach program to connect inseason Hawaii –grown food to school cafeterias, student education activities, recipe development, and farmer outreach. We have seen some success with December's local beef month and are eager to continue working through seasonal items with HIDOE-SFSB.

The Department of Agriculture is encouraged by the increased purchases of locally grown food the Department of Education has been procuring from local vendors, and supports their continued efforts to work with our local producers. Establishing a Farm to School Program with dedicated coordinators within the Department of Education will provide the critical support to build on the momentum of the current initiative and institutionalize a program with protocols that should work for the Department of Education.

Purpose of Bill: Authorizes the Department of Education to establish a farm to school

program. Requires the farm to school coordinator in the department of agriculture to work in collaboration with the department of education on any farm to school program. Establishes two FTE farm to school staff positions within the department of education. Appropriates funds.

Department's Position:

The Department of Education (DOE) supports the bill to establish two FTE farm to school staff positions within the DOE. Since this is a priority for the DOE, the Board approved budget included four farm to school positions and \$228,672 and the Governor's budget request in front of the legislature for consideration includes two farm to school positions and \$114,336.

Currently, the School Food Services Branch (SFSB) has made some good progress in implementing the Farm to School Program. However, the ability to grow the program, which includes increasing the consumption of local fruits and vegetables, procurement, developing school gardens, meal planning and providing curriculum and training is beyond SFSB current capacity and capabilities. These additional positions will assist SFSB's ability to move in a more efficient manner in increasing the Farm to School Program.

Furthermore, the result of having these two positions will not just impact the health of children; it will also impact the health of senior citizens that SFSB serves through its vended meal program. It will result in helping the economy through local agriculture growth as well as the local communities in which the schools and senior centers reside.

The Hawaii State Department of Education seeks to advance the goals of the Strategic Plan which is focused on student success, staff success, and successful systems of support. This is achieved through targeted work around three impact strategies: school design, student voice, and teacher collaboration. Detailed information is available at www.hawaiipublicschools.org.

Good afternoon, Chair Woodson, Vice Chair Kong, and members of the Committee

Thank you for this opportunity to testify!

I am Michele Matsuo, Chair of the Democratic Party's Education Caucus. The Ed Caucus strongly supports Farm to School initiatives, and teaching our Keiki to organically garden as well.

As you well know, it is important to our economy to keep our dollars here and the Farm to School initiative helps us do that. I personally request that you consider organic gardening and farming for our students' Farm to School experiences to keep their exposure to chemicals low. Organic agriculture is booming and it could prove important for Hawai'i in the event of shipping disruptions, like those caused by war, natural disasters, etc.

For the last nearly 3 years, Allegra Matsuo Mossman and I have been organic gardening, using dried leaves and limu for soil amendments with satisfying success. We are members of a community garden and have seen weeds turned into rich "black gold" compost. Our garden went from monthly green waste runs to the dump to zero green waste runs. The City delivers clean mulch from its tree trimming operations, to the community garden, and this not only helps in weed control but also helps break down into rich soil.

Through learning how to organically garden from resources available in the community, which might otherwise be thrown away, students can reduce waste and also teach their families and the community generally how to do the same. Some gardeners also like to use kitchen waste rather than running scraps in the kitchen sink disposal.

Thank you for the opportunity to testify in **strong support** of HB 2156, which authorizes the Hawai'i Department of Education (HIDOE) to establish a Farm to School Program and establishes two HIDOE Farm to School staff positions.

The Hawai'i Public Health Institute (HIPHI) works to advance policy and systems change to reduce disparities and improve the health of Hawai'i residents. HIPHI is home to the Obesity Prevention Task Force and the Hawai'i Farm to School Huiⁱ.

State-level support is critical to the success of Farm to School in Hawai'i

HB 2156 helps to support the progress made by HIDOE toward improving the quality of meals served in Hawaii's public schools. Locally sourced and scratched cooked recipes and menus were tested in the Kohala Complex on Hawai'i Island during the 2016-2017 school year; the inaugural year of the HIDOE 'Aina Pono Farm to School Program. With lessons learned from Phase I, the HIDOE School Food Services Branch (SFSB) has recently expanded the program to Mililani High School, which is HIDOE's second largest food production site in the state, serving over 3,000 meals per day. State-level funding will continue to build upon these successes and expand Farm to School to HIDOE schools.

Strong public support for Farm to School

Farm to School programs promote healthy eating habits for Hawaii's keiki both in school and at home through education, school gardens, and school food improvements. Public support for Farm to School is strong. In a recent public opinion pollⁱⁱ conducted for HIPHI, 93% of registered Hawai'i voters support increasing government funding to provide more locally grown food served in school meals, while 90% support increasing government funding to provide healthier foods in our schools and communities. In addition, stakeholders from the Obesity Prevention Task Force and the Hawai'i Farm to School Hui have identified this bill as a top legislative priority.

Dedicated Farm to School staff are required for statewide expansion

Ensuring that these school food improvements are made available every day to all 180,000 of Hawaii's public school students requires the full time dedication of two Farm to School staff within HIDOE. These positions are essential to:

- Expanding school food improvements statewide
- Providing critical support for school garden programs from within HIDOE
- Establishing a protocol for serving school garden-grown produce in school cafeterias

Farm to School activities help to promote healthy habits among our keiki

In Hawai'i, a growing public health concern is that approximately 1 in 4 children entering kindergarten are overweight or obese. Among high school students, only 1 in 5 (21.2%) consume fruit daily and 1 in 10 or (11.8%) consume vegetables dailyⁱⁱⁱ. Successful Farm to School programs can increase students' physical activity, school meal participation, preference for fresh fruits and vegetables, and improve academic achievement and behavior.

HB 2156 provides essential state-level support for expanding Farm to School in Hawai'i and improving our local school food systems. We respectfully ask you to pass this measure out of committee.

The **Hawai'i Farm to School Hui** is a statewide network whose mission is to strengthen Hawaii's Farm to School movement by supporting our island networks in the areas of capacity building, resource development and sharing, professional development, and policy development and advocacy. The Hui is comprised of five island-level school garden and Farm to School networks, community organizations and schools, and representatives from the Hawai'i Departments of Agriculture, Education, and Health and the University of Hawai'i. The Hui formed in 2010 and became a program of HIPHI in 2017.

Papa Ola Lōkahi, the Native Hawaiian Health Board and member of the State's Obesity Prevention Task Force, is in full support establishing a farm-to-school program within the Department of Education.

Illness and death due to chronic disease is higher among Native Hawaiians in Hawai'i than any other ethnic group. Hawaiians have higher rates of obesity and live 6 years less than the general population.

Papa Ola Lōkahi and our partners in Hawaiian health work to address these disparities through policy, research, developing and implementing programs and direct services, improving access to care, workforce development, data and information dissemination, traditional healing and more. Dr. Kekuni Blaisdell articulated how cultural conflict—through disconnection from land, language and culture—has contributed to the disparities.

We believe that prioritizing farm-to-school programming will impact all of Hawai'i's public school students, familiarizing them with real foods, connecting them with the 'āina will lead to healthier choices at home and throughout their lives.



The Kōkua Hawaiʻi Foundation is a 501(c)3 non-profit organization founded in 2003 to support environmental education in the schools and communities of Hawaiʻi. Our programs include 'ĀINA In Schools, 3R's School Recycling, Kōkua Hawaiʻi Foundation Field Trip Grants, Kōkua Hawaiʻi Foundation Mini-Grants, and Plastic Free Hawaiʻi.

'ĀINA In Schools is a farm to school initiative launched in 2006 that connects children to their local land, waters, and food to grow a healthier Hawai'i. In addition to encouraging the use of locally grown fruits and vegetables in school meals and snacks, the program includes a standards-based nutrition, garden, and compost curriculum that empowers children to grow their own food, make informed food decisions, and reduce waste. 'ĀINA In Schools also promotes field trips to local farms, chef cooking demonstrations in classrooms, as well as waste reduction, garden, and cooking educational opportunities for families and community members. We work directly with 23 Oʻahu elementary schools that have implemented the program school-wide. We have also trained an additional 472 educators from over 239 schools and organizations from across the state in the use of our 'ĀINA garden, composting, and nutrition curricula.

HB2156 is essential to expanding Farm to School statewide, providing necessary support to the Department of Education to improve school food environments, incorporate school garden programs in the school curriculum, and work with stakeholders to increase educational opportunities and the procurement of locally grown produce in school cafeterias.

With more than 85 percent of Hawai'i youth attending public schools, Farm to School is an ideal program that would bring parents, students, teachers, and farmers together to strengthen what is grown and consumed in our state. More importantly, students who participate in Farm to School activities are more likely to be familiar with, prefer, and consume fruits and vegetables at school and at home. It is never too early to establish healthy behaviors to prevent unhealthy weight gain, tooth decay, or Type 2 diabetes, which are often associated with unhealthy dietary behaviors. Please see the attached document from the National Farm to School Network, "The Benefits of Farm to School" for specific examples and statistics of how farm to school programs benefit students, schools, and local economies.

Having spent the last 12 years working to advance Farm to School in Hawai'i and serving as Core Partner (state-level representative) to the National Farm to School Network, Kōkua Hawai'i Foundation is highly invested in this movement. THE BENEFITS OF FARM TO SCHOOL

What is Farm to School?

Farm to school enriches the connection communities have with fresh, healthy food and local food producers by changing food purchasing and education practices at schools and early care and education sites. Farm to school empowers children and their families to make informed food choices while strengthening the local economy and contributing to vibrant communities. Farm to school implementation differs by location but always includes one or more of the following three core elements:

Procurement: Local foods are purchased, promoted and served in the cafeteria, as a snack or in classroom taste-tests.

Education: Students participate in education activities related to agriculture, food, health and nutrition.

School gardens: Students engage in hands-on, experiential learning through gardening.

Why Farm to School?



KIDS WIN

Farm to school provides all kids access to nutritious, high-quality, local food so they are ready to learn and grow. Farm to school activities enhance classroom education through hands-on learning related to food, health, agriculture and nutrition.



FARMERS WIN

Job Creation and Economic Activity



Public Health

Farm to school is a community-based strategy that includes a focus on creating a healthy school food environment.¹ Farm to school activities support development of healthy eating habits for children while improving family food security by boosting the quality of school meal programs.²-5

Student Nutrition Behaviors

- Improvement in early childhood and K-12 student health behaviors, including choosing healthier options at school meals, consuming more fruits and vegetables through farm to school meals and at home (+0.99 to +1.3 servings/day), consuming less unhealthy foods and sodas, reducing screen time and increasing physical activity.^{6-31,43-46,49,51,53,57,61-64,67,68}
- Increase in fruit and vegetable consumption among those with the lowest previous intake.⁵¹

The danger is that obesity can lead to chronic diseases later in life, such as diabetes, heart disease and some cancers. It is also costly to our society; each year, Hawaii spends roughly \$427 million obesity-related health care costs.

Staying active and eating healthy food are the two main ways to prevent obesity and reduce the risk of chronic disease. Establishing healthy behaviors at an early age can help to prevent the onset of many of the common chronic diseases. The American Heart Association estimates that 80 percent of heart disease and stroke is preventable through improved lifestyle habits.

Eating a variety of fruits and vegetables may help control both weight and blood pressure, and they contribute a number of important nutrients that most people don't get enough of, including folate, magnesium, potassium and dietary fiber, as well as vitamins A, C, and K. And they are naturally low in saturated fat and calories. The American Heart Association recommends eating eight or more fruit and vegetable servings every day. An average adult consuming 2,000 calories daily should aim for 4.5 cups of fruits and vegetables a day. Also, variety matters, so it's important to eat a wide range of fruits and veggies.

Teaching our keiki from a young age the value of healthy, fresh, and local foods can establish in them healthier eating habits that will continue through their lifespan. The American Heart Association encourages legislators to support HB 2156.

TESTIMONY IN <u>SUPPORT</u> OF H.B. 2139 – RELATING TO DISCRIMINATION IN EDUCATION

Dear Chairs Woodson and McKelvey, Vice-Chair Kong and Hashem, and Members of the Committee:

We, the undersigned students of the William S. Richardson School of Law, would like to thank the Committee for the opportunity to testify in **SUPPORT WITH AMENDMENTS** of H.B. 2139, which would enact a state version of Title IX by prohibiting discrimination on the basis of sex in educational programs and activities that receive state financial assistance.

H.B. 2139 is urgently needed in light of the current federal administration's overt and concerted effort to dismantle federal anti-discrimination laws. The Trump administration has reversed the federal government's previous interpretation of the prohibition against discrimination based on "sex" that included discrimination based on sexual orientation, and gender identity and expression. The administration also prohibited the right to appeal findings, forces complainants to work out the problem directly with the alleged perpetrator without a mediator, and eliminates the 60-day time frame, allowing the cases and emotional distress of parties to drag on for months. The administration also rescinded protections for transgendered students that had been put into effect by President Obama. This bill reflects the ever-growing state interest in stepping in and filling the enforcement gap with procedures that are fair and so that survivors feel safe coming forward since the Trump Administration has decided to walk away from its responsibility in enforcing civil rights.

In addition, United States' Department of Education (DOE) rescinded its guidance on the investigation of campus sex assaults. As a result, those who have suffered sex-based harm must now contend with weaker protections from sex discrimination, including sexual harassment and sexual assault, targeting women, ¹ girls, indigenous ² and LGBT individuals, ³ some of our most

Title IX helps hold perpetrators of gender-based violence accountable without involving the police or incarceration and highlights how gender-based violence intersects with racism, xenophobia, transphobia and other forms of oppression. The appeal of Title IX to many students, especially during President Trump's pro-policing reign, is the burden of proof — preponderance of the evidence — is attainable and the punishment for committing acts of violence centered on safety (no-contact directives, removal from campus grounds, counseling). Title IX also mandates schools provide accommodations for survivors of violence, such as psychological and academic support often inaccessible to students from a lower socio-economic status. The system Title IX aims to create —focused on violence prevention and healing — has the potential to address the needs of marginalized survivors and promote justice.

The recent wave of sexual harassment and sexual assault revelations uplifted through the #metoo movement have made clear that gender-based violence and harassment persists throughout the United States, including Hawai'i. The recent University of Hawai'i Climate Survey Report, which polled 44,671 adult students across ten UH campuses, further reveals the necessity for a state-level solution. For example, 1 in 8 students felt that it was **likely** that they would experience sexual assault or sexual harassment while on campus, while 1 in 4 felt that an off-campus, university-sponsored event incident was likely. ⁴ In addition, 1 in 16 UH survey

Over 2,000 women surveyed, 84 percent of Native American and Alaskan Native women have experienced violence, 56 percent have experienced sexual violence, and over 90 percent have experienced violence at the hands of a non-tribal member. participants system-wide reported non-consensual sexual contact at any time while enrolled at UH. ⁵

The bill's provision that allows for the Hawai'i Civil Rights Commission to exercise its rulemaking authority allows for survivors of sexual violence to explore more enforcement procedures and remedies aside from the Title IX investigation done at schools and criminal investigations. These civil law remedies may be prefereable in some circumstances. Some advantages of civil litigation include empowering victims (whereas in criminal cases, the victim is only a witness in the recovery); recovery of menetary damages for the harm inflicted on victims, validating both the victim's experiences and holding perpetrators accountable for their actions; enhancing safety and security practices to promote corporate responsibility; and heightening awareness behind sexual violence. The expansion of alternatives also provides the opportunity to lessen the burden on our courts and allows for reparations for those who suffered from sexual violence to begin to heal.

Recommended Amendments

It is now apparent that the Trump administration's rollbacks on the enforcement of federal regulations prohibiting sex discrimination extend beyond education. To ensure that no state agency be allowed to discriminate on the basis of sex, we request that you extend this bill to cover all state funded programs and services.

In supporting H.B. 2139, the State takes important steps forward in the conversation around sexual violence from one of compliance to one of overhauling and changing the culture to work toward the elimination of sexual violence on school campus. If we are going to have a holistic program to address this imminent issue, compliance and guidance has to be a part of it, but it cannot be the sole centerpiece of this movement.

Accordingly, we <u>SUPPORT</u> H.B. 2139, and respectfully urge your Committees to <u>PASS</u> this important bill. Thank you for the opportunity to provide testimony.

Dear Chairs, Vice-Chairs, and Members of the Committees:

I would like to thank the Committees for the opportunity to testify in SUPPORT of H.B. 2139, which would enact a state version of Title IX by prohibiting discrimination on the basis of sex in educational programs and activities that receive state financial assistance.

H.B. 2139 is urgently needed in light of the current federal administration's overt and concerted effort to dismantle federal anti-discrimination laws. The Trump administration has reversed the federal government's previous interpretation of the prohibition against discrimination based on "sex" that included discrimination based on sexual orientation, and gender identity and expression. The administration also rescinded protections for transgendered students that had been put into effect by President Obama. In addition, USDOE rescinded its guidance on the investigation of campus sex assaults. As a result, those who have suffered sex-based harm must now contend with weaker protections from sex discrimination, including sexual harassment and sexual assault. This war on women, girls, and LGBT individuals calls upon all of us to take action.

The recent University of Hawai'i Climate Survey Report, which polled 44,671 adult students across ten UH campuses, further reveals the necessity for a state-level solution. For example, 1 in 8 students felt that it was likely that they would experience sexual assault or sexual harassment while on campus, while 1 in 4 felt that an off-campus, university-sponsored event incident was likely. [1] In addition, 1 in 16 UH survey participants system-wide reported non-consensual sexual contact at any time while enrolled at UH. [2]

Accordingly, I SUPPORT H.B. 2139. I respectfully urge your Committee s to PASS this important bill. Thank you for the opportunity to provide testimony.

I spent six (6) years working for the State of Hawai'i as an elementary school teacher, so I can personally speak on my experience as a teacher and on the unique love that Hawai'i has for our school children. I have also volunteered as a Garden docent, for Kokua Foundation. So, I sincerely hope you take my letter seriously, to heart, but more importantly-factually.

I can tell you as a teacher for the school district, I had the privilege of ALSO getting school lunches, alongside my elementary school students. I want to tell you about the day, I realized something more had to be done, for our students, here in Hawai'i. It was a Spring day here in Hawai'i, we had amazing local kine school lunches at the school I worked at, all kine shoyu local chicken, rice, canned fruits, salad, milk. I had been eating these ono lunches for weeks, I began to put on weight, so I was relieved when I had the choice to get just a fresh salad. I had just made, a nice big salad, when I heard a student's voice say, "Miss Cass" that salad looks SOOOO good & fresh, I wish I could have some". As I looked up, I saw one of my students, a 4th grader, local Hawaiian-Filipino boy, who was my largest student, bigger than even the 5th graders at our school, and also the heaviest/overweight. It broke my heart in that moment when I realized, that the students don't even have the same access to fresh salad, like the teachers, I was surprised because he being so big, I figured he just enjoyed eating a lot; It was in THAT moment, I remembered, that people often overeat because their bodies are trying to obtain nutrients they are depleted in. I have taught adults how to eat healthier, so to imagine a child starting out so overweight at such a young age....broke my heart into several, million pieces that day. I said nothing to this student, weakly smiled, and walked away. Not only did he not have access to fresh salad, he had a want and desire to eat it, to learn about it, and incorporate it into his everyday life!!! I cannot stress, that education is EVERYTHING. If, most students cannot have these foods, the LEAST we can do is educate on the importance.

Because of THAT day, I started to volunteer as a Garden Docent for Kokua Foundation, but its difficult when we work full time jobs, so I can only volunteer several times a year, now. (Occurs during school hours & job). I hope my letter, has helped pave the road so we can begin, together, to establish theses positions rightfully within our district. Paid positions, would bridge the gap, it would bring up the health goals not just for our students, but for the teachers, who work long hours, and did not receive the education themselves ...which is reflected in the school kine lunches. Ono, but
