- Fiscal Implications: H.B. 2169 HD1 requests an unspecified amount of general funds for fiscal
- 2 year 2018-2019 for youth suicide early intervention, prevention, and education initiatives in
- 3 Maui county. The Department defers to the Governor's Executive Budget request for
- 4 appropriations and personnel priorities.
- 5 Department Testimony: The Department of Health supports the intent of H.B. 2169 H.D.1.
- 6 Between 2010 -2016 there were 150 suicides among all residents aged 10 to 24 years, making
- 7 suicide the leading cause of injury death for this age group. The 150 suicides accounted for 28%
- 8 of all deaths among residents of this age, and 40% of the injury-related deaths. The annual
- 9 number varied from 24 to 38 deaths per year. For every youth who dies from suicide in Hawaii,
- there are an estimated 8 (239 per year) who are hospitalized and another 18 (540 per year) who
- are treated in emergency departments (ED) for nonfatal self-inflicted injuries each year.
- Rates of suicide among youth are higher for all Neighbor Islands in comparison to Honolulu
- 13 County. EMSIPSB data shows that youth suicide and attempted suicide are significantly higher
- in rural communities compared to Oahu
- Given the higher rates of youth suicide in rural communities, the Emergency Medical Services
- and Injury Prevention System Branch respectively recommends that H.B. 2169 H.D.1 be
- amended to include the distribution of funds for youth suicide early intervention, prevention and
- education initiatives to Hawaii County, Kauai County, and Maui County.

This year we celebrate 20 years of serving the faith-based community! We support this bill that provides necessary funding for youth suicide early prevention, intervention and education.

We are committed to defending the sanctity of human life from conception until natural death, and everything that comes between. Many people in our community are concerned about suicide, because it affects the vulnerable people in our community, especially our youth and elderly.

In Hawaii, suicide was the most common cause of fatal injuries among Hawaii residents between 2010 and 2014, accounting for one-quarter of all fatal injuries and experts point out that one person dies by suicide in Hawaii every two days. Recent testimony has said that is one suicide every two days. This is heartbreaking and something we absolutely need to change! Several of our pastors have dealt with this very issue over the past few months.

Experts rightly point out that suicidal behaviors, for people of any age, are usually rooted in many different factors, with mental health issues playing an important role in the overall mix. It is a "perfect storm" of emotional issues and the only way to begin making a difference, is by identifying and treating each person. And the good news, is that it is fixable by awareness and treatment.

If this bill is passed with the appropriate funds necessary, Maui youth will have resources that may very well save their life. Protecting these precious lives are an outcome that is one upon which everyone in the community will agree. Funding for these types of services, we hope, will also be extended to each of the other islands.

I am Walter Yoshimitsu, the executive director of the Hawaii Catholic Conference which is the public policy voice of the Roman Catholic Church in the State of Hawaii. Many people at risk for suicide do not seek help so it is essential that people from across the spectrum of services, both secular and faith-based, come together to find a solution to prevent suicides in Hawaii.

As a conference, we believe that each and every human life is sacred. Because of that, we advocate for public policy that will save lives, not end them. On this point we have never wavered. To that end, we are in strong support of *HB 2169 HD1* that will appropriates \$25,000 for youth suicide early intervention, prevention, and education initiatives in Maui county.

Suicide affects people from every age, faith, or ethnicity. In fact, right here in Hawaii, according to the State Department of Health, "suicide was the leading cause of fatal injuries and the 10th leading cause of death among Hawaii residents of all ages." Many organizations are already doing great work to prevent the loss of innocent lives; however, more can and should be done.

Sadly, when an individual takes their own life, it does not end the suffering. In fact, it is quite the contrary. The truth remains that the pain of suicide will continue thereby negatively affecting the family and even the wider community. Fortunately, there is strong evidence that a comprehensive public health approach is effective in reducing suicide rates. As our state puts aside differences and makes a plan to come together and focus on our collective roles in suicide prevention, we will make a difference in our community.
