Title of Bill: HB 2238 RELATING TO EMERGENCY PREPAREDNESS.

**Purpose of Bill:** Establishes the safe keiki grant program to award funds to qualified

DOE schools to purchase supplies for students to remain at school shelters for 48 hours in the event of an emergency. Appropriates funds.

#### **Department's Position:**

The Hawaii State Department of Education (HIDOE) is in support of HB 2238 that establishes the Safe Keiki Grant Program to award funds to qualified HIDOE schools to purchase supplies for students to remain at school shelters for 48 hours in the event of an emergency. These emergency supplies would not only cover approximately 167K students but also the 40K school and support personnel.

Utilizing the optimum and recommended school item emergency supply list, it would cost approximately \$12 million (\$500 per classroom per day, times 12,000 classrooms) to purchase 48 hours worth of supplies for 256 schools. Paring down the list slightly could reduce this figure to \$7.2 million (\$300 per classroom per day, times 12,000 classrooms). Currently, HIDOE does not have the funds and, as such, receiving funding support from the Safe Keiki Grant Program would significantly contribute to HIDOE's efforts of ensuring schools are prepared. However, HIDOE would also require funding support in future years to replace the perishable supply items (i.e. food, water, etc) when shelf life has expired and possibly the need for constructing storage spaces for these supplies.

Also note, these calculations do not include Public Charter Schools.

The Hawaii State Department of Education seeks to advance the goals of the Strategic Plan which is focused on student success, staff success, and successful systems of support. This is achieved through targeted work around three impact strategies: school design, student voice, and teacher collaboration. To the Honorable Justin H. Woodson, Chair; the Honorable Sam Satoru Kong, Vice-Chair and the Members of the Committee on Education:

Good afternoon, my name is Melodie Aduja. I serve as Chair of the Oahu County Legislative Priorities Committee of the Democratic Party of Hawaii. Thank you for the opportunity to provide written testimony on House Bill No. 2164, relating to school-level funding for the Department of Education.

The OCC Legislative Priorities Committee is in favor of House Bill No. 2164 and support its passage.

House Bill No.2164 is in alignment with the Platform of the Democratic Party of Hawai'i ("DPH"), 2016, as it appropriates \$250,000,000 to the Department of Education for school-level funding.

The DPH Platform states that the '[w]e believe that the future of our state, as well as our country, depends upon an educated and knowledgeable citizenry. We support the prioritization of our resources toward providing quality public education and library services to every student, regardless of learning capacity or ability to pay, in an environment conducive to the learning process. These resources shall be made available at every level, from pre-school through higher education, including life-long learning." (Platform of the DPH, P. 6, Lines 296-300 (2016)).

We believe a major role of education is to develop critical and creative thinkers who are knowledgeable about issues and able to evaluate and solve real-world problems. The curriculum also should emphasize cultural learning, the arts, career and trace skills, and physical education so that we may preserve our health and rich cultural history. A variety of learning strategies should be used, including, group projects, cooperative learning, discussion, games and technological innovations. (Platform of the DPH, P. 6, Lines 310-314 (2016)).

Given that House Bill No. 2164 provides for school-level funding for the Department of Education, it is the position of the OCC Legislative Priorities Committee to support this measure.

Aloha! My name is Delylah Pagaduan and I am a Junior at Kalaheo High School in Kailua, Oahu. I strongly support this bill for emergency preparedness allowing schools to have students to be able to survive for 48 hours using the safe keiki grant program.

Public schools in Hawaii often have protocols for certain situations like fires, bombs, school threats and earthquakes, but they aren't enough especially since there are more threats than these. Even the protocol itself just isn't enough like for earthquakes, which is to crawl under a desk with hands over your head, is that very reassuring for students, staff and parents? According to the Live Science, natural disasters are becoming more common, it states "Scientists believe the increase in hydro-meteorological disasters is due to a combination of natural and made-made factors. Global warming is increasing the temperatures of the Earth's oceans and atmosphere, leading to more intense storms of all types, including hurricanes."

Recently, the state of Hawaii had a terrifying threat that ended up being false. The National Emergency Services had informed us that a missile was coming to Hawaii and that it wasn't a drill.
