DEPARTMENT'S POSITION: The Department of Human Services (DHS) supports this bill and offers the following comments. In addition to concepts identified in the measure, DHS administration is also discussing additional resources such as consultation, evaluation, and analytics capabilities that would support positive case outcomes and improved case practices.

<u>PURPOSE</u>: The purpose of the bill is to appropriate funds to establish a five-year program in the East Hawaii, Child Welfare Services (CWS) Section, in Hawaii County that limits the number of children per child welfare services caseworker to no more than twenty and funds additional case managers and support staff positions.

The notion of a five year pilot program is intriguing as DHS continues to examine ways to improve our services and response to families in crisis. DHS acknowledges an increase in children in foster care; the total number of children in foster care statewide has increased 23% from State Fiscal Year (SFY) 2014 to SFY 2017. The highest increase has been in the East Hawaii section, where we have seen a 56% increase of children in foster care over that same period. Preliminary data indicate parental substance abuse as the precipitating factor, resulting in these increased Child Welfare Services cases in East Hawaii. Fortunately,

CWS - East Hawaii has experienced a low vacancy rate (currently, all caseworker positions are filled in East Hawaii) and maintains a relatively stable workforce.

In SFY 2016, the confirmation rate for child abuse and/or neglect allegations in East Hawaii was the same as the statewide confirmation rate of 40%. Based on November 2017 data, the average caseload per worker in East Hawaii was slightly lower (25 cases) than the average caseload statewide (26 cases). The Department agrees that support is needed to reduce caseloads and increase the Child Welfare workforce, however, that need is not greater in East Hawaii than in other areas of the State.

As is well established, poverty, child abuse and neglect, and family violence, are results of complex social, economic and environmental factors, and we welcome the legislature's partnership to improve the child protective response system on the Big Island and throughout the state. However, in considering the suggested cap to worker caseloads, in addition to investment in child welfare services, any pilot must include equal or greater emphasis and investment to support and improve capacity of prevention and other services that strengthen families by addressing protective factors that when present in the home, reduce the risk and incident of abuse and neglect in the first place.

DHS appreciates the legislature's interest and commitment to protect and meet the needs of Hawaii's abused and neglected children. DHS is working with House and Senate committee members on a workable pilot project to improve the Child Welfare Services (CWS) system that will keep children safe and establish best practices in-line with the Administration for Children and Families federal standards. We understand that the legislature may not be able to allocate the projected cost of \$2.6 million at this time, and we will work with members and the community through conference to develop alternatives to achieve a caseload reduction to enable improved casework services to those in need of CWS services.

CWSB staff consistently report that insufficient resources and prevention programs are needed to better serve families. Early childhood and early learning opportunities for children and parents, residential substance abuse programs that allow children to be placed with parents, resources to address economic and health issues, limited transportation resources, and an aging state vehicle fleet are examples of needs identified by staff. To

address one of these needs, in SFY 2018, CWSB is identifying funding to purchase new vehicles for three of the Sections without motor pool services.

Thank you for the opportunity to provide written testimony **in strong support** of HB 2277, HD1, SD1 which appropriates funds to establish a five-year pilot program to limit the number of children supervised by social workers in the East Hawaii Child Welfare Services (CWS) section to <u>twenty or fewer</u> in order to appropriately care for the safety and well-being of children who have been or are at risk of being abused or neglected. I am Terry Walsh, with Catholic Charities Hawai`i.

Catholic Charities Hawai`i (CCH) is a tax exempt, non-profit agency that has been providing social services in Hawai`i for over 60 years. CCH has programs serving elders, children, developmentally disabled, homeless and immigrants. Our mission is to provide services and advocacy for the most vulnerable in Hawai`i. Our keiki deserve services that can protect them from harm and ideally prevent abuse and neglect.

Higher caseloads (40 – 50 per worker) are burdening CWS's ability to protect children as seen in high rates of child abuse and neglect as well as legal sanctions, claims, and settlements that have occurred when safety is compromised and court deadlines are unmet. Confirmed cases of child abuse and neglect in East Hawaii are documented at triple the rate of confirmed cases on Oahu. Since the great recession, the East Hawaii CWS section lost 19 out of 56 positions (a reduction in force of 34%). The Child Welfare League of America recommends caseloads of no more than 15 children per social worker. Reviews conducted by the United States Department of Health and Human Services show that the more time a social worker spends with a child and a family, the greater the likelihood that protective factors are strengthened and safety risks are reduced. At current caseload numbers in East Hawaii, it is more than difficult for social workers to make monthly visits and assessments in a geographic area that ranges from Honokaa to Ocean View.

We support implementation of this five-year pilot program ASAP. We strong support:

- 1. Limiting the number of children supervised by each social worker to 20 or fewer.
- 2. Adding eight full-time equivalent case managers and 15 full-time support staff positions.

We urge you to pass **HB 2277 HD1, SD1** to help protect our keiki in East Hawai`i from harm.

My name is Stephanie Batzer. I am the Chair of the Board of Directors for Family Programs Hawaii, a and family social worker, and I have been a Court Appointed Special Advocate Volunteer Guardian ad Litem (CASA VGAL) for nearly six years. On behalf of Family Programs Hawaii, I am submitting testimony in **STRONG SUPPORT of HB.2277 H.D.1 S.D.1** Relating to Child Welfare Services, which would establish the East Hawaii Child Welfare Services Section Pilot, increasing staff and reducing caseloads in the East Hawaii Child Welfare Services Section.

Children are Hawaii's most valuable resource. They are our future. Family Programs Hawaii is a unique non-profit agency that provides quality care to the children of Hawaii. Our goal is that every child in Hawaii has the opportunity to reach his or her full potential. We help foster children and children at risk with three areas of service: prevention, transition, and support. We do this from two offices, located in Honolulu and Hilo. Our social workers in Hilo see the impact of overworked Child Welfare Services caseworkers upon the children in foster care. This pilot is long overdue, and the children of Hilo deserve the greater level of support, and additional consultation, evaluation and analytics capabilities that this program would enable.

The rate of children entering into foster care has been on the rise in Hawaii for the past three and a half years. The rise has been most dramatic in Hilo, with the chief cause of removal being parental substance abuse and significant child neglect. Casey Family Programs, a benefactor of Family Programs Hawaii, has recognized the need to reduce the workload for child welfare social workers, and to help strengthen families before they enter into the child welfare system. Increasing the number of social workers combined with reducing individual caseloads should greatly improve the outcome for these families.

For this reason, I strongly urge you vote in support of H.B. 2277 H.D.1 S.D. 1., and strongly urge that the appropriation and implementation occur **well before** 7/1/3000.

The office oversees the safety of endangered children in a geographic area that extends from Honokaa to Ocean View, including the districts of north and south Hilo, Puna, and much of Hamakua and Kau. Furthermore, the rate of confirmed cases for abuse or neglect in 2015 was two hundred thirteen children per 100,000 residents in Hawaii county, nearly triple the rate of confirmed cases for the city and county of Honolulu.

The legislature further finds that due to challenging economic times and funding cuts in Hawaii's child welfare services, layoffs and hiring restrictions have caused the east Hawaii child welfare services section to lose nineteen of the fifty-six positions it had in 2009, resulting in a dramatic increase in average caseload per caseworker. The recommended number of caseloads for social workers is no more than fifteen children, but social workers in east Hawaii regularly have caseloads of forty to fifty children. These higher caseloads increase the potential for harm to children at risk for neglect or abuse, further contributing to the high rate of confirmed cases in Hawaii county, and has even prompted the family court to sanction the east Hawaii child welfare services section because of late filings of reports and failure to meet court deadlines. Therefore, the legislature finds that it is necessary to undertake a pilot project demonstrating the positive impact of adequate staffing levels on the safety and well-being of at-risk children and families in east Hawaii.

The purpose of this Act is to appropriate funds for:

- (1) The department of human services to establish a five-year pilot program in the east Hawaii child welfare services section in Hawaii county that limits the number of children per child welfare services caseworker to no more than twenty; and
 - (2) Additional case managers and support staff for the pilot program.

SECTION 2. There is appropriated out of the general revenues of the State of Hawaii the sum of \$ or so much thereof as may be necessary for fiscal year 2018-2019 for:

- (1) The department of human services, child welfare services branch, to establish a five-year pilot program that limits the number of children supervised by each child welfare services caseworker at no more than twenty in the east Hawaii child welfare services section in the county of Hawaii; and
- (2) Eight full-time equivalent (8.0 FTE) case managers and fifteen full-time equivalent (15.0 FTE) support staff positions for the pilot program.

The sum appropriated shall be expended by the department of human services for the purposes of this Act.

SECTION 3. This Act shall take effect on July 1, 2018.
