Chair Brower, Vice Chair Nakamura, and Members of the House Committee on Housing.

The Office of Planning (OP) opposes HB 2451 in its current form. HB 2451 would amend Hawaii Revised Statutes (HRS) § 205-4.5 (a)(4) to allow tiny homes or dwellings of less than 500 square feet, on lands in the State Agricultural Land Use District, provided the tiny home is mobile, used as a residential dwelling for a farm employee working a minimum of 16 hours on a farm or a family member of the farm employee, or by the owner of the farm, and provided other requirements are met, including an affidavit to the Land Use Commission (LUC).

HB 2451 is intended to encourage the use of "tiny" homes for farm worker housing in support of local agricultural production. OP fully supports efforts to help local farmers and grow the State's agricultural economy, including the need for housing for farm labor, but this is not an issue that can be solved simply by relaxing land use regulatory standards.

In addition, OP has the following objections to the bill as written:

- The counties have ample authority under HRS Chapter 205 and HRS § 46-4 to enact ordinances for acceptable forms of affordable farm labor housing, such as proposed in HB 2451, and this kind of initiative should be pursued at the county-level. Currently "farm dwellings" are allowed within the State Agricultural district. Thus, OP believes this measure is unnecessary;
- As written, the amendment to HRS § 205-4.5 (a)(4) will be problematic for county implementation and enforcement, and frustrate county efforts to regulate and control non-agricultural residential uses in the State Agricultural District.

- The measure includes a provision by way of an affidavit to the LUC that the tiny home will conform to the requirements. Since the LUC does not normally regulate uses and construction within the State agricultural districts this may be create difficulties in enforcement with the counties.
- The nature of mobile homes may subject the occupants to a higher than normal risk during hazardous conditions, such tsunamis, flooding, hurricanes and other relevant conditions.
- We note that there is a miswording in 205-4.5(24)(A)(ii), "The owner of a farm that has been engaged in agricultural production for a continuous period of less than five years;" should be changed to "...no less than five years".
- HB 2451has the potential to place farm labor families at risk of exposure to dust and pesticides and other public health and safety concerns.
- As currently written, HB 2451 would also provide another pathway for nonagricultural residential use in the State Agricultural District, which could contribute to further use of these dwellings for transient and vacation accommodations, increases in agricultural land values, and exurban sprawl without attendant public facilities and services.

Relating to Housing that Supports Agricultural Production

The County of Hawai'i Planning Department would like to express its STRONG OPPOSITION to this bill.

HB 2451 is redundant since both State and County land use laws already provide opportunities for employee housing and farm dwellings on legitimate farms within our Agricultural Districts. "Tiny homes" or all dwellings situated on Agricultural lands must be a "farm dwelling". There is no compelling need to create a "tiny homes" category of farm dwellings on Agricultural lands.

The Hawai'i County Zoning Code (HCC Chapter 25) currently allows for a "farm dwelling" as a permitted use on Agricultural-zoned lands, in alignment with State land use law. By Zoning Code definition, a "Farm dwelling" means a single-family dwelling located on or used in connection with a farm, or if the agricultural activity provides income to the family occupying the dwelling.

There is a misconception that obtaining a farm dwelling unit is complicated. An owner only needs to sign a Farm Dwelling Notice for the first farm dwelling unit on a parcel. The department has adopted rules of practice and procedures for owners to obtain additional farm dwelling units (beyond the initial farm dwelling). An Additional Farm Dwelling Agreement is signed if an owner can provide documentation of adequate farming activity. Bill 2451 proposes a process of determining adequate farming activity that is similar to our current process. Tiny homes can be currently built on agricultural lands in the County of Hawai'i. Therefore, HB 2451 is redundant and likely to cause confusion.

HOUSE BILL NO. 2451 RELATING TO HOUSING THAT SUPPORTS AGRICULTURAL PRODUCTION

Chairperson Brower and Members of the Committee:

Thank you for the opportunity to testify on House Bill No. 2451 that seeks to amend Chapter 205 by authorizing "tiny homes" of less than 500 square feet for residential use within the Agricultural District under certain conditions. The Department of Agriculture is opposed to this measure that allows a specific type of housing under a different set of conditions than what exists in Chapter 205 which already permits "farm dwellings" and "employee housing" that are accessory to agricultural activities.

House Bill 2 from the 2017 Legislative Session was vetoed because Chapter 205 and the Hawaii County zoning ordinance (Chapter 25, Hawaii County Code) already allow for "farm dwellings" and "employee housing" of any size as permitted uses of agricultural zoned land.

Chapter 205 is replete with piecemeal amendments that attempt to address a problem by imposing a solution upon the counties. The Department is concerned that these "tiny homes" may become de facto residential dwellings if the County is unable to adequately monitor and enforce the conditions of this measure.
