Aloha Transportation Chair Aquino, Vice Chair Quinlan, and esteemed members of the Committee on Transportation:

Hawaii Bicycling League **strongly supports HB2499**, which would define electric bicycles as classified by the federal government at "low-speed electric bicycles" as bicycles in the state of Hawaii.

HB2499 is a sound approach to defining and regulating low-speed electric bicycles. Currently electric bicycles are in a regulatory limbo in Hawaii; given the growth in electric bikes in recent years this regulatory limbo is a problematic situation. Using the federal definition of "low speed electric bicycles" will bring Hawaii in line with 21 other states. It's also important to note that the federal definition has shaped electric bicycle manufacturing and the electric bicycles currently available for sale in Hawaii. Furthermore, using the federal definition of "low speed electric bicycles" will ensure that we do not treat all electric bicycles equal – those that can go higher speeds than 20mph as specified in the federal definition (in some cases, much higher speeds) shouldn't be afforded the same treatment as bicycles.

Chairman Aquino, Vice-Chairman Quinlan:

I am testifying in SUPPORT of HB2499. I have used a bicycle in Hawaii for about 30 years. In recent years there has been increased interest in so-called pedal-assist bicycles (aka e-bicycles) as an alternative to the traditional bike. These bicycles typically look and operate very similar to traditional bikes and the rental bikes used in the Biki Bike program. Under current law, since these bicycles have a motor, they are classed with "mopeds". However, to my knowledge, no user/owner of these bicycles complies with the law on registration or operation of mopeds. If enacted, this bill will clarify that pedal-assist/e-bikes will in general follow the registration and operation rules for bicycles which is appropriate. The prohibition on sidewalk riding may not be mandatory, but is reasonable in most cases. There may be locations however, where riders feel they must use sidewalks for their safety (for example, Kam Hwy between the end of the Pearl Harbor Bike Path and the Ford Island Causeway where no bike lane/shoulder exists and alongside JB Pearl Harbor-Hickam where HART's rail contractor has removed the bike lane in favor of providing an additional vehicle lane).

I urge you to pass HB2499 in order to clarify that electric bicycles ("e-bikes") should be considered as bicycles, not model or motor-driven cycles. The availability of small electric motors has revolutionized bicycling as a means of transport for ordinary people. With electric assist an e-bike can be pedaled with less effort, meaning that commuters can arrive looking ready for work rather than looking like they just finished a sweaty workout. An e-bike travels at speeds similar to a regular bike, but with much less effort required of the user. Whether peddling up a steep hill or right into a stiff trade wind, an e-bike brings cycling within the realm of the possible.

This bill clarifies language using national standards in order to ensure that e-bikes are not mistakenly interpreted as motorcycles or mopeds. Note that such a designation might prevent the use of e-bikes in bike lanes and other designated bicycle-only zones. This would have the perverse effect of making cycling more dangerous. This bill will prevent such a misinterpretation of current law.

I rode a regular bike for years, but riding uphill and pedaling longer distances is just too much for me anymore. I try to use bike lanes as much as possible, but Honolulu has so very few bike lanes, so I must either use the roadway or the sidewalk. I use the roadway when I can, but many streets are too crowded and frankly unsafe to navigate. The only way I can ride safely is by using the sidewalk from time to time.

HB2499 would prohibit riding on the sidewalk for all low speed electric bikes. Perhaps if Honolulu had sufficient alternative bike lanes for all major streets this would make sense, but as it is this bill will significantly limit the places I can safely ride. Please reconsider this part of the bill. I can understand prohibiting bicycle riding on sidewalks in Waikiki and Downtown, but for many parts of Honolulu, riding on the sidewalks is the only way to insure a safe and stress-free ride, either for a regular bike or a low speed electric bike.
