Purpose of Bill: Makes housekeeping amendments to remove preschools from the superintendent of education's scope of authority and to clarify that

the director of the Executive Office on Early Learning may authorize preschool personnel access to a student's immunization registry

information.

EXECUTIVE OFFICE ON EARLY LEARNING'S POSITION: The Executive Office on Early Learning (EOEL) supports H.B. No. 2507.

This housekeeping bill would bring statute into conformity with previously enacted legislation that place the responsibility for preschool/pre-kindergarten with what is now the Early Learning Board and EOEL.

Previously enacted statutes include the following:

- Repeal of sections 302A-409 and 302A-410, HRS, which required DOE to develop an early education plan. The same legislation established an early learning system to be developed and administered by the entity now known as the Early Learning Board, which is tasked with formulating statewide policy relating to early learning (section 302L-1.6, HRS, first enacted in 2012);
- Establishment of EOEL to "help the State meet its goal of providing a viable early learning system for the keiki of Hawaii" (Conference Committee Report No. 173 for S.B. No. 2545, enacted as Act 178, Regular Session of 2012), and tasking EOEL with developing a plan for the early learning system (section 302L-1.5, HRS, first enacted in 2012);
- Establishment of the EOEL Public Pre-Kindergarten Program to be administered by EOEL (section 302L-7, HRS, first enacted in 2015); and

 Transformation of the Early Learning Advisory Board into a governing board, to "empower the Early Learning Advisory Board to take a more active role in directing consistent early childhood development policy and expand the public prekindergarten program", recognizing that "a broad and consistent approach to early childhood development promotes the health and wellbeing of children" (Senate Standing Committee Report No. 1058 for H.B. No. 498, enacted as Act 202, Regular Session of 2017).

The bill would also allow the EOEL Director to ensure compliance with mandatory student immunization requirements.

We believe H.B. No. 2507 further clarifies the Legislature's intent to charge the Early Learning Board and EOEL with the responsibility for preschool/pre-kindergarten.

Over the past 10 years, I have served as a member of the Early Learning Task Force, the Early Learning Council and the Early Learning Advisory Board, which is now the Early Learning Board. HB 2507 helps to clarify the intent of legislation to charge the Executive Office of Early Learning, under the governing authority of the Early Learning Board, to develop a state-wide early learning system with specific responsibility for a preschool and pre-K years.
