My name is Joyce Camille Ramano and I am a pharmacist in support of this bill. Medication non-adherence can hinder the optimization of patient care plans leading to an increase in front-end healthcare expenditure (hospital admission and readmission, etc.) and worsening morbidity and mortality. Compliance packaging helps improve medication adherence as it prepackages a patient's monthly medication supply into a blisterpack that separates medications by the appropriate time of the day to take them. Compliance packaging ensures that patients receive all of their maintenance medications at the same time and allows patients to store all of their medications in one place, which makes it easier to obtain an accurate and current medication list in case of an emergency. More importantly, it is a very helpful tool for patients with complex medication regimens, poor memory, low healthcare literacy, language barrier, and/or mental health disorder as it prepackages the patient's medication into weekly pillboxes separated by times of the day. It also engages pharmacists in patients' care plans because it allows us to keep track of patients' monthly medication regimens and verify clinically-significant medication changes and/or intervene as necessary. Compliance packaging promotes a collaborative healthcare team approach in overcoming medication non-adherence that negatively affects patient outcomes and healthcare expenditure.
