Aloha Chair Luke, Vice Chair Cullen and members of the Committee,

My name is Krystal Schlechter and I am currently a tour guide on Hawai'i island. I attended the University of Hawai'i at Hilo (UHH), and graduated with a B.S. in Astronomy and a B.A. in Physics in 2015. During my time at UHH I had the amazing pleasure of interning for the Pacific International Space Center for Exploration Systems (PISCES). It was my first internship as an aspiring astronomer and without a doubt, that internship helped shaped who I am today on top of providing me with a unique, handson, intellectually challenging, and breathtaking educational experience. As a learner and educator, I want as many students as possible to have the chance to experience internships like I did. This is why I support Measure HB2557.

I first got to know PISCES through the Akamai Internship Program. I started working on a project that would help a satellite called the Lunar Atmosphere Dust and Environment Explorer (LADEE). I was provided with two telescopes that I would set up and attach video cameras to them and record the moon, ultimately looking for meteors crashing on the surface of the moon. During my Akamai internship, (due to a short time frame) I was able to organize the the project and get it going. Setting up two telescopes on the slopes of Maunakea in the middle of night is quite difficult and dangerous for one person so I organized volunteers from the UHH Astronomy Department to help me. I had to first learn, and then teach my volunteers how to properly set up and take down 11" telescopes, how to analyze the data that we got, and how to properly take care of the equipment and each other during our long nights on the mauna. This was a long term project however, so after my Akamai internship was completed, PISCES hired me on as an intern directly so that I could see the mission through.

Thanks to PISCES, by the time the LADEE mission was completed, I had logged around 1000 hours of observing alone; I had trained about 10 people how to properly care for, operate, and transport, fairly large telescopes (a few of these people went on to volunteer or work for the Maunakea Visitor Information Station with the experience they gained); I became a mentor to a high schooler that went on to win awards for her work with the LADEE project and continues to pursue astronomy today; I got the amazing opportunity to see the LADEE mission be sent off to space (mostly thanks to donations, but impossible without PISCES support) from Wallops, VA. Overall I

developed social skills and learned how to act in professional settings and write press releases. I attended conferences and got to speak about the project to people around the world about the work we were doing at PISCES, further developing my communication and speaking skills.

Had I not interned for PISCES, I'm not sure I would have completed my degree. I often found my coursework hard and difficult but when I thought about the work I was doing, and what I could do from that, and that kept me inspired and fighting. I would not have been exposed to as many opportunities as I was, or developed as many connections on the island and around the world, therefore I might not be where I am today nor possess the wealth of knowledge that I have today. These are all if's and maybe's, but I can say for certain that my education at UHH would not have been nearly as fulfilling or even adequate if it were not for the additional work and experience that I gained during my time intening for PISCES. It would be a downright shame to take that same educational experience away from future students.

Although I have decided not to pursue astronomy research (by no fault of my internship with PISCES), I still use the skills and knowledge I gained from my time interning for PISCES. One of the most common questions I get on tour today (especially in Kona) is: "what do you do with all this lava, can you use it for something?" When I start by telling them we mostly just use it as a road foundation, people are disappointed. They often think that seems wasteful. Then I start describing some of the work PISCES has done with the basalt, like the 3D printed sidewalk in Hilo and the possibilities of this in space, the martian and lunar rover testing on Maunakea, and the research into lava tubes and, again, the possibility of living in them in space. People are suddenly excited for what the future holds upon hearing this information. They see Hawai'i not just as beaches and palm trees, but as a place of science and innovation, carrying on the Hawaiian traditions to explore and utilize without waste. In my opinion, tourists seems to walk away happier knowing that the money they spend on island isn't just going back to the resorts, but to the future of humans. I know I would be much happier knowing my taxes were going to encourage our future generations to expand our knowledge and capabilities as a human race as well as helping them develop the skills they will need to do so.

Please, continue to support PISCES and the work they do in with internship and economic development programs on Hawai'i island. Support support Measure HB2557.
