Genuine progress indicators (GPI) are more commonly used in ecological economics to appropriately measure sustainability initiatives by measuring whether the environmental impact and social costs of economic production and consumption are negative or positive factors in overall health and well-being.

OP appreciates the intent to coordinate the many indicators provided in the Hawaii 2050 Sustainability Plan, the Aloha+ Challenge resolution, and the Hawaii Comprehensive Economic Development Strategy to align and support the development of statewide genuine progress indicators for an overall sustainable economic development strategy.

The Department of Business, Economic Development and Tourism (DBEDT) supports the intent with comments on House Bill 2560.

HB 2560 requires the state's sustainability coordinator to develop a sustainable economic development strategy, derived from data mining services provided by the University of Hawaii, and using genuine progress indicators (GPI) to generate recommendations that promote indigenous-based economies, and the economic diversity, and sustainability of the State's economy.

DBEDT offers the following comments:

- 1) We support the development of a sustainable economic development strategy and the development of genuine progress indicators as a set of metrics to supplement the measurement of the gross domestic product (GDP). Genuine progress indicators (GPI) are more commonly used in ecological economics to appropriately measure sustainability initiatives by measuring whether the environmental impact and social costs of economic production and consumption are negative or positive factors in overall health and well-being.
- 2) The Sustainability Coordinator would require two appropriations in order to complete the strategy: \$500,000 to UH for data-mining services; and \$100,000 to OP for research services, provided that it does not replace or adversely impact the priorities indicated in the Executive Budget.

- 3) The project will take longer than 6 months. We recommend that the report in 2019 be a progress report with the final report being due in 2020.
- 4) DBEDT supports the use of both GDP and GPI measures to be used as appropriate.

To the Honorable Cindy Evans, Chair; the Honorable Jarrett Keohokalole, Vice Chair, and Members of the Committee on Economic Development & Business:

Good morning. My name is Melodie Aduja. I serve as Chair of the Oahu County Committee ("OCC") Legislative Priorities Committee of the Democratic Party of Hawaii. Thank you for the opportunity to provide written testimony on House Bill No. 2560, relating to a study to develop a sustainable economic development strategy that uses genuine progress indicators to provide recommendations to strengthen Hawaii's indigenous-based economies and create a more diverse and sustainable economy for

the State. The OCC Legislative Priorities Committee is in favor of House Bill No. 2560 and support its passage.

House Bill No. 2560, is in accord with the Platform of the Democratic Party of Hawai'i ("DPH"), 2016, as it: (1) requires the state sustainability coordinator to develop a sustainable economic development strategy; (2) directs the state sustainability coordinator to use genuine progress indicators to generate recommendations that promote indigenous-based economies, economic diversity, and sustainability; (3) requires the University of Hawaii to provide data mining services; and (4) requires a report to legislature.

Specifically, the DPH Platform states, "We believe in efforts to build and retain a qualified workforce in Hawai'i . . . As the party of working men and women in Hawai'i, we work to protect labor rights and social security; to ensure fair labor practices, a living wage for all workers, equal pay for equal work and fair taxation; we encourage legislation to raise the minimum wage and paid family and sick leave; to protect employees' rights to organize and bargain collectively with their employers; to oppose the outsourcing of Hawaii's jobs; to promote employment opportunities and sustainable growth; to assist the economically disadvantaged and advocate for sound trade and economic policies; and build our workforce for jobs in emerging technologies, in green industries, in renovation and in green construction, so that their jobs are not dependent on ever-expanding real estate development. (Platform of the DPH, P. 3, Lines 119, 122-129 (2016)).

Given that House Bill No. 2560 provides for a study to develop a sustainable economic development strategy that uses genuine progress indicators to establish recommendations to strengthen Hawaii's indigenous-based economies and create a more diverse and sustainable economy for the State; it is the position of the OCC Legislative Priorities Committee to support this measure.
