Relating to Road Repair and Maintenance in Housing Subdivisions

The County of Hawai'i Planning Department would like to express **OPPOSITION of H.B. 2570** that places requirements on counties regarding road repair and maintenance in subdivisions.

I applaud Representative Buenaventura for trying to tackle this problem. Fifty years in the making, substandard subdivisions in Puna and Ocean View have hundreds of miles of substandard and deteriorating roads. Bill HB 2570 would place an unfair burden on the County of Hawai'i to implement the legislation. I agree that we must determine viable solutions for substandard subdivisions, but I find it impossible to accomplish this under a timeline dictated by the current legislative session. Moreover, determining viable options demands collaborative discussions and decision making between departments and across jurisdictions which is a time intensive process.

To move this issue forward in the County of Hawai'i, a feasibility study is needed that would include financing and implementation options. No doubt that lack of staff capacity, funding and competing priorities have prevented the county from conducting a feasibility study to date. Therefore, I suggest the State provide \$300,000 to the County of Hawai'i to fund a feasibility study on roads and repairs in substandard subdivisions conducted by a consultant and contract management by a county department.

I'm writing in support of HB2570. I have lived in Hawaiian Acres since 1975. The original developers of the subdivision were not required to provide infrastructure back then. A road corporation was formed in the 1960's that operated solely on voluntary contributions from lot owners. Road maintenance has always been seriously underfunded despite the best efforts of many committee members. In the past few years contributions have become almost nonexistent and the road committee is now essentially dysfunctional.

We need help. The land prices in this subdivision are very low, primarily because of the terrible roads. Consequently we are seeing a dramatic surge in people moving out here because of the affordability. The new residents are, by and large, even less able or inclined to contribute money to infrastructure. I see no alternative to mandatory road fees. I believe that it should be up to the property owners in the subdivisions whether they have mandatory fees of any kind. Having oversight of the private roads by government officials has not been a requirement in the past and should not be one in the future. Slightly more than 10% participate by residents paying \$60/month/lot - well under \$30,000/year for over 300 miles of sun-standard roads - does not come close to addressing the issues. Currently the Road Corporation can not find enough voulunteers to represent each of the six "major" arteries (B through G).
