In consideration of **HOUSE BILL 2585 RELATING TO OCEAN SAFETY**

House Bill 2585 proposes to require Tourism Special Fund moneys to be made available to support state and county ocean safety programs. The Department of Land and Natural Resources (Department) supports this measure provided that its passage does not replace or adversely impact priorities indicated in the Executive Supplemental Budget request and offers the following comments.

The Department is supportive of any measure that allocates revenue derived from the tourism industry to the Department to offset the impacts of the tourism industry on specific Department programs especially those related to beach and ocean safety.

The Department's Division of Boating and Ocean Recreation currently provides an ocean safety program that includes safety education and such items as swim buoys. The Department's Division of State Parks currently contracts lifeguard services with the four counties for staffing costs and with this additional revenue would be able to provide ancillary equipment such as lifeguard towers, rescue vehicles and other necessary equipment.

The Department is open to any suggested percentage but would suggest 5% which would cover the Department's four lifeguard contracts as well as increasing ocean safety education outreach.

Chair Onishi, Vice-Chair Fukumoto, and Committee Members:

The Hawai'i Tourism Authority (HTA) offers the following **comments on HB2585**, which proposes to allocate a percentage of the Tourism Special Fund (TSF) to support state and county ocean safety programs, education and visitor awareness. HTA proposes that any additional funding for ocean safety programs, beyond what HTA already provides, should be allocated from Transient Accommodations Tax (TAT) revenues, rather than the TSF.

HTA is actively involved in supporting State, county and community ocean safety programs, as well as programs focused on education and increasing visitor awareness of dangerous ocean conditions. These programs include the Junior Lifeguard Program, which HTA funded in 2017 with \$250,000 when the City and County of Honolulu's budget shortfall threatened to end the program. Through this program, approximately 2,000 young residents were trained as community water safety ambassadors to enhance their ocean safety awareness and water rescue skills. HTA also places ocean safety information in a prominent location on its GoHawaii mobile application and the gohawaii.com and hawaiibeachsafety.com websites. HTA also provided water safety video footage for Hawaiian Airlines' in-flight water safety video.

HTA also contributed to the 2017 State of Hawai'i Drowning Prevention and Ocean Safety Conference, the State Drowning and Aquatic Injury Prevention Advisory Committee's efforts to increase visitors and residents' water safety awareness and research projects focused on visitor water safety awareness. HTA recently updated its visitor satisfaction survey to separate swimming, snorkeling and diving to assist State agencies and improve tracking and monitoring of visitor water activities.

HTA plans to continue supporting programs and is actively engaged with its stakeholders across the State to identify new initiatives to increase ocean safety. Diverting a percentage of the TSF to fund "state and county ocean safety programs" would impair HTA's ability to fund community programs and allocate funding across the board based on rapidly changing circumstances. Therefore, HTA proposes that the bill be amended to allocate monies from TAT revenues, instead of from the TSF.

programs.

Statistics compiled by the State Department of Health show that drowning is the leading cause of unintentional injury deaths for visitors to Hawaii, and that the overwhelming majority of these fatal drownings involve swimming and/or snorkeling in the ocean.

The HLA strongly supports HB 2585 and urges your favorable consideration of this important matter.

Aloha Representatives,

I work in Ocean Safety. We respond to the North, South and West coastlines of Maui Island. We only have 9 stations, 12 towers for the whole island. This is not adequate coverage to keep visitors and residents safe as we have already had 10 ocean related deaths in 2018 thus far. Ocean safety education is not adequate. Pu'u Keka'a on Ka'anapali where the Sheraton is has had 22 deaths. Lifeguards are employed by the county unless contracted to specific state beaches (Hapuna, Makena, Ke'e, etc). Neighbor islands in particular need more lifeguards at places where people are drowning and these are mainly state beaches and resort areas where the county does not have "jurisdiction." Something needs to be done. Last legislative session some representatives felt that taking away lifeguards limited liability protections would make it safer for folks at our beaches. Five weeks into 2018, it seems visitors to our beaches are more unsafe than ever before. We need coordinated efforts to promote ocean safety that collaborate between, county, state and tourist leaders - I hope this bill can do that. Give back lifeguard liability protection and extend it to hotels that step up and do the right thing that chip in funds to the county along with the state to extend lifeguard protections at heavily used dangerous state beaches. By working together in a coordinated way we can save lives.

Comments:

I live in S Kihei and Ulua is our regular beach spot. There is a disproportionate rate of deaths and injuries at this particular beach (ULUA) in Wailea. There is public parking, scuba lessons, commercial activity, showers, bathrooms, a convenient "drop off" area with a paved ramp going straight down to nearly the water's edge. Andaz hotel and Wailea Elua Villas (all vacation rented) front this area. The "Wailea Path" which is a paved sidewalk stretching up and down the shore also means LOTS of visitors are coming to this beach. Sometimes there is even a Pacific Whale Foundation educational table set up on this beach. But NO LIFEGUARD!

We can't control people or water conditions- but I've observed that tourists tend to NOT go to places as often when there are no services (no parking, no showers, no bathrooms) and if they do there is a sense that they are on their own. But at Ulua it feels like there is everything you see on a life guarded beach- except the actual life guard. Flags should have been up and warning signs posted on Feb 4th when an 80 year old male from Alaska sadly and tragically died. I was there on Feb 4 and saw the emergency team trying so hard to save this man. Waves were crashing 6-8 feet on shore- no one in their right mind would snorkel in that. It's sad but I think preventable. I'm all for taking money from the tourism industry to fund more lifeguard stands- not just MOVE them around, but fund NEW stations AND protect our watermen and women from liability as they risk their lives to save others!
