Testimony COMMENTING on HB2663 RELATING TO DISTRICT HEALTH OFFICERS OF THE STATE OF HAWAII.

- 1 **Fiscal Implications:** Potential salary and benefits costs adjustments.
- 2 **Department Testimony:** The Department of Health (DOH) acknowledges the intent of HB2663
- 3 which is to require a District Health Officer (DHO) to be a Hawaii-licensed physician.
- 4 The department has had a history of competent and effective DHOs coordinating public health
- 5 efforts in rural counties who were both physicians and non-physicians. Since 1995 the Hawaii
- 6 District Health Office has had three DHO that were not physicians, including the current officer,
- 7 who has been in the position on an acting basis for approximately 6 years and was then made
- 8 permeant in December 2011. The incumbent has an extensive environmental health background,
- 9 particularly well-suited for Big Island needs, and has been employed with the Department of
- Health since December 1983, approximately 34 years.
- It is important to note that the primary responsibility of the DHOs is administrative in nature.
- 12 These administrative duties include procurement, payroll, pre-audit, accounting, budget
- management, labor relations, employee benefits and transaction, classification, recruitment and
- examination, training and safety, IT, and facilities management.

- 1 The District Health Offices are not independent of the department but are an essential part that
- 2 provides vital services to neighbor island communities. These public health, environmental
- 3 health, and behavioral health services receive guidance from a variety of sources in Honolulu
- 4 and the counties, and it is the role of the District Health Officer to support these efforts and
- 5 maintain statewide consistency.
- 6 It is accurate to say that a physician is knowledgeable in medicine, but medicine is not the same
- 7 a public health, a very distinct field of study, and while a clinical background may lend itself to
- 8 certain situations, strong administrative talent and a expertise in population health management
- 9 are also required. Unfortunately, in the current marketplace these types of applicants are difficult
- 10 to recruit and hire.
- 11 The Department of Health understands the concerns forwarded by the Hawaii County Council
- but respectfully suggests that statute requiring specific qualifications is obtrusive and impedes on
- managerial decisions best left to the executive branch. The department requests to retain its
- current flexibility to consider both physician and non-physician applicants when recruiting for
- District Health Officers, to ensure that we are able to consider individuals with the most relevant
- skills, knowledge and abilities to provide effective leadership and guidance to our District Health
- 17 Offices statewide. The department respectfully requests this measure be deferred.
