Thank you for the opportunity to provide comments supporting the intent of **House Bill 2671, HD1**, **SD1** provided it does not impact the priorities detailed in the Governor's Executive Budget.

This bill appropriates yet unspecified funds to the Office of the Governor, the Department of Labor and Industrial Relations, the Department of Business, Economic Development, and Tourism, the Department of Human Resources Development, and the Department of Agriculture to collaboratively develop and implement solutions to assist dislocated workers and address the overall continued availability of gainful employment on the island of Molokai.

Although the Office of the Governor supports the intent of this measure, our office does not have the resources to lead this project and generate the report required in SD1. If the Legislature would like the Office of the Governor to take the lead, we would request additional funding for our office to support this initiative.

#### Re: H.B. No. 2671 HD1 SD1 Relating to Employment Opportunity

HB2671 HD1SD1 proposes to appropriate funds to the Office of the Governor and the Departments of Labor and Industrial Relations, Business Economic Development and Tourism, Human Resources Development, and the Agriculture to collaborate in developing and implementing methods to assist dislocated workers and address the need for gainful employment on the island of Molokai. DLIR <u>supports the intent</u> of this measure provided it does not conflict with the Governor's budget priorities. DLIR <u>defers</u> to the Office of the Governor regarding the reporting requirements in the measure.

With the passing of this legislation and funds appropriated to the department, DLIR would provide assistance with basic educational and vocational training to better prepare affected populations on the island of Molokai for potential job opportunities. Entrepreneurial training may be included if small business opportunities are developed in collaboration with designated agencies.

#### HB 2671 HD1 SD1 - RELATING TO EMPLOYMENT OPPORTUNITY

Chair Dela Cruz, Vice Chair Keith-Agaran, and members of the Senate Committee on Ways and Means:

Thank you for the opportunity to testify in support of HB 2671 HD1 SD1. With Mycogen leaving Moloka'i, as many as 80-90 temporary agricultural workers will lose their jobs. This further aggravates the economic plight on Moloka'i. The College of Tropical Agriculture and Human Resources (CTAHR) believes that with the collaboration of the diverse agencies mentioned some retraining and creative job deliverance is possible that not only will help some portion of the soon to be unemployed, but will also increase the agricultural production of the island.

While the bill is not specific as to the solutions, the immediate need for resources to support economic development is real; and retraining as well as equipment support will certainly be necessary and will not easily wait until next year. CTAHR is already engaged with Windward Community College (WCC) with WCC funding the retraining and CTAHR Extension Agents providing the farm training.

For these reasons we support the bill and are available to provide our input to determine what solutions are applicable to benefit the citizens of Moloka'i.
