TESTIMONY TO THE HOUSE COMMITTEE ON COMMERCE PROTECTION AND COMMERCE

House Bill 2675 - Relating to Emergency Management

The Disability and Communication Access Board (DCAB) supports the intent of House Bill 2675 to require each local television station to make emergency information that is provided in the audio portion of its video programming accessible to persons with hearing disabilities by using a method of closed or open captioning.

The importance of this bill is underscored by the events of the false missile alert on January 13, 2018. There were no captioned or interpreted announcements on television to inform the deaf and hard of hearing community that the alert was a false alarm, nor were there any captioned or interpreted press conferences, interviews, or explanations after the false alarm. Persons with hearing disabilities are entitled to receive the same timely information from the media.

While we support the intent of the bill, we would like to offer technical comments regarding the wording of the bill. It should be noted that captioning of video programming does not automatically make the information equally accessible to all persons with hearing disabilities. Additional requirements, such as live American Sign Language (ASL) interpretation, will increase the number of individuals that are afforded effective communication during emergency broadcasts. This is important to note because a significant number of individuals with a hearing disability graduate high school without the reading proficiency needed to effectively understand written emergency announcements.

Chair Takumi, Vice Chair Ichiyama, and the Members of the Committee:

HB 2675 would require each local television station to make emergency information that is provided in the audio portion of its video programming accessible to persons with hearing disabilities by using a method of closed or open captioning. The Hawaii Emergency Management Agency (HI-EMA) fully supports this part of the bill.

However, HB 2675 also tasks HI-EMA with monitoring and enforcing the captioning requirement by issuing a warning and assessing a fine if the requirement is not met by a television station. The HI-EMA *opposes* this part of HB 2675.

With respect, HI-EMA does not have the resources to monitor and enforce complaints as specified above nor collect and receive fines. The primary focus for HI-EMA and county emergency management agencies before, during and after a disaster is to provide emergency resources and support to county and jurisdiction requests for assistance. This additional responsibility will detract from that primary purpose.

SUBJECT: Comments for House Bill 2675 Relating to Emergency Management

I am Melvin N. Kaku, director of the Department of Emergency Management (DEM), City and County of Honolulu (City). H.B. 2675 requires each local television station to make emergency information that is provided in the audio portion of its video programming accessible to persons with hearing disabilities by using a method of closed or open captioning.

While DEM agrees with the intent of the bill we feel that the Hawaii Emergency Management Agency (HI-EMA) may not be the best governing body to monitor compliance nor issue notices of violation or assess fines as addressed in the bill.

During an emergency activation for a major disaster it may prove difficult to assign HI-EMA to constantly monitor Emergency Alert System (EAS) broadcasts issued by local television and cable stations

DEM feels that this duty and the intent of H.B. 2675 would be better served by the State agency other than Hawaii Emergency Management Agency, who are the governing body responsible for issuing administrative rules and guidelines for the utilization of communication access services for our disabled community. In this regard, we cannot support H.B. 2675.

TESTIMONY OF CHRIS LEONARD PRESIDENT – HAWAI'I ASSOCIATION OF BROADCASTERS COMMENTS REGARDING HB 2675 RELATING TO EMERGENCY MANAGEMENT

BEFORE THE HOUSE COMMITTEE ON CONSUMER PROTECTION AND COMMERCE FEBRUARY 9, 2018

Good afternoon Chairman Takumui, Vice Chair Ichiyama and members of the committee. For the record, my name is Chris Leonard and I am the President of the Hawaii Association of Broadcasters. The Association represents over 75 Television & Radio stations that serve local communities across the State of Hawai'i. I am providing these comments regarding HB 2675 on behalf of our Association.

Local broadcasters across the State of Hawaii have a duty to serve the public interest with emergency information, news, public affairs programming and entertainment. The Hawaii Association of Broadcasters is in agreement with you that timely communication of emergency messaging is of utmost importance to our Hawai'i residents and visitors. Furthermore, we are in agreement that it is imperative that the State Emergency Management Plan and State Emergency Alert Plan (EAS) require accessibility of programming providing emergency information as required by 47 CFR §79.2.

The intent of HB 2675 is currently addressed by federal regulation (47 CFR §79.2). This section requires "...video programming distributors must make emergency information, as defined in paragraph (a) of this section, that is provided in the audio portion of the programming accessible to persons with hearing disabilities by using a method of closed captioning or by using a method of visual presentation as described in §79.1..."

We would strongly recommend that you strike the portion of the bill that would duplicate and be preempted by 47 CFR §79.2 and rather focus on the rewrite of the State EAS Plan and revisions to the State of Hawai'i Emergency Operation Plan (Basic Plan dated May 2017) to make sure that the plans are compliant with Federal law and ensure that there are provisions in the plan to address the hearing and visually impaired communities. The State EAS Plan controls the use of the EAS system by state and county official and defines the operational procedures for its' use. The plan is currently being addressed by the State Emergency Communications Committee (SECC) which is comprised of Emergency Management officials, broadcasters and other private industry stakeholders. The final revised plan must be reviewed and approved by the Federal Communications Commission (FCC).

We ask you to consider language similar to the following to best achieve the goals of HB 2675:

The State EAS Plan and State Emergency Management plans shall be revised to be compliant with all Federal Communications Commission (FCC), Department of Homeland Security (DHS) / Federal Emergency Management Agency (FEMA) requirements for emergency alerting and broadcasts including compliance with 47 CFR §79.2 ensuring accessibility of programming providing emergency information.

We are committed to working with you to make sure that we have plans in place that protect all Hawai'i residents and visitors including those with hearing disabilities and to ensure that emergency managers and tv and radio broadcasters roles in emergency broadcast situations are clearly defined.

Testimony in *support* to House Bill 2675 – Relating to Emergency Management

My name is Peggy Liang. I am presenting this testimony as an individual in favor of HB 2675, which require requires each local television station to make emergency information that is provided in the audio portion of its video programming accessible to persons with hearing disabilities by using a method of closed or open captioning.

From my personal experience on January 13, 2018: I was completely lost when I got the alert on my phone and I had to rely on other people for further information based on one alert. Later, I found the live stream related to the public announcement and it was not captioned. Having it on the television would benefit the audience as any possible outlet including those people with English as a second or foreign language. Hawaii is the most diverse state with flourished international visitors coming in for vacation.

The bottom line is that the passage of House Bill 2675 will provide effective communication access on the television for the Deaf, Hard of Hearing and Deaf Blind.

I strongly urge the Committee to pass this bill, which will bring the safety among the residents and visitors with equal and effective communication access.
