TESTIMONY TO THE HOUSE COMMITTEE ON PUBLIC SAFETY

House Bill 2675 - Relating to Emergency Management

The Disability and Communication Access Board (DCAB) supports the intent of House Bill 2675 to require each local television station to make emergency information that is provided in the audio portion of its video programming accessible to persons with hearing disabilities by using a method of closed or open captioning.

The importance of this bill is underscored by the events of the false missile alert on January 13, 2018. There were no captioned or interpreted announcements on television to inform the deaf and hard of hearing community that the alert was a false alarm, nor were there any captioned or interpreted press conferences, interviews, or explanations after the false alarm. Persons with hearing disabilities are entitled to receive the same timely information from the media.

While we support the intent of the bill, we would like to offer technical comments regarding the wording of the bill. It should be noted that captioning of video programming does not automatically make the information equally accessible to all persons with hearing disabilities. Additional requirements, such as live American Sign Language (ASL) interpretation, will increase the number of individuals that are afforded effective communication during emergency broadcasts. This is important to note because a significant number of individuals with a hearing disability graduate high school without the reading proficiency needed to effectively understand written emergency announcements.

My name is Peggy Liang. I am presenting this testimony as an individual in favor of HB 2675, which require requires each local television station to make emergency information that is provided in the audio portion of its video programming accessible to persons with hearing disabilities by using a method of closed or open captioning.

From my personal experience on January 13, 2018: I was completely lost when I got the alert on my phone and I had to rely on other people for further information based on one alert. Later, I found the live stream related to the public announcement and it was not captioned. Also, the American Sign Language interpreter was not displayed to give the Deaf community, effective communication access. I suggest you to consider adding the interpreter on the site to widen the audience including those people with English as a second or foreign language. Hawaii is the most diverse state with flourished international visitors coming in for vacation.

The bottom line is that the passage of House Bill 2675 will provide effective communication access on the television for the Deaf, Hard of Hearing and Deaf Blind.

I strongly urge the Committee to pass this bill, which will bring the safety among the residents and visitors with equal and effective communication access.

Thank you for the opportunity to provide written testimony on House Bill No. 2675, relating to HEMA and broadcasting emergency information in closed or open captioning for the benefit of the hearing-impaired. The OCC Legislative Priorities Committee is in favor of House Bill No. 2675and support its passage.

House Bill No. 2675, is in accord with the Platform of the Democratic Party of Hawai'i ("DPH"), 2016, as it requires each local television station to make emergency information that is provided in the audio portion of its video programming accessible to persons with hearing disabilities by using a method of closed or open captioning.

Specifically, the DPH Platform states, "[t]he inherent dignity and equal and inalienable rights of all human beings are the foundations of freedom, justice, and peace. We support affirmative action, the full implementation of the Civil Rights Acts of 1964 and 1990 and the Americans with Disabilities Act of 1990." (Platform of the DPH, P. 3, Lines 158-161 (2016)).

Given that House Bill No. 2675 requires HEMA to broadcast emergency information in closed or open captioning for the benefit of the hearing-impaired, it is the position of the OCC Legislative Priorities Committee to support this measure.
