Testimony of SUZANNE D. CASE Chairperson

In consideration of HOUSE BILL 430 RELATING TO THE DIAMOND HEAD STATE MONUMENT

House Bill 430 proposes to authorize the issuance of general obligation bonds for the planning, design, and construction of a visitor and interpretive center at Diamond Head State Monument (DHSM) and requires the Department of Land and Natural Resources (Department) to seek funds. **The Department supports this measure and offers the following comments.**

Diamond Head State Monument (DHSM) is one of the icons that represent Hawaii around the world. DHSM is a branded image that appears in countless advertisements, photos, social media, and products. It is the definitive and most recognizable backdrop to Waikiki. Visitation in 2015 was at 901,136 and in 2016 up 10% to 1,025,318 visitors, which averages to about 3,000 per day.

The Department, through the Division of State Parks, has been engaged in discussions regarding the critical need for a visitor interpretive center at DHSM for a number of years. More recently, due to new opportunities, there have been robust discussions with the Department of Defense, Hawaii Emergency Management Agency, the DHSM Citizens Advisory Council and other agencies that utilize DHSM for a variety of management functions. There is an existing framework via the DHSM Master Plan Update (2003) to move forward on the planning elements, which include permitting and Chapter 343 HRS compliance, along with architectural designs that would be the basis of determining the cost of construction. The Updated Master Plan identified a couple of key interior locations as desirable for the construction of a visitor center.

Currently, the Department of Defense has plans and funding to demolish two existing and primary buildings on the crater floor within DHSM. While the Department may be interested in retaining one for park management, it is now timely and prudent to begin the planning and
