Good morning Chair Nishihara and Vice Chair Wakai, and members of the Committee:

I am Ron Han, Director of the State Office of Veterans Services. I appreciate this opportunity to provide testimony in support of House Concurrent Resolution 109 as long as its implementation does not impact or replace the priorities set forth in the Executive Budget.

According to the Federal Benefits for Veterans, Dependents and Survivor's Booklet (2012 edition), Chapter Nine (9) "Special Groups of Veterans"; World War II era Filipino Veterans are eligible for certain VA benefits. Generally, Old Philippine Scouts are eligible for VA benefits in the same manner as U.S. Veterans. Commonwealth Army Veterans, including certain organized Filipino guerilla forces and New Philippine Scouts residing in the United States who are citizens or lawfully admitted for permanent residence are also eligible for VA health care in the United States on the same basis as U.S. Veterans. Certain Commonwealth Army Veterans and new Philippine Scouts may be eligible for disability compensation and burial benefits. Other Veterans of recognized guerilla groups also may be eligible for certain VA benefits. Survivors of WW II era Filipino Veterans may be eligible for dependency and indemnity compensation. Eligibility and rates of benefits vary based on the recipient's citizenship and place of residence.

#### Re: H.C.R. No. 109

The Hawai'i Civil Rights Commission (HCRC) has enforcement jurisdiction over Hawai'i's laws prohibiting discrimination in employment, housing, public accommodations, and access to state and state funded services. The HCRC carries out the Hawai'i constitutional mandate that no person shall be discriminated against in the exercise of their civil rights. Art. I, Sec. 5.

The HCRC strongly supports H.C.R. 109, Urging the President of the United States and the United States

Congress to Grant Full Veterans Benefits to Filipino Veterans Who Fought in WW II But Were Subsequently Denied
the Benefits to Which They Were Entitled.

These resolutions ask the United States in efforts to pay a debt of gratitude and justice, attempting to remedy a history of injustice, broken promises, and discriminatory treatment suffered by a now dwindling generation of heroic Filipino Veterans who served under US command, were promised citizenship and veteran's benefits, and to this day continue to suffer the consequences of broken promises and belated remedies.

During WWII, members of the Philippine Armed Forces served in the US Armed Forces in the war against Japan. They were among a broader class of non-citizens serving in the US Armed Forces who were offered veterans benefits and naturalization as part of the 1942 enactment of the Second War Powers Act, however many were denied the ability to naturalize, as well as veterans benefits, such as health care, disability pensions and burial expenses..

With the enactment of the Rescission Act in 1946, these Filipino Veterans who served under US Command

were singled out and denied full and equal veterans status and benefits given to others.

Those who fought with American troops deserve full benefits, however belatedly. Much of that generation has already passed, and this resolution seeks to right a wrong that it may soon be too late to remedy.

The HCRC strongly supports H.C.R. 109, which asks the U.S. Congress to grant full veterans benefits to Filipino WW II veterans.

We honor the service of all of our military members." (Platform of the DPH, P.8, Lines 530-534 (2016)).
