Thank you for the opportunity to testify on SB1208 SD2. I support the bill to issue special purpose revenue bonds to assist Twin Bridge Farms in purchasing TMK 6-7-001:026. The parcel is 281 acres and is located at 67-421 Farrington Highway Waialua, HI 96791.

Twin Bridge Farms was founded in 1998 and is currently a 250-acre operation in Waialua that produces primarily asparagus along with seed corn, sunflowers, and potatoes for consumption and seed. It is part of a group of farms that established diversified agriculture on the North Shore after Waialua Sugar shut down in the mid-1990s. Our asparagus and potatoes can be found in local restaurants and supermarkets across the State.

The new parcel represents an opportunity to expand our operation and move into larger scale potato production. The new operation will employ 8-10 new employees and the potatoes will be distributed through our current distribution channels.

Thank you again for considering SB1208 SD2. The added local production will go a long ways towards the State's goal of doubling food production.
