Aloha Chair Inouye, Vice Chair Espero, and Members of the Committee on Transportation and Energy,

Mahalo nui loa for your kind consideration of SB 2004, which authorizes the issuance of general obligation bonds for appropriation to the Department of Transportation to complete the construction and installation of a signalized crosswalk on Vineyard boulevard at River Street.

My name is Kehaulani Lum, and I am an active Board member of Lum Sai Ho Tong (LSHT), a 129-year-old Chinese cultural treasure on River Street. Every year, our historic Tin Hau Temple, one of the last Taoist ritual temples in Hawai'i, welcomes thousands of members and visitors from Hawai'i and around the world, all advancing the preservation of Chinese cultural traditions.

With your previous approval of the installation of a signalized crosswalk at the mauka end of River Street, you have ensured the safety, well being and accessibility of LSHT and Chinatown's residents and visitors, most of whom travel by foot along the River Street corridor. Safe and direct access across busy Vineyard Boulevard that improves the connection between the north and south ends of Chinatown, including the Sun Yat Sen pedestrian mall, is needed because there are popular destinations on both sides of the street, and the area demographics include a high number of people who are elderly or have impaired mobility.

This measure requests additional funds to support Department of Transportation Project Number 98A-01-15, to construct and install the crosswalk on our heavily used pedestrian thoroughfare. Due to increased construction costs in the intervening years since the Legislature first approved the crosswalk, an appropriation of an additional \$352,800 is needed to complete this project.

This amount pales in comparison to the potential harm and liability of even one person being injured, without the signalized crosswalk; a situation which you have had the excellent foresight to prevent. We are most grateful.

Thank you, again, for your serious consideration of SB 2004 and for your dedicated concern for the safety of our people.
