The Peace, Justice, and Stewardship of the Environment Committee of the Church of the Crossroads acts out of Christian principles to advance peace, social justice, and environmental preservation in our communities and the world.

The number of gun deaths in the U.S. has increased in recent years. It is alarming that the number of mass shootings has escalated to the level that there is, on average, nearly one mass shooting each day in our country. The media report on the most horrific of these, such as those in Las Vegas, Parkland, Sandy Hook, and Orlando, but there are many more that most people are not even aware of.

America is suffering from rampant gun violence, and aggressive steps must be taken to control it. Fortunately, Hawaii has strict gun laws that have been successful at limiting gun violence in our communities. In fact Hawaii has been raised as a model for other states. Still, more can be done.

The purchase of fully automatic weapons has been severely restricted in the U.S. since the 1930's. Semi-automatic rifles, which are legal, require one trigger pull for each round fired. However, the invention of bump-stocks transforms semi-automatic rifles so that they simulate fully automatic rifles that can fire at a rate of 400 to 800 rounds per minute with one trigger pull. The Las Vegas gunman who killed 59 people and wounded hundreds more had two bump-stocks.

This bill prohibits bump stocks and other mechanisms that transform semi-automatic rifles to simulate fully automatic rifles. It is a common-sense response to new technology that unnecessarily makes guns even more deadly than they already are.

For the foregoing reasons, the Peace, Justice, and Stewardship of Creation Committee of the Church of the Crossroads supports this bill and urges the committee to pass it.
