TESTIMONY ON SENATE BILL 2047, SENATE DRAFT 1 RELATING TO PUBLIC SAFETY

Chair Dela Cruz, Vice Chair Keith-Agaran, and Members of the Committee:

The Department of Public Safety (PSD) **opposes** Senate Bill (SB) 2047, Senate Draft (SD) 1 and asks that it be deferred in lieu of other immediate prosecutorial and compliance oversight agency reviews.

The allegations raised by the originators of this bill are serious in nature and deserving of criminal and administrative review immediately, rather than via the long timeline associated with the enactment of a statute, the eventual implementation of an audit, to be followed, thereafter, by the publication of the audit findings.

The bill's originators allege criminal behavior. Such criminal behavior should be immediately reported to the Office of the Attorney General (AG) and the Federal Bureau of Investigation (FBI).

The bill's originators allege Civil Rights Compliance violations. Such violations should be immediately reported to the AG for criminal investigation and the State Civil Rights Compliance Office for administrative investigation.

The bill's originators allege personnel management violations. Such violations should be immediately reported to the AG for criminal investigation

and to the Department of Human Resources Development (DHRD) for administrative investigation.

The bill's originators allege fiscal and procurement violations. Such violations should be immediately reported to the AG for criminal investigation and to the Department of Accounting and General Services (DAGS), as well as, the State Procurement Officer (SPO) for administrative investigation.

The bill's originators allege gross ethical violations. Such violations should be turned over to the AG for criminal investigation and to the State Ethics Commission for administrative investigation.

Overwhelmingly and as meticulously documented in PSD's 2018 annual Report to the Legislature, required by Act 144, Session laws of Hawai'i 2007, mental health services to inmates have been dramatically improved since programmatic failures in the provision of these services were identified in April/May of 2017.

The Department does not and would not object to or resist the State Auditor being tasked with the kind of overall or targeted audit in which Executive departments regularly participate. Noting the testimony of the Auditor's Office on SB 2047 to the Senate Committee on Public Safety, Intergovernmental, and Military Affairs on February 13, 2018, PSD respectfully requests that if the Committee on Ways and Means determines that an audit shall be conducted, that the Committee focus the scope of the requested audit to topics that are conducive to auditing. As previously mentioned in this testimony, many allegations raised by the originators of this bill fall under the jurisdiction of other offices or agencies.

It is for these reasons and others that PSD respectfully asks that this bill be deferred and that the underlying serious allegations be immediately assigned to appropriate law enforcement and compliance oversight agencies responsible for investigations of such allegations.

S.B. NO. 2047, S.D. 1, RELATING TO PUBLIC SAFETY

Hearing: Wednesday, February 28, 2018, 11:00 a.m.

The Office of the Auditor has **no position** regarding S.B. No. 2047, S.D. 1, which requires us to conduct a performance audit of various offices and programs within the department of public safety. **However, we offer the following comments.**

Some portions of the work called for by the bill may be beyond our expertise and require us to procure a consultant to assist us in performing the audit. We note and appreciate that the bill does include an appropriation, which can be used to retain an appropriate consultant.

The bill would also require us to submit an "interim report" twenty days prior to the convening of the 2019 regular session. Our office would be unable to do an "interim" report beyond a general status update. Our audit process is such that we do not discuss preliminary findings or the draft report with anyone other than the agency being audited. We do so to afford the auditee the opportunity to provide additional facts, explanations, or clarifications so that we can confirm or revise our assessment(s). Audit standards prevent us from otherwise disclosing any findings until our work is complete and all findings and recommendations have been thoroughly verified and made final.

We also request that the committee significantly narrow the scope of the requested audit, both the offices to be audited as well as the programs and activities to be assessed. Although the bill requires a final audit report before the 2020 regular session, given our resources and the other work we need to do on an ongoing basis, it will be difficult to provide a meaningful report on all of the issues contained in the bill.

STRONG SUPPORT FOR SB 2047 SD1 - AUDIT OF DEPT. OF PUBLIC SAFETY

Aloha Chair Dela Cruz, Vice Chair Keith-Agaran and Members of the Committee!

My name is Kat Brady and I am the Coordinator of Community Alliance on Prisons, a community initiative promoting smart justice policies in Hawai`i for more than two decades. This testimony is respectfully offered on behalf of the families of ASHLEY GREY, DAISY KASITATI, JOEY O`MALLEY, JESSICA FORTSON AND ALL THE PEOPLE WHO HAVE DIED UNDER THE "CARE AND CUSTODY" OF THE STATE as well as the approximately 5,500 Hawai`i individuals living behind bars or under the "care and custody" of the Department of Public Safety on any given day. We are always mindful that approximately 1,600 of Hawai`i's imprisoned people are serving their sentences abroad thousands of miles away from their loved ones, their homes and, for the disproportionate number of incarcerated Kanaka Maoli, far, far from their ancestral lands.

SB 2047 SD1 requires the Auditor to conduct a performance audit of certain offices and programs within the Department of Public Safety. Appropriates funds. (SD1)

One of the things that the community has always asked for is that the same level of accountability be applied to the department that the state demands from people in their "care and custody". We fail to understand why a department that incurs incredible liability to taxpayers is allowed to be unaccountable. The department stands on its testimony in public hearings (and doesn't even say if it supports or opposes the measure) and is rarely questioned at hearings. Why is this?

Transparency and accountability are vital to a vibrant democracy. It is insulting to taxpayers when we testify on bills without knowing the position of the department beforehand and then at the hearing the department does not, and generally is not, asked to speak.

This audit will hopefully shed some independent light on this department that is responsible for the lives and health of the people in their "care and custody" as well as for those who work in their facilities.

Community Alliance on Prisons urges the committee to support this important audit that we hope will provide the information that legislators need in order to develop thoughtful and sound policies that serve the public interest. Mahalo for hearing this bill and for the opportunity to testify.
