<u>**DEPARTMENT'S POSITION**</u>: The Department of Human Services (DHS) appreciates the intent of this measure, and offers comments.

<u>PURPOSE</u>: The purpose of the bill is to require the Department of Human Services (DHS) to implement an earned income disregard program as an intermediate step to implementing a full Medicaid buy-in program.

This is similar to SCR 8 (2017) that expressed legislative support for implementing an earned income disregard as an interim step to implementing a full Medicaid Buy-in program. The Medicaid Buy-In task force, which DHS Med-QUEST division (MQD) has participated in since its inception, has been working to implement a Medicaid Buy-In program in Hawaii. However, despite several bills to implement, the program was not funded and thus, not implemented.

For that reason, the task force recommended taking the interim step of MQD implementing another earned income disregard that would allow individuals with disabilities to earn income and not lose their Medicaid benefits, which they would be at risk of given current Medicaid eligibility rules. While this interim program would not provide the full benefits of a Buy-in program, such as also disregarding the assets of the individual, it would

increase the amount of income an individual could earn while retaining Medicaid eligibility, which would be a positive step.

In our analyses of implementing the interim step, the primary impact would be to help current Medicaid beneficiaries to become more self-sufficient. While there may be new individuals who would gain coverage with this change, at this time the estimated increase would be covered within the projected population increases. Therefore, no additional appropriation is requested at this time.

SB2050 SD2 also has MQD reporting back on the impact of implementing the income disregard as well as annually evaluating the feasibility of implementing a full Medicaid Buy-In program. We are also encouraged to work with the University of Hawaii's Center on Disability Studies. Although this would add to the administrative requirements, it would be feasible for us to do this.

SUBJECT: SB 2050 SD2 – Relating to Persons with Disabilities

The State Council on Developmental Disabilities (DD) **SUPPORTS SB 2050 SD2.** The purpose of the bill is to require the Department of Human Services to implement an earned income disregard program as an intermediate step to implementing a Medicaid buy-in program.

Act 200, Session Laws of Hawaii 2012, established a joint legislative Task Force to assist in exploring the development and possible implementation of a MBI program for working individuals with disabilities based on Hawai'i's current Medicaid income and asset limits subject to approval by the Federal Centers for Medicare and Medicaid Services. The Task Force was convened by Senator Suzanne Chun Oakland and the late Representative Mele Carroll. The Council is a member of the Task Force and has been engaged in discussions on establishing and implementing a MBI program for individuals with disabilities. The Task Force was in general agreement that the MBI program was a viable option to pursue to enable workers with disabilities to be employed while protecting them from losing their medical benefits and supports.

In 2015, the Task Force continued to meet to discuss various options on implementing a MBI program. One option that the Task Force fully supported and encouraged was for the DHS Med-QUEST Division (MQD) to submit a budget request for funds to start the MBI program.

In 2016, DHS MQD submitted an Executive supplemental budget request of \$293,405 in general funds with Federal Medicaid matching funds of \$344,155 for a total of \$637,560 to implement the MBI program. The request was included in the 2016 State budget bill (HB 1700 - Relating to the State Budget), under Program ID HMS

401/PE- Add funds for Ticket to Work Medicaid State Plan Services. Unfortunately, this did not transpire.

In 2017, DHS MQD was not able to implement an Earned Income Disregard program as un interim measure.

According to the National Disability Navigator Resource Collaborative, Hawai'i is one of four states without a Medicaid Buy-in program. We are in strong support of Medicaid buy-in program for the State of Hawai'i.

We appreciate the Legislature's past involvement with the Task Force and perseverance in addressing options for individuals with disabilities to become employed and maintain their access to Medicaid.

Thank you for the opportunity to submit testimony in support of SB 2050 SD2.

Good morning, my name is Melodie Aduja. I serve as Chair of the Oahu County Committee ("OCC") Legislative Priorities Committee of the Democratic Party of Hawaii. Thank you for the opportunity to provide written testimony on **SB2050 SD2** relating to Medicaid; Earned Income Disregard Program; and the Deaf and Blind Task Force.

The OCC Legislative Priorities Committee is in favor of **SB2050 SD2** and support its passage.

**SB2050 SD2** is in accord with the Platform of the Democratic Party of Hawai'i ("DPH"), 2016, as it requires the department of human services to implement an earned income disregard program as an intermediate step to implementing a medicaid buy-in program; requires reports to the legislature; and takes effect upon approval by the Centers for Medicare and Medicaid Services.

Specifically, the DPH Platform states, "We seek programs that prepare people with disabilities for independent and productive lives. We are committed to the elimination of glass ceilings that prevent women and minorities from advancing to the highest levels of government, education and business." (Platform of the DPH, P. 3, Lines 143-145 (2016)).

Given that **SB2050 SD2** requires the department of human services to implement an earned income disregard program as an intermediate step to implementing a medicaid buy-in program; requires reports to the legislature; and takes effect upon approval by the Centers for Medicare and Medicaid Services, it is the position of the OCC Legislative Committee to support this measure.
