Title of Bill: SB 2051 RELATING TO EDUCATION.

Purpose of Bill: Permits individual department of education schools and career

pathways, academies, or programs operated within a department of education school, to engage in commercial enterprises, including the sale of goods produced by or for an individual school, career pathway,

academy, or program.

Department's Position:

The Department of Education (Department) supports S.B. 2051 which would allow an individual department school or any career pathway, academy, or program operated within a school, to engage in commercial enterprises that are related to their primary educational purposes, including the sale of goods produced by or for an individual school, career pathway, academy, or program.

The Department's Community Engagement Office (CEO) is charged with the responsibility of stewarding Connect 2 Careers (C2C), a statewide partnership formed to build, measure, and scale high-quality work-based learning experiences for students which align with local, county, and state economic and labor market needs.

S.B. 2051 aligns with the Department's Strategic Plan for student success in college, career, and citizenship. This measure will enhance the rigor and relevance of work-based learning throughout the P-20 continuum as students engage in comprehensive, real-world immersive experiences particularly in the areas of entrepreneurship and strategic commercial enterprise.

The Hawaii State Department of Education seeks to advance the goals of the Strategic Plan which is focused on student success, staff success, and successful systems of support. My name is Camille Hampton. I am a lifelong Wai'anae Resident and former business teacher at Wai'anae High School. I currently am a program coordinator for an Education Pathway Program at the University of Hawai'i at West O'ahu.

I am writing to request your support of SB2051. As a former business educator, having the ability to create relevant, real-world experiences for students was a critical component of effectively reaching students and helping them understand content. The amendment of Section 302A of the Hawaii Revised Statutes provides an opportunity for Career and Technical Education (CTE) programs within the DOE to expand and support hands-on learning experiences for students and allow programs to market products and services and deposit funds back into the program.
