Chairs Gabbard & Kahele, Vice Chairs Riviere & Kim and members of the Senate Agriculture and Environment and Higher Education, thank you for this opportunity to provide my personal testimony in **strong support of SB 2075** relating to the Sustainable and Organic Agriculture Program (SOAP) the University of Hawaii, at Manoa, College of Tropical Agriculture and Human Resources.

I strongly support this bill provided that its passage does not replace or adversely impact priorities as indicated in the University's Board of Regents Approved Executive Biennium Budget. Let me state from the onset of this testimony that, as a member of the faculty at the University of Hawaii at Manoa, it is important to note that I support the prioritization process that the administration utilizes to establish their annual budgetary request to the legislature and can only advocate for additional funding of university programs if it does not negatively impact existing requests that are included in the executive budget.

My name is Joshua Silva, and I am a Extension Agent at UH Manoa, College of Tropical Agriculture and Human Resources. Today, I am providing personal testimony.

The Sustainable and Organic Agriculture Program (SOAP) at the University of Hawaii at Manoa, College of Tropical Agriculture and Human Resources (UH CTAHR) remains committed to providing continuing education, in the form of agricultural professional conferences, growers workshops, field day activities, web based newsletters, applied field research in sustainable and organic agriculture, and in field technical support for agricultural professionals and producers across the state.

Although demand for organic farming systems and commodities are increasing, farming inputs to successfully grow marketable crops are limited compared to conventional systems. Thus, applied research in these areas are needed for organic and small farms to succeed. The SOAP team has addressed this need and conducted research into agricultural topics such as cover crops, local organic soil amendments, integrated pest management, beneficial insects, and variety trials for crop diversification and disease

resistance. SOAP shares its findings with the farming community and public through its online newsletter called Hanai `Ai, which has disseminated university and extension research to readers statewide for nearly 8 years. Each quarterly issue attracts 500 to 1000 readers. In addition to Hanai `Ai, SOAP also hosts numerous field days and conferences statewide for local farmers every year, showcasing and demonstrating sustainable practices and applied research projects like reflective mulch and screenhouses for pest and disease control.

The ability to continue and expand our applied research on farmland which includes CTAHR's certified organic lands, on farm field trials, dissemination of science based information delivery, and recruitment of field support positions are needed to fill immediate research and educational gaps and increase our ability to answer and respond to emerging and re-occurring issues in support of Hawaii's diversified agriculture industry.

I believe that bill SB 2075 has much merit. I strongly recommend that it be funded. Ongoing funding to support at CTAHR is crucial to the sustainability of Hawaii's diversified agriculture. Thank you for the opportunity to express our strong support for SB 2075.

As a certified organic producer on Hawaii island for the past 17 years, the one thing that has always been missing, especially in comparison to my native Oregon and my graduate studies in California, are Cooperative Extension Agents who can truly and directly advise regarding organic options and patterns.

Notably, how to best reach a conclusion which meets certification standards (and who to double check with in that regard), while also being cost-effective and not hurting the fragile unique Hawaii environment means Agents who are truly familiar with tropical/Hawaiian agriculture and are looking out not only for the financial "bottom line" but equally the environmental impact of decisions made.

Since Hawaii imports such a significant percentage of produce consumed here at this time, it is vital that what is produced here is not destroying the environment and the health of farmers and farm families, aside from farm workers/employees.

That all said, it is with great pleasure and encouragement that I encourage you to fully support having more Extension Agents who can work with farmers and also pursue research to be making wise decisions and providing the best advice. While there has been some of this over the years, notably through efforts of folks such as Ted Radovich, it has been minimal compared to what is needed and Hawaii island has 60% of the farms in the state and has not had a continuous and readily available person with such skills and expereince for some time, and this fudning would allow the needed efforts to take a strong step forward to meet needs and to maintain healthier needs organic farmers address.
