To the Honorable Rosalyn H. Baker, Chair; the Honorable Jill N. Tokuda, Vice-Chair, and Members of the Committee on Commerce, Consumer Protection and Health:

Good afternoon. My name is Melodie Aduja. I serve as Chair of the Oahu County Committee ("OCC") Legislative Priorities Committee of the Democratic Party of Hawaii. Thank you for the opportunity to provide written testimony on Senate Bill No. 2110 SD1, relating to Hazardous Waste; Household Used Motor Oil; and Retail Automotive Parts Stores.

The OCC Legislative Priorities Committee is in favor of Senate Bill No.2110 SD1 and support its passage.

(Platform of the DPH, P. 8, Lines 407-415 (2016)).

"We believe in the vigorous enforcement of our environmental laws and increased public-private stewardships and citizen involvement in protecting our resources." (Platform of the DPH, P. 8, Lines 432-433 (2016)).

Given that Senate Bill No. 2110 SD1 requires retail automotive parts stores with an existing oil collection and storage unit to accept household generated used motor oil for recycling or disposal; defines retail automotive parts store; and allows a retail automotive parts store to collect a fee for the actual cost of disposal or recycling, it is the position of the OCC Legislative Priorities Committee to support this measure.
