Chair Dela Cruz, Vice Chair Keith-Agaran, and members of the Senate Committee on Ways and Means.

The Office of Planning (OP) supports SB 2168, provided the appropriation does not replace or adversely impact priorities requested in the Executive Budget. SB 2168 would appropriate funds for grants-in-aid to the counties for the identification and mapping of agricultural lands for designation as important agricultural lands (IAL) by the State Land Use Commission (LUC), pursuant to Hawaii Revised Statutes (HRS) § 205-47. SB 2168 appropriates \$250,000 for Fiscal Year 2018-19, to be allocated equally among the four counties.

Funding would facilitate completion of the county IAL mapping process and possibly accelerate the timeframe for submittal of county petitions for IAL to the LUC. However, it is our understanding that the County of Kauai has completed their mapping studies and does not anticipate petitioning for the designation of additional IAL lands beyond what has already been designated under the voluntary petition process. The City and County of Honolulu is also nearing the completion of its identification and mapping process, and maps of proposed IAL are currently undergoing public review and comment prior to submittal to the Honolulu City Council.

This raises the question of whether grants-in-aid to the County of Kauai and the City and County of Honolulu would be allowed for reimbursement for work that has been completed. This may need to be clarified in the measure.

Thank you for this opportunity to comment on SB 2168 dealing with Important Agricultural Lands.

The County of Hawai'i's General Plan and various Community Development Plans have goals, objectives, and policies consistent with preserving viable and productive agricultural land for farming and ranching. This County supports the intent of IAL, and any funding assistance from the state is welcomed, but offer some concerns and suggested amendments to SB 2168.

There are a number of issues that will not be resolved by this bill at its proposed funding level:

- The County of Hawai'i has more than 1.2 million acres designated as state land use (SLU) agriculture, far more than any other county (followed by Maui having just over 400,000 acres on its three islands).
- With other critical priorities in play, this County does not foresee having the staff, funds, or capacity in the coming years to initiate the IAL study and extensive landowner and public outreach required by Act 183, especially given the size of our island.
- Pursuant to HRS 205-45, Landowners can, at any time in the process, file a petition and lock out the county proceedings, thereby rendering moot any analysis, time, and expense already incurred by the counties.

During Hawai'i County's last General Plan review in 2005, we took information from a study being done by USGS, which was an initial effort in the direction of identifying IAL, but it did not include the level of research required for true IAL based on Act 183 and was not intended to substantiate going public with a petition to the LUC. In consideration of the above, we request amendments to SB 2168 regarding the following:

- 1. The preamble of SB 2168 talks about identifying IAL "within sixty months of receipt of state funds." The sixty month timeframe was called for in Act 183 (2005) but should be deleted; or if it must remain, triggered by petition of a county to the state to accept the funds, which must be approved by the appropriate County Council.
- 2. While any state contribution to the IAL effort is always welcomed, the amount of money proposed in SB 2168 would be only a fraction of what is needed statewide. In consideration of what the other counties have spent on their IAL efforts, we respectfully request that the total sum be increased to at least \$2 million.
- 3. Although evenly splitting the funds among the counties may appear equitable, the cost of such a study is tied more closely to the amount of land studied and the number of parcels/landowners that will require review, consultation and coordination. We thereby request that you consider dividing the funds based on a percentage of state land use agriculture lands in each county, rather than dividing them equally. We would add that, to be fair, we would support the use of appropriated funds to reimburse the other counties for IAL efforts they have concluded or currently have in process.



LURF's mission is to advocate for reasonable, rational and equitable land use planning, legislation and regulations that encourage well-planned economic growth and development, while safeguarding Hawaii's significant natural and cultural resources, and public health and safety.

LURF appreciates the opportunity to express its **support of SB 2168** and of the various agricultural stakeholder groups who defend the goals of viable agricultural operations and the conservation and protection of agriculture, including IAL in Hawaii. As noted in HRS Section 205-41, the intent of Act 183 (2005) was to develop agricultural incentive programs to promote agricultural viability, sustained growth of the agricultural industry, and the long-term use and protection of important agricultural lands for agricultural use.

Passage of the long-awaited IAL legislation would be pointless without complete implementation of the law which is intended to provide programs, incentives and inducements, and which requires the cooperation and support of agricultural, business, and educational organizations, as well as government agencies in order to become fully-realized.

LURF members include private property owners, farmers and ranchers who own, maintain, and engage in agricultural enterprises, and who consider the identification and assured availability of IAL critical to the continued conduct of their operations and to help sustain and preserve their businesses into the future. Chair Dela Cruz and Members of the Senate Committee on Ways & Means:

I am Paul Oshiro, testifying on behalf of Alexander & Baldwin, Inc. (A&B) on SB 2168, "A BILL FOR AN ACT RELATING TO IMPORTANT AGRICULTURAL LANDS." We support this bill.

After over twenty five years of debate, negotiation, and compromise, the IAL Law and process was finally enacted in July 2008. After years of pursuing a land-use approach to this constitutional mandate, the IAL Law that was successfully passed (Act 183 (2005) and Act 233 (2008)) was premised on the principle that the best way to preserve agricultural lands is to preserve agricultural businesses and agricultural viability. As such, the IAL Law not only provides the standards, criteria, and processes to identify and designate important agricultural lands to fulfill the intent and purpose of Article XI, Section 3 of the Hawaii State Constitution, it also provides for a package of incentives designated to support and encourage sustained, viable agricultural activity on IAL.

The IAL Law presently authorizes the identification and designation of IAL in one of two ways --- by voluntary petition to the State Land Use Commission by the landowner or farmer; or subsequently by the Counties filing a petition to designate lands as IAL pursuant

to a County identification and mapping process. In either case, the LUC determines whether the petitioned lands qualify for IAL designation pursuant to the standards, criteria, objectives, and policies set forth in the IAL Law. To date, the voluntary petition process has resulted in the designation by the LUC of over 130,000 acres of agricultural lands as IAL from voluntary petitions by Alexander & Baldwin, Parker Ranch, Castle & Cooke, Mahaulepu Farm, Grove Farm, Monsanto, the Robinson Family, and Kamehameha Schools.

This bill provides grants in aid to the Counties for the identification and mapping of IAL. With the voluntary petition process already providing a significant amount of IAL throughout Hawaii, this appropriation will assist the Counties in fulfilling the second method of IAL designation, which will be initiated by the County identification and mapping of IAL. When completed, these County maps will be forwarded to the LUC which will enable them to designate qualified lands as IAL.

Based on the aforementioned, we respectfully request your favorable consideration on this bill. Thank you for the opportunity to testify.
