TESTIMONY ON SENATE BILL NO. 2326, RELATING TO TOWING.

TO THE HONORABLE LORRAINE R. INOUYE, CHAIR, AND MEMBERS OF THE COMMITTEE:

The Department of Commerce and Consumer Affairs ("Department") appreciates the opportunity to testify on S.B. 2326, Relating to Towing. My name is Stephen Levins, and I am the Executive Director of the Department's Office of Consumer Protection. The Department supports this bill and offers the following comments.

This bill adds a new section to Hawaii Revised Statutes ("HRS") chapter 291C, the Statewide Traffic Code, to: (1) prohibit towing companies from towing a vehicle parked in a parking stall that would require a person to pay for parking at a ticket issuing machine if the ticket issuing machine is inoperable; and (2) define "ticket issuing machine."

For most drivers, having a car towed can be a stressful and costly event because of the expense and inconvenience of retrieving a towed vehicle from a towing company's base yard. Hawaii's towing statute, HRS section 290-11, informs vehicle owners of their rights when their car is towed by regulating: (1) the parking restriction signage requirements for private and public properties; (2) the maximum fees a towing

company can charge a vehicle owner for towing, difficult hook-ups, and storage; (3) the payment methods a towing company must accept; and (4) the notice requirements a towing company must follow when it tows and returns a vehicle. Since section 290-11 regulates towing, the Department respectfully submits that section is a more appropriate placement for the provisions of this bill.

The new section proposed in this bill enhances consumer protection by prohibiting a towing company from towing a vehicle if a ticket issuing machine is not working and by minimizing illegal tows. Consumers should not be towed when there is no evidence their vehicle has parked longer than authorized.
