Thank you for considering this bill, which provides a path towards recognizing that the medical use of cannabis in Hawaii is currently accepted medical use in treatment in the United States, which means that our Medical Use of Cannabis Program does not violate federal law.

Given the perilous position that has been created by failing to address this misconception that our program violates federal law, further immediate steps are necessary to protect our patients and dispensaries.

Please consider the following amendment to this bill:

SECTION 3. In the meantime, Section 329-14, Hawaii Revised Statutes, is amended by adding the following subsection:

(f) The enumeration of cannabis, tetrahydrocannabinols or chemical derivatives of these as Schedule I controlled substances does not apply to the medical use of cannabis pursuant to Section 329, Part IX, and Section 329D, Hawaii Revised Statutes.

Please note that Guam has the same clause in their UCSA. See page 11, Section 2 of The Joaquin Concepcion Compassionate Cannabis Use Act of 2013.

I am Captain Phillip Johnson of the Narcotics/Vice Division of the Honolulu Police Department (HPD), City and County of Honolulu. The HPD opposes Senate Bill No. 2407, S.D. 1, H.D. 1, Relating to Medical Cannabis.

This bill seeks to allow the medical use of cannabis for the treatment of opioid addiction. substance abuse, and withdrawal symptoms resulting from the treatment of those conditions. There is not enough research so show the efficacy of using cannabis to treat opioid use disorders, and it switches out one addiction for another. This will need to be thoroughly researched before treating such a problem.

The fact remains that the Food and Drug Administration has not approved marijuana for medical use. Doctors who are prescribing medical marijuana to qualifying patients do not actually know which formulations or which dosing to give for specific symptoms or disorders.

The HPD urges you to oppose Senate Bill No. 2407, S.D. 1, H.D. 1, Relating to Medical Cannabis.
