SUBJECT: Senate Bill No. 2436, Relating to Firearms

I am David Nilsen, Captain of the Records and Identification Division of the Honolulu Police Department (HPD), City and County of Honolulu.

The HPD supports Senate Bill No. 2436, Relating to Firearms, as it will shorten the time period that a disqualified firearms owner has to voluntarily turn in their firearms.

This bill amends subsection (b) of Hawaii Revised Statutes Section 134-7.3 by shortening the time period for the voluntary surrender of firearms upon disqualification from ownership, possession, or control of firearms from 30 days to an unspecified number of hours. The HPD urges that these changes also be made to subsection (a) to allow uniformity and consistency through the entire section.

The HPD supports Senate Bill No. 2436, Relating to Firearms.

Hawaii currently has strong, sensible gun laws that help protect our citizens from the horrors of gun violence. Yet a loophole exists in Hawaii law which allows convicted felons, domestic abusers and others with violent history to keep their dangerous firearms for 30 days until law enforcement can intervene. Most states specifiy that convicted domestic abusers give up their guns within 24 hours. This is exactly what Hawaii needs to do. Giving violent people a month to hold onto their weapons could certainly lead to more violence and possible death, especially in the case of domestic abuse. States that have 24 hour reliquish laws see a 14% lower rate of partner homicide. Pass this law and reduce gun violence. Make Hawaii safer for everyone.
