At times, these individuals will operate their vehicles in a reckless manner in eluding law enforcement by resisting a lawful order to stop the motor vehicle. These types of incidents serve to put both the law enforcement officers and the community in danger.

For these reasons and as a matter of deterrence from such behavior, we urge this committee to approve this legislation. Thank you for allowing the Hawai`i Police Department to provide comments relating to Senate Bill 2453.

Testimony of the Office of the Public Defender, State of Hawaii to the Senate Committee on Judiciary

February 2, 2018, 9:30 a.m.

S.B. No. 2453: RELATING TO THE HAWAII PENAL CODE

Chair Taniguchi and Members of the Committee:

This measure would create a new offense of resisting an order to stop a motor vehicle under unauthorized control, a class B felony. In addition, it would increase the penalty for the offense of unauthorized control of propelled vehicle (§708-836, H.R.S.) from a class C felony to a class B felony. The Office of the Public Defender strongly opposes both portions of S.B. 2453.

We understand the reason this measure was proposed – law enforcement safety and public safety. This legislature has an interest in the prevention of high speed chases with people in stolen vehicles, where there is potential for injury to our law enforcement officers and members of the public.

First, this bill will not have a deterrent effect on people fleeing law enforcement officers while evading arrest. People flee because they panic. It is a person's innate "fight or flight" reaction. A person driving a stolen vehicle will not stop to think about the offense of resisting an order to stop a motor vehicle under unauthorized control before choosing to disobey a police officer's order to stop the vehicle.

Second, this bill makes no provision for someone who unknowingly drives a vehicle without authorization from the "real" owner. For example, what if a woman is driving a friend or relative's car, mistakenly believing that the friend or relative is the vehicle's owner. Upon being told to stop by an officer, she chooses to continue driving until she finds a safe place to stop, like a store parking lot, or police station. Should this woman be charged with a class B felony? Should she have to await her day in court in custody, unable to post bail?

Third, we believe there are other offenses applicable to this situation that penalize defendants in an equal or more severe fashion than that which is proposed in this measure. If, while fleeing or resisting an order to stop a stolen vehicle, the driver hits a car occupied by a driver and/or other occupants. That person could be charged with criminal property damage in the first degree (§708-820, H.R.S), a class B felony. If someone is killed during a suspect's attempt to evade arrest in a stolen car, that person could be charged with manslaughter (§707-702, H.R.S), a class A felony or negligent homicide in the first or second degree (§707-702.5 & 707-703, H.R.S.). Negligent homicide in the first degree is a class B felony.

There are other offenses of ranging from misdemeanor to class C felonies that also address the concerns raised in this measure. If a person sustains serious bodily injury because of a suspect's attempt to evade arrest, he could be charged with negligent injury in the first degree (§707-704, H.R.S.), a class C felony. If a person sustains substantial bodily injury because of a suspect's attempt to evade arrest, he could be charged with negligent injury in the second degree (§707-705, H.R.S.), a misdemeanor.

Finally, in 2016, this legislature created the offense of resisting an order to stop a motor vehicle in the first degree (§710-1026.9, H.R.S.). A person commits the offense of resisting an order to stop a motor vehicle in the first degree if they intentionally disobey an order of a law enforcement officer to stop the vehicle and are intentionally fleeing or attempting to elude a law enforcement officer (§710-1026.9(1)(b)(i), H.R.S.). This offense is a class C felony.

While we believe this measure to be duplications, we would not oppose the insertion of the language of this bill into §710-1026.9, H.R.S. as subsection (iii). The statute, as amended, would read as follows:

[§710-1026.9] Resisting an order to stop a motor vehicle in the first degree. (1) A person commits the offense of resisting an order to stop a motor vehicle in the first degree if the person:

- (a) Intentionally fails to obey a direction of a law enforcement officer, acting under color of the law enforcement officer's official authority, to stop the person's motor vehicle; and
- (b) While intentionally fleeing from or attempting to elude a law enforcement officer:

- (i) Operates the person's motor vehicle in reckless disregard of the safety of other persons; or
- (ii) Operates the person's motor vehicle in reckless disregard of the risk that the speed of the person's vehicle exceeds:
- (A) The applicable state or county speed limit by thirty miles per hour or more; or
- (B) Eighty miles per hour or more, irrespective of the applicable state or county speed limit.

For purposes of this section, "the applicable state or county speed limit" shall have the same meaning as in section 291C-105.

- direction of a law enforcement officer, acting under color of the law enforcement officer's official authority to stop the vehicle; and
- (B) The person is operating the motor vehicle in violation of section 708-836.
- (2) Resisting an order to stop a motor vehicle in the first degree is a class C felony. [L 2016, c 231, §47]

We strongly oppose increasing the offense of unauthorized control of propelled vehicle from a class C to a class B felony. We talk about prison overcrowding, we talk about sentencing reform, but at the same time see attempts every year at increasing the severity of offenses, which directly contradicts efforts at reforming our criminal justice system. We believe the primary focus of this measure is the safety of law enforcement officers and members of the public, which we have addressed in our testimony and proposes amendment to this bill.
