Aloha,

As the County of Maui Abandoned Vehicles Administrator, I am writing to oppose HB 2442 and SB2479. The intention of the bill is understandable; however, in practice, the bill would negatively impact county abandoned vehicles programs, and ultimately, is not feasible. While it may be assumed that the intention is to remove vehicles from public eye within 10 days, the placement of the new language after the words "disposed of" is contradictory to other mandates within HRS Ch. 290. Counties are tasked with notification to owners, storage, and auction of vehicles, all of which require a minimum of 10 days to accomplish.

There are many reasons why counties would not have the ability to accomplish the proposed 10-day removal including but not limited to: non-timely submission of reports by police department, vehicles may need to be cleaned out of trash before tow, special equipment may need to be ordered for certain tows requiring special procurement and logistics, storage facilities may be inadequate, and realistically, the volume of abandoned vehicles that have been reported exceeds counties' ability to remove them within a 10-day period. To my knowledge, all of the counties' abandoned vehicles programs are understaffed and budgets are stretched to limits.

There are subsections of HRS Ch.290 that may be modified to increase counties' ability to remove some vehicles from public roadways more quickly; however, the particular mandate of HB 2442 and SB2479 is not practicable. I urge this body to reject this bill.

OPPOSITION TO SENATE BILL 2479, RELATING TO ABANDONED VEHICLES

TO: The Honorable Clarence K. Nishihara, Chair And Members of the Committee on Public Safety, Intergovernmental, and Military Affairs

The Honorable Lorraine R. Inouye, Chair And Members of the Committee on Transportation and Energy

As the Director of the city's department of customer service, it is my agency that is responsible to address abandoned vehicles on Oahu's roadways.

The City and County of Honolulu ("City") opposes S.B. No. 2479 requiring counties to remove and dispose of abandoned vehicles ("AV") on public roads within 10 business days. The removal of an AV is separate from the disposal process, both with varying rules and timelines.

Removal Process

The removal process is the primary concern. Once the vehicle is identified as abandoned, as outlined by section 290-1, Hawaii Revised Statutes (HRS), the City has imposed upon ourselves a 72 hour window for AVs to be removed from public streets. That is my target, and we are working every day to meet our own mandate but with severe frustration. Imposing a 10 day requirement will not help remedy the situation. The biggest frustration is a lack of space. There is less and less open land to lease on this island. Fewer landowners are willing to lease the lots they do have for the purpose of storing vehicles. EPA and environmental concerns make it costly. Our contractors are losing their current lots and are struggling to find additional lots to lease. But given sufficient land and space, perhaps with the assistance of the state, I am confident that AVs can be removed from public roads in under 10 days. What most affects space? It's the rate of disposal.

Disposal Process

Once taken into custody, section 290-2, HRS, requires that a written notice be sent to the registered owner on record allowing up to 20 business days for the vehicle to be claimed. Once that time has passed, section 290-3, HRS, mandates the vehicle be disposed of by public auction. The City conducts regular abandoned vehicle auctions monthly. Only if unsuccessfully auctioned can the City dispose of the vehicle.

In addition to this statutory timeline, beginning last year, we have been challenged with vehicles owned by military service members. In accordance with the provisions of 50 U.S.C. §551, Servicemembers Civil Relief Act, the City is prohibited from disposing of these vehicles without a waiver of release signed by the registered owner. We are required to locate the service member, majority of whom are no longer on island, to obtain the release. In the absence of a signed waiver, the City must seek a court order allowing disposal. All this is costly, time consuming, and consumes valuable space.

Now, imagine that the notification and auction process is complete and the military-related SCRA processing is satisfied. We now face a salvage challenge. The State Department of Health issued approvals of just five salvage sites capable of processing disposed cars. One of them just lost their lease and cannot do business until a new lot is found and the state issues a new permit. That was the City's tow contractor. The other four businesses are at capacity and are turning away cars.

So running out of space to store and lacking options to process, abandoned vehicles sit.

How can the State assist in addressing this growing issue?

With the declining price of scrap metal, perhaps the state can offer more incentives for businesses to do this work to meet demand.

Or better yet, we seek your help to stop the illegal abandonment of vehicles. There are no strong penalties in place to deter such action. Many of the citations issued are ignored. Alternatives need to be developed for our unique island state.

Last year alone, Hawaii saw 84,051 new or transferred vehicles brought onto the islands. Last year alone, my small staff of 12 investigated 28, 263 abandoned vehicle complaints and took action on 9,668 unwanted vehicles left on public property.

We also have found that many of these abandoned vehicles were not even registered as required by law. Stronger registration laws may need to be considered. It is difficult to hold someone accountable, should we choose to do so, if there is no record of ownership.

Thank you for the opportunity to convey our concerns with and opposition to S.B. No. 2479.

The problem with the bill is it only treats the symptoms... not the cause. The federal law requires abandoned military owned vehicles be held for a year. Currently about 20 military cars per month are towed. This is the first thing that needs to be addressed. Our service men deserve the best, but they need to be responsible for a vehicle if they purchase one here in Hawaii. Perhaps the military needs to step up with programs to prevent military owned abandoned vehicles. The next thing that needs to happen is late fees for registering vehicles needs to be increased. Now, I'm thankful that I only had to pay a \$15 fine for registering my vehicle a week ago when it was due last September! However, the fine is not an incentive to register a vehicle on time. Why register an island beater when the registration is more than the worth of the car? Then, when the vehicle ends up stripped on the side of the road, the registered owner of derelict vehicle is not held accountable. Next, Hawaii needs to ban older cars from being shipped here. Transplants come here, ship their car from California for \$1070 and when the car dies... it ends up derelict. Another thing that makes things worse is the Hawaiian DMV does not send out reminders. Other states send out mailings and emails to let one know the registration is coming due. And, in other states you get pulled over if your registration is outdated and the owners get fined. That rarely happens here. It's a better gamble for many islanders to drive their older unregistered vehicles and hope they don't get pulled over for something else than to pay late and overdue registration fees. To add to all this car theft is out of control here. The police are inundated with theft reports and those stolen cars are left on the side of the road stripped and many times burnt out. This is where John Q Public can help. Hopefully the bill coming up that allows citizens to submit pictures of dumpers will help fend off the tide of garbage and derelict vehicles plagueing the island. Finally, to mandate the cities and counties remove derelict vehicles in 10 days is a great wish, but it will fail because the root causes are not being dealt with. If we don't change the laws and customs, we will continue to remain insane... doing the same thing over and over and expecting a different result.
