**Purpose of Bill:** Appropriates funds to the department of education to provide up to

\$1,690 to each special education classroom teacher for instructional

materials and equipment.

#### **Department's Position:**

The Department of Education (Department) supports the intent of SB 2521 appropriating funds so that every special education classroom teacher is provided up to \$1,690 for instructional materials and equipment that support student learning, provided that its passage does not replace or adversely impact priorities indicated in the Board of Education's approved budget.

The intent of this bill aligns with Goals 1 and 2 of the Department's Strategic Plan as extra materials and equipment would help ensure student and staff success.

The Department is currently researching the background on this measure for historical allotment of these funds to special education classroom teachers and requests additional time to report back to this committee. It is also calculating a proposed budget impact of this measure. If SB 2521 is to be enacted, the department respectfully requests funding for the purposes of this measure.

Thank you for this opportunity to provide testimony.

The Hawaii State Department of Education seeks to advance the goals of the Strategic Plan which is focused on student success, staff success, and successful systems of support. The Special Education Advisory Council (SEAC), Hawaii's State Advisory Panel under the Individuals with Disabilities Education Act (IDEA), strongly supports S.B. 2521 which provides funds to special education classroom teachers to spend toward instructional materials and equipment to meet their students' unique instructional needs.

A number of teacher surveys have highlighted the need for additional adaptive curricula, assistive technology and specialized equipment to enable special education students to access their individualized instruction. The monies for these additional supports are often not included in the school budget, and many special education teachers spend their own funds to support their students. The flexibility to purchase additional instructional materials and equipment is sorely needed in order for students with disabilities to access learning opportunities, make meaningful academic gains, and thus reduce the huge achievement gap between special education and non-special education students.


Chair Kidani and Members of the Committee:

The Hawaii State Teachers Association strongly supports SB 2521, relating to special education.

Hawai'i struggles to meet the needs of special education students. Based on statewide assessments, most special needs students are performing below grade level in reading and mathematics. For the 2016-2017 school year, the statewide achievement gap between high needs students—which includes special education children, English language learners, and economically disadvantaged students—and non-high needs students was 33 percent for language arts and 28 percent for math.

Department of Education officials, including State Superintendent Christina Kishimoto, have stated that closing the achievement gap between special needs students and their general education peers is a top priority. Doing so, however, requires investing in additional resources for special education teachers and classrooms. In 2011, the ten-year-long DOE ended the special education classroom supply fund, after American Recovery and Reinvestment Act revenue that had been used to subsidize the fund expired. The loss left schools scrambling for alternatives and SPED teachers unable to provide essential supplies for their students, including curricular materials, high-interest low Lexile books, hands-on materials to support learning in math, adaptive programs and supplies, extra supplies needed for learning life skills out in the community, and even the paper needed for printing of individualized education plan forms, modified lessons, etc.

We must provide a quality education to our special needs students and invest in the professional necessities of their instructors. To improve the achievement of our most vulnerable keiki, the Hawaii State Teachers Association asks your committee to <a href="mailto:support">support</a> this bill.

Honorable Chair Kidani and committee members:

I am Kris Coffield, representing IMUAlliance, a nonpartisan political advocacy organization that currently boasts over 400 members. On behalf of our members, we offer this testimony in strong support of Senate Bill 2521, relating to special education.

Hawai'i's special needs students are performing below grade level in both reading and mathematics. For the 2016-2017 school year, the statewide achievement gap between high needs students—which includes special education children, English language learners, and economically disadvantaged students—and non-high needs students was 33 percent for language arts and 28 percent for math. While State Superintendent Christina Kishimoto and the Hawai'i State Board of Education have made closing the achievement gap between special needs and general education students their top priority, doing so requires investing in additional resources for special education teachers. In 2011, the Hawai'i State Department of Education discontinued the special education classroom supply fund, which, for a decade, had given \$1,690 to every special education teacher for essential supplies, including curricular and classroom materials and printing of individualized education plan forms. Reinstating this funding will help teachers fulfill the IEPS of children with special needs. It would cost \$3,635,190 to provide the \$1,690 in supply funds to each of the state's 2,151 SPED teachers, but would be money well spent.

To support the unique learning needs of our most vulnerable children, we ask your committee to support this bill.

I am Inga Park Okuna, a counselor at Kalihi Uka School. Please pass SB 2521 to provide special education teachers with critical funds for classroom needs.

About 10% of public school students qualify for Special Education services. These students are considered "high needs" students by the DOE. The range of needs by these students is exceptionally broad. They have unique learning needs which is why each student in special education receives an IEP—Individualized Education Program. They require specialized materials and supplies. Many require individualized reward systems to keep them motivated and feeling successful. Yet special education teachers aren't given the money and support needed to be able to meet the needs of all of these students. Teachers and schools are pressured to close the gap and raise the achievement level of these students. In order to do this, we must give teachers additional funding for resources and supplies. In 2011, the DOE ended the special education classroom supply fund, which provided every special education teacher \$1,690 per year to provide essential supplies for their students, including curricular and classroom materials. I am Rebecca Hadley-Schlosser, a special education teacher at Nanaikapono Elementary School. Please pass SB 2521 to provide special education teachers with critical funds for classroom needs.

As a special education teacher, I have spent 20 of my 21 years in the DOE working out on the Waianae Coast. I am very concerned that funding for special education has been cut, resulting in the need for me to spend more money out of my pocket for supplies for my classroom.

If we want to increase the achievement of my students with special needs, we much give teachers additional funding for resources and supplies so that we are not spending that money out of our own pockets, essentially taking away money needed for my family. In 2011, the DOE ended the special education classroom supply fun which provided every special education teacher \$1690 to use towards supplies for our classrooms, including curricular and classroom materials. When this was done, special education teachers were then expected to meet the individual needs of our students using whatever funds the principal gave to us. For some teachers, that amount was \$200 or less. This amount of money does not allow the teacher to purchase research-based, effective curricula and materials that our students need in order to access the general education curriculum and work towards their grade level standards. Reinstating this funding will help teachers fulfill the individualized education plans of our children with special needs.

Please pass this bill so that all special education teachers across Hawaii are better able to meet the needs of our students.

Because we had this funding we were able to have newer supplies. I have always had Special Education students, even when teaching CTE classes. The Special Education department always had enough to give me supplies and help as necessary because I had the extra work of have their students in my classes.

Seven years ago I was displaced because of budget reasons. I was placed as a Special Education teacher. I was shocked when I learned that we just got the leftovers when it came to materials. Old books, broken desks, no computers. I had to scrape and scrounge for all my supplies or pay for them out of pocket. Why? Because we receive between \$60-\$80 a year for supplies. We can not buy a book when the average textbook is \$80. We can not buy computers. We can buy some posters, pens, manipulatives the must be shared,

I bought my own document camera. I brought my old computers from home, which cannot be hooked up to the internet because of rules stating the computer must be school property. I don't want to have to depend on my own pocketbook to have my classroom stocked.

Even the amount proposed would help, but barely make a dent. I will still have to scour Craigslist for freebies and cheap deals. I will have to place ads to get donations. This is not fair. We would not expect any other state employee to provide all of these things. Don't tell me that I decided to become a teacher and this is what is expected of teachers. It shouldn't be.

Please support our students. Please support our teachers that take on the role of creating educated, responsible future citizens.
