RELATING TO AGRICULTURE

Senate Bill No. 2522, S.D. 1, H.D. 1, establishes the Agriculture Accelerator Program and the Agriculture Accelerator Special Fund (AASF) to authorize the Agribusiness Development Corporation to provide funds and invest in new or existing agriculture businesses approved by the Board of Agriculture in return for equity in those agriculture businesses. The AASF would be funded by appropriations through the Legislature, grants, donations and any interest earned from the balance in the special fund.

As a matter of general policy, the Department of Budget and Finance does not support the creation of any special fund which does not meet the requirements of Section 37-52.3, HRS. Special funds should: 1) serve a need as demonstrated by the purpose, scope of work and an explanation why the program cannot be implemented successfully under the general fund appropriation process; 2) reflect a clear nexus between the benefits sought and charges made upon the users or beneficiaries or a clear link between the program and the sources of revenue; 3) provide an appropriate means of financing for the program or activity; and 4) demonstrate the capacity to be financially self-sustaining. In regards to Senate Bill No. 2522, S.D. 1, H.D. 1, it is difficult to determine if the proposed special fund would be self-sustaining.

HFB supports the intent of SB 2522, SD1, HD1, which establishes the agriculture accelerator program to authorize the agribusiness development corporation to provide moneys and invest in existing or new agriculture businesses approved by the board of directors of the ADC in return for equity in those agriculture businesses. It also establishes an agriculture accelerator special fund to provide funds for the agribusiness development corporation to provide moneys to and invest in agriculture businesses under the agriculture accelerator program.

ADC was initiated by the agricultural industry as the closure of plantations escalated and there was a need to identify mechanisms that could quickly place farmers on lands that were destined to be idle.

HFB believes that ADC has a tremendous amount of power and has a responsibility in continuing to assist Hawaii's transition from plantation agriculture to smaller diversified agricultural operations.

Hawaii's farmers and ranchers are finding it difficult to secure the financial support necessary to build capacity. The agriculture accelerator program can result in increased capacity, new business opportunities, increase employment opportunities and address Hawaii's goals of increased self-sufficiency and sustainability.

E ka Luna Hoʻomalu Luke, ka Hope Luna Hoʻomalu Cullen, a me nā Lālā o kēia Kōmike, aloha! My name is Dana Sato and I serve as the Oʻahu Island Director of Asset Management for the Community Engagement and Resources Group of Kamehameha Schools.

We are writing to **support SB 2522 SD1 HD1**, which establishes the Agriculture Accelerator Program (Program) to authorize the Agribusiness Development Corporation (ADC) to invest in existing or new agriculture businesses approved by the Board of Directors of ADC in return for equity in those agriculture businesses and establishes an Agriculture Accelerator Special Fund to provide moneys that ADC may invest in agriculture businesses under the Program.

The Agriculture Accelerator and its accompanying special fund is an essential catalyst for farmers and ranchers to accelerate their products and services time to market and uncover new business opportunities. In order for Hawai'i to realize a significant increase in food production and growth of the agricultural industry in the state, access to capital for new and existing businesses is key to their success.

Kamehameha Schools (KS) believes in the importance of agriculture and the investment in local farmers and ranchers. We are committed for the long term to cultivating food that would enhance our independence from the importation of life-supporting goods and services. KS has invested \$22 million dollars in infrastructure improvements, to help farmers increase food production on KS agricultural lands, but we recognize that we cannot do it alone.
