- 1 **Fiscal Implications:** The Department of Health (Department) would need resources to support the
- 2 cesspool task force that is covered under this measure and defers to the Governor's Supplemental
- 3 Budget Request for appropriation priorities.
- 4 **Department Testimony:** Cesspools are a major source of pollution to Hawaii's waters. There are
- 5 approximate 88,000 cesspools in the State, discharging approximately 53 million gallons of
- 6 untreated sewage into the groundwater every day. Groundwater flows into drinking water sources;
- 7 since ninety-five percent of all drinking water in Hawaii comes from ground water sources, this
- 8 cesspool pollution can potentially harm human health. Groundwater also flows into streams and the
- 9 ocean, harming public health and the environment, including beaches, recreational waters, and coral
- reefs. Cesspools should be phased out in order to eliminate threats to drinking water and
- recreational waters. There is an urgent need to protect the public health and environment with
- cesspool upgrades as soon as feasible. These upgrades can be to sewer, septic systems or any other
- individual wastewater systems that comply with the Department's Chapter 11-62, Hawaii
- 14 Administrative Rules.
- 15 The Department supported the prior version of this bill that any owner of property containing a
- 16 cesspool or cesspools located within a priority upgrade area and identified as priority level 1, 2, or
- 17 3, as determined by the Department, shall upgrade the cesspool or cesspools by connecting to a
- 18 sewer system or installing an individual wastewater system or systems that comply with Department
- rules. The main advantage of using the point-of-sale approach for cesspool phase-out is that the
- 20 cost of replacing a cesspool can be negotiated between the buyer and seller and factored into the
- selling price and/or the financing of the home. Other States which include Rhode Island and New

- 1 Jersey have passed similar legislation to phase-out cesspools. The Department recommends that the
- 2 State of Hawaii should also enact similar legislation to phase-out cesspools.
- 3 Thank you for the opportunity to testify on this measure.

Aloha Chair Mizuno & House Committee on HHS,

As the Oʻahu Chapter Coordinator of the Surfrider Foundation, I am writing with comments on the amended SB 2567, a bill initially requiring Cesspool upgrades within unspecified amount of days after point of sale. The amendments to make this bill a task force are disappointing given it started as a piece of legislation with teeth that really worked on the issue at hand. Requiring upgrades at the point of sale is the absolute minimum our State should be doing to protect our public trust. While the costs may be high for upgrades, building this in to housing costs is a logical step in addressing at least a few of the homes with problems.

Since the passage of Act 120 two years ago, there have only been a handful of cesspool upgrades, and we are working with the Hawaii Dept. of Health (DOH) to improve their public outreach and community involvement. While we understand that amendments were made to further work out the appropriate time-frame for requiring upgrades, Surfrider supports the fastest possible equitable time frame to address this major pollution issue now.

Non-point source discharge from cesspools in Hawaii is a serious threat to our water quality, and this bill would create a working group to come up with the best ways to do cesspool upgrades, conversions or connections to sewer lines. With about 88,000 across the state, Hawaii has the highest number of cesspools in the country, and many pose a threat to water resources. These substandard wastewater systems leach untreated human waste, harmful pathogens and nutrient loads into nearby waters. Cesspools are a leading source of water pollution, and their effluent can contaminate drinking water sources, streams and oceans with disease-causing pathogens, algae-causing nutrients and other harmful substances.

In monitoring the water quality of North Shore beaches on Kauai, the Surfrider Chapter there has seen improvement after the replacement of cesspools at Kauai County beach parks and along the Hanalei River, where enterococcus counts at the beach at the Pavilion and estuary decreased approximately 56% between 2004 and 2013. Where sewer connections are not available, septic systems and ATU's are a big step forward in protecting public health and the environment. We helped pass the bill to give homeowners tax credits for upgrading their cesspools within 400 feet of the shoreline, waterways or wells because they are the most dangerous. We hope they will make sure the replacements have some form of aerobic digestion.

We support the diversified solution perspective being presented at this year's State legislature. Tax credits and grant programs are an important mechanism, but having some more stringent demands that place responsibility on residents buying into an archaic infrastructure system is also an important step in making sure we move towards a more sustainable State. While we understand that the issue is complicating because of the heavy cost of upgrades, the situation is also of pressing need. Our marine resources and public health are at stake. Ultimately, the science already exists to prove the problem and the precedent has already been set – no other State allows these archaic infrastructure pieces to be used. The reasons are very simple, the uncontrolled release of untreated human waste into our freshwater and nearshore ocean waters is a detriment to all levels of the health spectrum.

There is unquestionably a need to reduce groundwater and ocean discharge pollution, but targeting all cesspools in areas 1-3 for immediate replacement while tax credits are available only to those within 200 feet of the ocean or a water source places a heavy burden on the people who can least afford it. The restrictions of the credit exclude nearly everyone in the only area of affordable housing remaining in the state, in Puna and Hilo, where most people get their water from catchment rather than groundwater wells and there are no significant beach or reef areas. Dear Honorable Senators,

It is entirely unfair that as a homeowner of Puna we pay the same tax rates as the rest of the county yet we receive a fraction of the services and infrastructure. There is no water service throughout the majority of the subdivisions nor is there any sewer or waste disposal. Now the state is putting the burden on the homeowner. Subdivisions such as Hawaiian Paradise Park, the largest of it's kind, don't even sit on an aquifer. Only the homes along the shoreline, which already require septic systems, could have sewer systems that affect ocean water quality.

Because of the high real estate cost throughout most of the state, Puna is home to the largest population of poor and disabled. The effect of this legislation will have a direct disparate impact on those who are the least able to afford the requirement.

Also there are alternative solutions that have been entirely ignored, such as incinerating toilets, that offer better solution. My plumbing contractor advised me NOT to convert to septic as Puna receives so much rainfall that he said overwhelms septic systems and causes them to malfunction. My plumber futher stated that he has seen many that have waste which overflowed into the drainage field and needed to be dug up and completely redone at around \$18,000 to fix.

Understand that as a homeowner, our goals are the same: to have access to clean water & safe waste disposal. Please try and craft a solution in which we can all share in the responsibility without putting the burden largely on the poor and disabled.
