SENATE BILL NO. 2572 SD2 RELATING TO AGRICULTURE

Chairperson Creagan and Members of the Committee:

Thank you for the opportunity to testify on Senate Bill No. 2572 SD2 that requests two separate appropriations for FY 2018-19 to be expended by the Department of Agriculture to conduct import substitution projects to encourage Hawaii's farmers and growers to identify and grow food and non-food alternative products to phase out imports of high-risk pathway food and commodities by 2027; and to produce outreach materials to encourage Hawaii residents to buy local products and foster a sense of pride and self-responsibility in protecting Hawaii's agriculture, environment, and lifestyle. The Department of Agriculture supports this measure provided it does not impact the Department's priorities listed in the Executive Budget.

The Department may direct some of the funding for import substitution projects to the development or updating of cost-of-production, disease/pest vector risk, and agronomic information for food and non-food import replacement products that are targeted. This data will allow farmers to have as much information to help them with their decision-making on what food and non-food import replacement products to grow. Without this information, decisions may result in suboptimal outcomes.



Regarding the enhanced "buy local" outreach proposal, the existing buy local program in the Department has resulted in media campaigns via television and at the retail level. We believe our in-house buy local program is both effective and efficient to best accomplish encouraging Hawaii residents to buy local products and foster a sense of pride and self-responsibility in protecting Hawaii's agriculture, environment, and lifestyle.

As a general practice, the Department works with entities that impact the agricultural farm-to-table pathway such as the University of Hawaii's College of Tropical Agriculture and Human Resources – Extension Services, Hawaii Farm Bureau, Pacific Gateway Center, Kapiolani Culinary Program and the Hawaii Farmers Union United.

Aloha Chair Creagan, Vice Chair DeCoite, and Members of the Committee:

I am Randy Cabral, President of the Hawaii Farm Bureau (HFB). Organized since 1948, the HFB is comprised of 1,900 farm family members statewide, and serves as Hawaii's voice of agriculture to protect, advocate and advance the social, economic and educational interests of our diverse agricultural community.

The Hawaii Farm Bureau supports SB 2572, SD2, which appropriates funds for the Department of Agriculture to conduct import substitution projects to encourage Hawaii farmers and growers to identify and grow food and nonfood alternative products to phase out imports of high-risk pathway food and commodities by 2027. Appropriates funds for outreach materials to encourage Hawaii residents to buy local products and foster a sense of pride and self-responsibility in protecting Hawaii's agriculture, environment, and lifestyle.

Import replacement is a huge opportunity for our farmers. In a global market place, new products give our local farmers an edge. In turn, replacing high risk imports will mean less risk for invasive species introduction. The high rate of new pests into the islands is a challenge to not only agriculture but the environment.

Hawaii's farmers and ranchers are finding it difficult to secure the financial support necessary to build capacity. Access to grants can result in increased capacity, new business opportunities, increase employment opportunities and address Hawaii's goals of increased self-sufficiency and sustainability.

HFB has been active in promoting "Buy Local" campaigns such as HDOA's "Buy Local, It Matters!" a call-to-action campaign to help encourage local residents to buy local farm products, the "Hawaii Seals of Quality" program which was developed to distinguish quality Hawaii grown crops and value-added products, the "Made in Hawaii" branding the "Kauai Grown", and "Grown on Maui". Campaigns such as these, which seek to promote

locally grown agricultural products and recognizes the farmers, ranchers, retailers, and restaurants that bring these products to the consumer create increased demand and economic viability for Hawaii's agriculture industry.

morning, my name is Melodie Aduja. I serve as Chair of the Oahu County Legislative Priorities Committee of the Democratic Party of Hawaii. Thank you for the opportunity to provide written testimony on **SB2572 SD2**, relating to Hawaii Agriculture; Import Substitution Projects; Outreach Materials; DOA; and an

appropriation. The OCC Legislative Priorities

Committee is in favor of **SB2572 SD2** and support its passage.

SB2572 SD2 is in accord with the Platform of the Democratic Party of Hawai'i ("DPH"), 2016, as it appropriates funds for the Department of Agriculture to conduct import substitution projects to encourage Hawaii farmers and growers to identify and grow food and nonfood alternative products to phase out imports of high-risk pathway food and commodities by 2027; and appropriates funds for outreach materials to encourage Hawaii residents to buy local products and foster a sense of pride and self-responsibility in protecting Hawaii's agriculture, environment, and lifestyle.

Specifically, the DPH Platform states, "[Agriculture in our state must be preserved and its future strengthened. Sufficient prime agricultural lands must be maintained for the health, economic well-being and sustenance of the people. We believe in an integrated approach to agricultural innovation and sustainability. We encourage the responsible development of ocean resources in order to achieve sustainability of our marine resources, and ensure and improve the health of our reef and marine life.

This approach includes, but is not limited to, the adoption of the native Hawaiian concept of ahupua'a, an integrated approach to land management. This could also include development of economic, land and ocean use policies that foster sustainable crops both for local consumption and for export, policies to foster agriculture-related infrastructure at shipping points, and increased inspection to protect against invasive species and to encourage reduced holding times.

We will promote ethical and safe production of livestock, dairy products, poultry and eggs.

Recognizing the importance of the ocean as a life-sustaining resource, we must protect its ecological balance while promoting the cultivation of ocean resources as a step toward greater self-sufficiency.

To ensure wise use and equitable distribution of our precious water, we must stress water conservation and alternative patterns of water treatment and consumption such as the use of recycled water for irrigation, water storage reservoirs, and the use of catchment systems by the public.

As an island state, securing affordable food for all is a priority. We support healthy, sustainable, and diversified local food production, and "Buy Local" strategies to assure greater food security and food safety.

We recognize the essential link between the availability of adequate and affordable water and low-cost electrical power as essential components of viable agricultural businesses.

We support land use planning and infrastructure development to support sustainable diversified agriculture, including low cost inter-island transportation of agricultural products. We likewise support publicly funded research and development for agricultural diversification and value-added products. (Platform of the DPH, P. 2, Lines 76-107 (2016)).

Given that **SB2572 SD2** appropriates funds for the Department of Agriculture to conduct import substitution projects to encourage Hawaii farmers and growers to identify and grow food and nonfood alternative products to phase out imports of highrisk pathway food and commodities by 2027; and appropriates funds for outreach

materials to encourage Hawaii residents to buy local products and foster a sense of pride and self-responsibility in protecting Hawaii's agriculture, environment, and lifestyle, it is the position of the OCC Legislative Committee to support this measure.
