In consideration of SENATE BILL 2675, SENATE DRAFT 1 RELATING TO SUSTAINABLE DEVELOPMENT GOALS

Senate Bill 2675, Senate Draft 1 proposes to codify sustainable development goals based on the Unites Nations' Global Goal fourteen, life below water. **The Department of Land and Natural Resources (Department) supports this measure and offers the following comments**.

Hawai'i's culture, economy, and way of life are intimately tied to our marine environment. We depend on healthy coral reefs and fisheries for food, recreation, tourism, and our island way of life. These mutually-dependent resources help to attract more than eight million annual visitors and generate more than \$360 million a year for Hawai'i's economy. However, the health of our marine environment is increasingly at risk from unsustainable fishing practices, land-based pollution and runoff, and warming and rising seas.

At the Hawai'i-hosted 2016 IUCN World Conservation Congress, Governor Ige announced the <u>Sustainable Hawai'i Initiative</u> as part of the statewide effort to achieve the *Aloha+ Challenge* sustainability goals. The Governor's commitment includes a target to effectively manage 30% of Hawai'i's nearshore waters by 2030 (The 30x30 Marine Initiative). *Effective management* focuses on collaboratively developing action based on biological, as well as socio-cultural, economic, and governance drivers. Management could include spatial rules and designations in addition to consistent monitoring, enforcement, and education efforts. The Department's Division of Aquatic Resources (DAR) is currently developing a strategic plan to implement and measure the 30x30 Marine Initiative by pursuing the following objectives:

- A. **Implement statewide management actions**, including fisheries rules, to improve nearshore ecosystems, ensure responsible use, and sustainably manage key food fish species.
- B. **Identify a statewide network of priority areas** for effective management of at least 30% of Hawai'i's nearshore waters, and work collaboratively with local stakeholders to identify management options appropriate for each place.
- C. **Encourage responsible behavior** through compliance and enforcement of rules related to nearshore fisheries and ecosystems.
- D. **Prioritize and institutionalize monitoring** and data analysis to inform adaptive management.

Senate Bill 2675, Senate Draft 1 would provide a legislative mandate to support and implement effective management. The 30x30 Marine Initiative will improve the health of our nearshore resources by setting specific goals related to improving ocean-based enforcement, fisheries management, land-based and ocean-based source pollution, and climate adaption measures. This bill would strengthen DAR's commitment to achieving the sustainability goals that have been developed through the Aloha+ Challenge, the Promise to Pae'āina, and the 2016 World Conservation Congress Sustainable Hawaii Initiative. This measure would ensure legislative support and longevity of the 30x30 Marine Initiative and demonstrate the holistic support of this effort.

The Office of Hawaiian Affairs **SUPPORTS** SB2675 SD1, which codifies sustainable development goals based on the United Nations' Global Goal fourteen, life below water.

OHA has long sought to promote the resiliency and health of our islands' lands and natural and cultural resources. OHA's strategic priorities include maintaining Native Hawaiians' connection to 'Āina (Land & Water) as an inherent means to connect to the past, as well as encouraging Native Hawaiian participation in the stewardship of Ka Pae 'Āina o Hawai'i. In line with this priority, OHA's strategic results specifically seek to preserve cultural and natural resources and historic properties, including by increasing the percent of ahupua'a that are managed sustainably.

In July of 2014, OHA joined the Governor, four county mayors, the legislature, and Hawai'i Green Growth public-private partners from across the State, in launching the Aloha+Challenge, a statewide commitment to sustainability. Since then, OHA has worked through various partnerships to support these goals throughout the islands.

As a member of the Hawai'i Climate Change Mitigation and Adaptation Commission established by Act 32 (Reg. Sess. 2016), OHA also currently assists with direction, facilitation, coordination and planning among state and county agencies, federal agencies, and other partners on climate change mitigation (reduction of greenhouse gases) and climate change resiliency strategies. These strategies include sea level rise adaptation, water and agricultural security, and natural resource conservation. OHA understands that the impacts of climate change—such as coastal flooding and erosion and impacts to terrestrial and marine ecosystems—will affect the oceans and marine resources, as well as the cultural practices, livelihoods, and food security of Native Hawaiians. Understanding the extent of these changes and their impacts and identifying early adaptation actions is essential to protecting the communities and natural and cultural resources of Ka Pae 'Āina O Hawai'i.

OHA therefore appreciates and supports the intent of this measure. OHA believes that the sustainable development goals relating to protecting our oceans, seas, and marine resources will reaffirm and reinforce our ongoing efforts to ensure the overall resiliency and sustainable stewardship of our island home.

Accordingly, OHA urges the Committee to <u>PASS</u> SB2675 SD1. Mahalo nui for the opportunity to testify on this measure.

We strongly urge our candidates and elected officials to take immediate action to mitigate and adapt to the consequences of climate change. The Oahu Economic Development Board supports SB2675 to adopt the United Nations 2030 Sustainable Development Goal (SDG) #14, into state law. Honorable Chair Dela Cruz, Vice Chair Keith-Agaran, and Members of the Committee:

As a statewide partnership, Hawai'i Green Growth (HGG) **strongly supports SB2675 SD1** to adopt the United Nations 2030 Sustainable Development Goals (SDGs) into state law. We recognize the critical importance of conserving and sustainably using our oceans, seas, and marine life as part of a sustainable future, as highlighted through SDG14. Even further, HGG recommends adopting the entire global framework with all 17 SDGs, as reflected in **SB2661 SD1**. HGG acknowledges discussions underway to determine the appropriate placement in HRS, but supports the overarching vision to holistically address 21st century challenges that cut across environmental, social, and economic priorities.

We appreciate the Senate's leadership on the 2018 Majority Program on UN Sustainable Development Goals (SDGs), as well as the support for Hawai'i sustainability initiatives over the past several decades. Our partnership believes that the SDGs can help advance local efforts to address key challenges in Hawai'i across housing, climate change, energy, environmental protection, health, education and economic development by acknowledging that none of these can be addressed without consideration for the others. We cannot meet our climate goals without achieving sustainable development outcomes and vice versa. Senator Kenneth Brown's 1973 Mālama Hawai'i speech proposed that every action – economic, social and political - be guided by *mālama*. The 17 SDGs embody Hawai'i's mālama 'āina approach to resource management, and counsels the necessity of maintaining a balance between all aspects of our environment, society, and economy. In many ways Senator Brown foretold the eventual arrival of the SDG framework.

Hawai'i launched the *Aloha+ Challenge*: *He Nohona 'Ae'oia* one year prior to the formal adoption of the SDGs by over 190 countries. The *Aloha+ Challenge* is led by the State Legislature (Senate Concurrent Resolution 69), Governor, four County Mayors, Office of Hawaiian Affairs, and private sector and civil society partners. Building on Hawai'i's history of systems thinking and many community initiatives, this commitment identifies statewide sustainability goals across energy, food, natural resources, waste, smart sustainable communities and climate, green education and workforce. Hawai'i's *Aloha+ Challenge* is recognized as a place-based model to support locally and culturally appropriate implementation of the SDGs. At the same time, the global SDG framework supports the implementation of local models like the *Aloha+ Challenge*, Sustainable Hawai'i Initiative, 100 Resilient Cities, Promise to Pae 'Āina, and other efforts, and can help attract new resources to drive implementation. It also builds on Hawai'i's recent adoption of the Paris Agreement (Act 32) and the inspiring Mālama Honua Worldwide Voyage of Hōkūle'a. Enacting SDGs into state law is significant for Hawai'i locally, nationally and internationally.

Above all, the partnership recognizes that Hawai'i's long-term security in the face of climate change and other challenges is now linked to the success of this global agenda. Because of the scale of the threat, this is no longer something Hawai'i can do alone. Indeed, for many in the international community, Hawai'i holds the answer to finding the balance based on the wisdom of our host culture and fundamental island values, as embodied in Senator Kenneth Brown's speech delivered 45 years ago. It is our kuleana, both a responsibility and privilege, to partner with communities across the globe to build a more sustainable future for Hawai'i and island earth.
