## Testimony in SUPPORT of SB2798 INTELLECTUAL AND DEVELOPMENTAL DISABILITIES WAIVER ADMINITRATIVE CLAIMING SPECIAL FUND

- 1 **Fiscal Implications:** The proposed DDD Special Fund, upon approval from the legislature, is
- 2 expected to receive reimbursements for through Targeted Case Managementand other
- Administrative claiming. Under section 1903(a)(7) of the Social Security Act, federal payment is
- 4 available at a rate of 50 percent for amounts expended by a state for allowable cost for
- 5 administration of programs for the Medicaid popu; ation. The anticipated administrative claiming
- 6 beginning in FY2019 is estimated at \$700,000 to \$1.2 million, which will support compliance
- 7 requirements of the Medicaid I/DD Waiver.
- 8 **Department Testimony:** The Department of Health strongly supports SB2798. The Department
- 9 of Health, Developmental Disabilities Division is the operating agency for the State of Hawaii's
- 10 1915(c) Medicaid Home and Community Based Services (HCBS) Waiver to serve persons with
- intellectual and developmental disabilities (I/DD). Medicaid administrative claiming is allowable
- for the proper and efficient administration of the HCBS I/DD waiver. SB2798 requests the
- 13 legislature's approval of the establishment of a special fund for deposits from administration
- claiming to administer the HCBS I/DD waiver.
- 15 Currently, administrative claiming for the operations of the HCBS are deposited in the general
- fund, limiting the DOH's ability to implement new federal requirements for sweeping changes to
- implementation of the waiver, including the final rule on Community Integration and its Home
- and Community-Based Settings Requirements. Implementation of these requirements and
- 19 operations of quality services requires an adequate infrastructure that include ongoing

- 1 monitoring and training for staff, families, waiver participants and providers. The monies from
- 2 this special funds will be used to meet these requirements, and to modernize operations. The
- 3 fund would be used for:
- 4 (1) Payment for fiscal management services of the Hawaii section 1915(c) Home and
- 5 Community-Based Services for People with Intellectual and Developmental Disabilities waiver;
- 6 (2) Training of staff, waiver providers, waiver participants, their families, and their legal
- 7 representatives, and community stakeholders;
- 8 (3) Quality management activities for operating the Hawaii section 1915(c) Home and
- 9 Community-Based Services for People with Intellectual and Developmental Disabilities waiver;
- 10 (4) Ongoing operations and maintenance of the information technology system;
- 11 (5) Conducting rate methodology studies to define rates for the Hawaii section 1915(c)
- Home and Community-Based Services for People with Intellectual and Developmental
- 13 Disabilities waiver; and
- 14 (6) Assessment services for determining participant's level of support needs.
- 15 DOH-DDD has collaborated with the Department of Human Services (DHS) MedQuest Division
- 16 (MQD).
