Good morning, my name is Melodie Aduja. I serve as Chair of the Oahu County Committee ("OCC") Legislative Priorities Committee of the Democratic Party of Hawaii. Thank you for the opportunity to provide written testimony on **SB2846 SD2 HD1**, relating to the East Kauai Irrigation System; Transfer of Operational Authority; DOA; AG; DLNR; and an appropriation.

The OCC Legislative Priorities Committee is in favor of **SB2846 SD2 HD1** and support its passage.

Chairperson Johanson and Members of the Committee

My name is Jerry Ornellas and I strongly support SB 2846 SD2 HD1. I am the president of the East Kauai Water Users' Cooperative which has managed the Stateowned reservoir and ditch system in the Kapaa/Kalepa area for the past 17 years under a year-to-year revocable permit from the Department of Land and Natural Resources. On September 20, 2016, the Cooperative was informed by DLNR, as a consequence of the East Maui irrigation case, that we would have to seek a long-term water lease. We were given three years to complete the application process which includes an Environmental Impact Statement that is beyond our monetary resources to pay for, as well as other complex requirements. Even if we had the resources to pay to meet the requirements, we could only bid on the system at public auction with no guarantee that we would ultimately be awarded a lease for the system.

Once the three years expires, DLNR will no longer renew the system's revocable permit, the Coop will cease operation, the irrigation system, including the recently renovated Wailua and Upper Kapahi Reservoirs, will revert to DLNR control and most likely be abandoned. In 2001, ITC Water Management, hired by the State to evaluate the East Kauai system, estimated the cost to build it in 2001 to be in excess of \$200 million. We are talking about the potential loss of a substantial and irreplaceable State asset.

We are therefore in favor of SB 2846 SD2 HD1 allowing the East Kauai system be taken over by the Department of Agriculture. This is in keeping with the mandate of Article XI, Section 3, of the State Constitution: "The state shall conserve and protect agricultural lands, promote diversified agriculture, increase agricultural self-sufficiency and assure the availability of agriculturally suitable lands."

It is also in keeping with Act 90 of the Session Laws of Hawaii, 2003, passed in response to the decline of the plantations and directing certain public lands classified for agricultural use and their related facilities, of which our water system is one, be transferred from DLNR to the Department of Agriculture.

In 2003, the Department of Agriculture released its comprehensive Agricultural Water Use and Development Plan which analyzed the development and present status of State's plantation-developed irrigation systems and concluded that the

East Kauai System was among five State systems "important and viable to Hawaii's growing diversified agricultural industry."

Our system includes two reservoirs and 22 miles of ditch which has historically serviced thousands of acres of State and private lands. In particular, it services more than 1,000 acres of the State Kalepa lands located between Kapaa and Lihue, and a similar amount of private former cane lands mauka of Kapaa town. When first taken out of sugar cane in 2001, the Kalepa lands had gone into pasture, but in the last few years, through the good action of the Agribusiness Development Corporation, nearly 300 acres to date has been leased to farmers who are actively developing their crops, including ginger, bananas, noni and sweet potatoes. This is only possible because the Coop can provide these farms with water.

Aside from the State lands and private Kapaa parcel, the Coop system can service thousands of acres of so-called "marginal lands"—those not taken by the cane companies and now privately owned. These are located throughout Kapaa and are or could be productive agricultural lands, such as my own farm.

The Department of Agriculture is the natural State agency to manage this public water system, as is the pattern in most other states in the country. It is also the only long-term, permanent way to manage the system for the benefit of our citizens.

I respectfully ask that you pass this bill.

Aloha Chair Johanson, Vice Chair Holt, and Members of the Committee:

I am Randy Cabral, President of the Hawaii Farm Bureau (HFB). Organized since 1948, the HFB is comprised of 1,900 farm family members statewide, and serves as Hawaii's voice of agriculture to protect, advocate and advance the social, economic and educational interests of our diverse agricultural community.

The Hawaii Farm Bureau strongly supports SB 2846, SD2, HD1, which transfers operational authority over the portions of the east Kauai irrigation system operated and maintained by the east Kauai water users' cooperative to the department of agriculture, establishes positions within the agricultural resource management division, and authorizes GO bonds for plans, designs, land acquisition, and equipment.

Since the demise of plantation operations across the islands, irrigation systems have fallen into disrepair. Ditches that carried water developed major leaks, and in some cases such as in Kau, cracks in tunnels created losses so that there is no longer significant water flow. The Governor, the legislature, and the public all support increased self-sufficiency and sustainability, but without adequate water supply, agriculture in Hawaii cannot remain viable, much less grow.

The East Kauai Irrigation System services more than 12,500 acres of agricultural land on Kauai. The repair and maintenance of this 2 reservoir, 22-mile irrigation system is critical for Kauai's farmers who depend on it for their operations. Water availability is a basic necessity for farmers and ranchers to maintain and expand their production, particularly in times of drought. A reliable water supply is a key factor when Hawaii's farmers and ranchers are considering whether to start new farms or expand existing ones.

For the past 17 years, the East Kauai Water Users' Cooperative has managed the State-owned reservoir and ditch system in the Kapaa/Kalepa area via a year-to-year DLNR revocable permit. This entity has served to keep the system functioning so that it

can supply water to the many Kauai farms that rely on it for irrigation, and future local farms that will also need the water.

However, the Co-op does not have the means to continue to maintain the system and to meet the new requirements mandated by the State, including a costly EIS, to secure a long-term water lease. We support this bill that would allow the system to be managed by the Department of Agriculture, which is the appropriate entity to undertake these responsibilities.

Thank you for the opportunity to provide our opinion on this important matter.
