Beyond our own careers as artists, as a participant of Honolulu Biennial, I witnessed people of all ages and backgrounds interact with powerful art and educational programs. While the inaugural biennial welcomed 97,305 visitors, 1,200 children through a free bus and educational tour program, and generated an economic impact of \$35.5 million dollars--for me the best part of the festival was seeing local residents discover or reconnect to important historic resources Honolulu has to offer, such as Foster Botanical Garden where my sculpture was installed. Attendance for the garden tripled during the duration of the festival.

As an artist, I also received immediate support to create innovative educational programming that allowed me to present concepts relating to Hawaiian land use, architecture, science, and professional development to over 1000 students in public and private schools, as well as several hundred college and graduate students at UH

Manoa, UH West O'ahu. The biennial opened many doors to help artists like myself achieve our creative missions and extend the value of our creativity to the community and beyond.

Through the power of art and complementing educational public programs, Honolulu Biennial truly brings together and connects our community and all the cultures of the Pacific together in a way that is both profound and inspiring. I look forward to the next edition of Honolulu Biennial in 2019 and gratefully ask for your support for SB2897.
