POSITION: The Department of Human Services (DHS) supports this measure to the extent that this appropriation does not replace or adversely impact priorities indicated in the Executive Budget.

<u>PURPOSE</u>: The purpose of the bill is to establish the position of the Governor's Coordinator on Homelessness in statute. In addition, the bill makes an appropriation and attaches the Governor's Coordinator of Homelessness to the Department of Human Services for administrative purposes, and requires the position to report to the Governor.

Currently the position of the Governor's Coordinator of Homelessness is located in the DHS Director's Office (HMS 904) as a special project, though the Coordinator's office is physically located with the Governor's staff. The Legislature should establish the position as a permanent position, exempt from provisions of Chapter 76, and should also consider additional appropriations for operational issues to cover basic functions of the position such as travel, postage, and copying.

For Hawaii to reach "functional zero," the State will continue to require a focused, strategic, and coordinated effort lead by the Governor's Coordinator on Homelessness who

has the ability, authority, and credentials of the Governor and the Legislature to work with all state departments, County governments, Federal agencies, and the private sector.

In consideration of SENATE BILL 2906 RELATING TO THE GOVERNOR'S COORDINATOR OF HOMELESSNESS

Senate Bill 2906 proposes to statutorily establish the position of the Governor's Coordinator on Homelessness, establish clear lines of communication and provide funding for the functions of the office. The Department of Land and Natural Resources (Department) is in strong support of this measure.

The Governor's Office on Homelessness has provided much needed leadership and coordination for administrative agencies in addressing the problem of homelessness on our individual lands. This Office is crucial to effectively address homelessness because individual agencies, such as the Department are ill-equipped to address the problem alone. The Governor's Office on Homelessness has been able to coordinate outreach, law enforcement and clean-ups across departments as well as with the Counties. This efficiency saves staff and money for the State. Some of the work of this Office includes:

- Developing Standardized Notification Procedures
- Leveraging the resources of different departments for more effective clean-up operations (i.e. Nimitz Viaduct).
- Coordinating contracting services to more effectively move people into long-term housing.

Thank you for the opportunity to provide written testimony **in strong support** of **SB 2906 SD1**, which statutorily establishes the Governor's Coordinator on Homelessness position. I am Terry Walsh, with Catholic Charities Hawai'i. We are also a member of Partners in Care.

Catholic Charities Hawai'i (CCH) is a tax exempt, non-profit agency that has been providing social services in Hawai'i for over 60 years. Our mission is to provide services and advocacy for the most vulnerable in Hawai'i. Ending homelessness is a top priority for 2018.

After years of ever increasing homelessness, Hawai`i finally saw a decrease in the Point in Time Count for homeless in 2017. Catholic Charities Hawai`i has seen extensive planning, collaboration and the development of a new system to address the many facets of homelessness, in coordination with the Governor's Coordinator on Homelessness. This position has proven to be key to addressing homelessness. It is very important that the position be made permanent. This will enable the stability and long term planning that is needed to effectively address homelessness throughout our state.

Catholic Charities Hawai`i and Partners in Care work closely with this position. The coordinator serves as an important bridge between the work of the state, multiple state departments and agencies, the counties, and the many non-profits who provide services to end homelessness. The Coordinator enhances the collaboration to effectively and efficiently plan and move initiatives forward and at a faster pace than in the past. The Coordinator position is essential for the state to look at the big picture and match resources to needs, based upon a broad understanding of what is happening in the community and among service providers. This Coordinator's position has been invaluable to help stakeholders become engaged in addressing homelessness. This measure would ensure ongoing accountability and coordination between the many departments and agencies that work to end homelessness. This position is also invaluable to the State to coordinate strategic plans and benchmarks to address this critical issue for Hawai`i.

We urge you to statutorily establish this position to continue the strong leadership and collaboration that is need for our State to strongly address homelessness.

Thank you for the opportunity to testify in **support** of SB 2906, which statutorily establishes the Governor's coordinator on homelessness position. The position has proven to be key to addressing homelessness in Hawai'i, and it is important that the position be made permanent to allow the stability and long-term planning necessary to address homelessness in Hawai'i.

Homelessness is one of the biggest problems facing Hawai'i. Our state has the highest housing costs in the nation and the lowest wages when adjusted for cost of living. Not surprisingly, we also have the highest homelessness rate in the nation, with 7,220 unsheltered homeless at last count. Thanks to a growing focus on homelessness in recent years, we have started to turn the tide on homelessness, reducing the homelessness rate for the first time in years last year.

The Governor's coordinator on homelessness has played a critical role in these efforts. The coordinator serves as an important bridge between the work of the state, the counties, and of NGOs involved in addressing homelessness. The coordinator is well-situated to be able to look at the big-picture, with access to information about the resources available to combat homelessness and an understanding about what is happening on the ground. The coordinator's work is invaluable in helping to connect and guide the efforts of the stakeholders engaged in addressing homelessness.

For these reasons, Hawai'i Appleseed supports SB 2906. Thank you for your consideration of this important bill.
