### TESTIMONY ON SENATE BILL 2918, RELATING TO EMERGENCY MANAGEMENT

# Before the Senate Committees on PUBLIC SAFETY, INTERGOVERNMENTAL AND MILITARY AFFAIRS and GOVERNMENT OPERATIONS

Aloha Chairs Nishihara and Kim, Vice-Chairs Wakai and Ruderman, and the Members of the Committees

SB 2918 prohibits the Hawaii Emergency Management Agency (HI-EMA) from issuing any alert or warning related to military matters without receiving prior approval for such an alert or warning from the United States Pacific Command (USPACOM). HI-EMA opposes the bill and offers the following comments:

- Under the current notification process for a military threat to the state of Hawaii, primarily
  an inbound missile, USPACOM will call the HI-EMA State Warning Point via a secure
  line and issue a pre-scripted message identifying the inbound threat.
- In addition, the Federal Emergency Management Agency (FEMA) will issue a similar message via the National Warning and Alert (NAWAS) system to the state.
- Both USPACOM and FEMA are in the missile event conference that determines if there
  is a threat to the state.
- Only upon receipt of these messages will the SWP issue an alert or warning to the state.

Consequently, under the protocol already in place, HI-EMA will not issue any real-world alert or warning related to military matters without receiving notification from USPACOM and FEMA.
